1. Invitation to Bid and Tender Conditions

The Airports Authority (hereinafter: "**the Authority**"), which owns, manages and operates the airports and ports according to the Airports Authority Law, 5737, 1977, as well as the land transit terminals according to the Airports Authority Law (Temporary Provision), 5700, 1980, hereby invites bids for participation in a public tender for entering into a contract to provide maintenance services, expansions and upgrades to a building control system, installed at Ramon Airport, for the Authority, all subject to the provisions specified in the tender documents (hereinafter: "**the Tender**" and "**the Services**").

2. Nature of the engagement and general information

Below is detailed general information regarding the contract and the services. It is emphasized that this is a summary only, and the binding provisions are those detailed in the contract and its appendices.

2.1 Background and general

information – As part of the Ramon Airport construction project, an electrical, energy and air conditioning control system was purchased and installed. This system manages all electrical, lighting, water and air conditioning systems at the airport. The system includes: central infrastructure for the control systems, programmable controllers, **HMI system**, communication system, computer systems, control panels, etc. The tender is a single-stage tender in which the winning bid will be selected as detailed in Section 13 below.

2.2. The nature of the services –

For the aforementioned purpose, the Authority intends to enter into a contract with **one winner**, to provide maintenance services, expansions and upgrades to a building control system installed at Ramon Airport, all as detailed in the technical specifications attached as **Appendix A** to the contract.

2.3. Contract period -

2.3.1 The period of the Authority's contract with the winning bidder will begin on the date the contract is signed by the Authority, with the period of providing the services beginning on 01/08/2025 and lasting for 60 months (hereinafter: **the "Contract Period"**). The actual

commencement of the services will be on the date specified in the work commencement order, which the contract manager will deliver to the winning bidder, after the date of signing the contract and the performance of all His required obligations.

2.3.2 The Authority alone shall be entitled, at its sole discretion, to extend the contract period for an additional period or periods of **up to 36 months, cumulatively**, in any combination, in accordance with its sole discretion.

2.3.3 The remaining provisions regarding the contract period are as detailed in Section 6 of the contract.

2.4. The consideration -

In exchange for the successful bidder's performance of all of its obligations under the contract, in full and on time, the Authority will pay for the services actually provided to it by it, a consideration calculated in accordance with the percentage of the discount specified in its financial bid, for each of the items specified in the price list, as part of the submission of its bid to the tender, and all in the manner and under the conditions and subject to the other provisions specified for this purpose in the contract.

"Price List" - for this purpose - means a bill of quantities in which the unit prices stated are maximum prices for each component and are dictated in advance by the Authority, which is attached to the tender documents and constitutes an integral part thereof.

The consideration for the performance of maintenance,

and expansions and upgrades (as required) will be made in three ways according to the following order:

A. In accordance with the discount percentage given by the winning bidder, as part of submitting its bid for the tender.

B. According to the latest edition of the Dekel consolidated price list without coefficients, (except for the main contractor coefficient, according to the tables in the Dekel price list appendices) and with an additional discount of 15%. C. According to the tax invoices paid by the contractor, plus contractor overheads at a rate of 12%, which will be paid in accordance with prior approval to be given by the inspector. The annual maintenance fee for the expansion of the

system will be at a percentage rate of 3% of the total value of the expansions and upgrades. The additions will be summed up once a year at the end of December each year. A review year will be given for each expansion and the addition in consideration will only begin after the end of the review year, starting in January of the following year. Bidders' attention regarding the registration of the winning bidder as a resident of the Eilat

area for VAT purposes, as detailed in Subsection 14.4 of the contract.

#### 2.5. Scope of services -

The scope of the services that will actually be provided, both on a single occasion and with reference to the total scope of the services/purchases throughout the entire contract period, their timing and characteristics (if any), will be determined from time to time according to the needs of the Authority, and at its sole discretion. Without prejudice to the generality of the foregoing, it is clarified that the information regarding quantities and/or scopes presented in the tender documents (to the extent presented) is a non-binding estimate, made for weighing and evaluation purposes only, **as this is a framework contract without obligation.**

It is further clarified that the Authority does not undertake to order any of the services from the winning bidder to any extent and/or at certain times, if at all, and this without the winner being entitled to any compensation and/or indemnity, of any kind or type in connection therewith, **to the extent that such were not required, or were required to a limited extent or different from what he expected.**

It is clarified that the above section does not apply to the provision of preventive maintenance services, which will be carried out according to a defined annual work plan, in accordance with the technical specifications attached to the contract, for which the scope of services is detailed in the contract, and in addition, the consideration for these services is a fixed payment.

#### 2.7. Special conditions -

Without prejudice to the generality of the above, the contract manager will be entitled, subject to the approval of the authorized bodies in the Authority, to make changes to the content of the contract as a right of option available to the Authority, without changing the contract period and without changing the nature of the contract, in accordance with the Authority's procedures.

#### 2.8 General -

Without prejudice to the generality of the provisions of the tender documents, the winning bidder is obligated, among other things, to provide the services, as detailed below:

• Detecting and handling faults.

• Supply and replacement of defective hardware, according to the organization's procedures.

- Performing software upgrades (at least once every three months, updates Operating systems, critical updates and any other updates required by Authority) and hardware (according to the agreement).
- Performing software updates for workstations and servers according to manufacturer's instructions.
- Installation, maintenance and updating of an anti-violence system (type to be coordinated with the Authority with the winning bidder) which will be updated once a week, and which will allow Blocking the connection of external devices.
- Conducting training for all users.
- Performing installations and additions to the control system.
- Maintaining control panels according to an annual maintenance plan.
- Performing a full monthly backup for workstations and servers or in cases of Making updates or changes to the system, immediate backup.
- Writing software for the programmed controllers, if a change is required Will be performed during normal business hours without charge.
- Writing an HMI application for all control systems.
- Programming lighting or air conditioning according to schedules at 4 levels at least.

The service will be provided at Ramon Airport only by one employee on site during working hours.

The offeror, during working hours, Sunday - Thursday, 08:00 - 17:00.

The winner will be required to maintain a programming team for complex requirements as well as backup if necessary,

As detailed in the technical specifications for the maintenance team, section 3.4.

3.2 The Authority shall be entitled at any time and at its sole discretion to change, including postponing, the deadlines specified in Section 3.1 above for one or more specified periods. Notices of such postponement shall be published in the system, and the provisions of Sections 10.4-10.5 below shall apply to them. All provisions that applied to the deadlines that preceded them shall apply to the new deadlines determined by the Authority, to the extent that they are determined. For the avoidance of doubt, nothing in this section shall guarantee the granting of any extension.

3.3. The change in deadlines will not be intended to derogate from any other and/or additional right available to the Authority under the tender documents and/or by law, and the Bidder hereby waives it finally and irrevocably, and will be prevented and silenced from raising any claim and/or claim and/or demand in connection with the exercise of the Authority's rights in accordance with the provisions of subsection 3.2 above.

#### 4. Tender documents

4.1 The following documents shall together constitute the Tender Documents (in this invitation: "**Tender Documents**"):

4.1.1 This Invitation to Bid and its annexes which form an integral part thereof (hereinafter: "**the Invitation**"), including:

4.1.1.1 The Bidder's Declaration on its annexes that form an integral part thereof, attached as **Annex D** to the Invitation (hereinafter: "**Bidder's Declaration**").

4.1.2. A contract with its annexes which form an integral part thereof (hereinafter: "**the contract**").

4.1.2.1 In this regard, it is clarified and emphasized that in accordance with the provisions of Section 7 below, the bidder must attach as an integral part of its bid **Appendices A-D1** attached to the contract.

4.1.2.2 The bidder will be required to sign the remaining annexes to the contract, i.e., **annexes E-1H, K, X, X, X, 2K, 2K, 2K, 2K, 2K**, which are detailed in the list of annexes to the contract, and which appear in the system - as part of his declaration. **By signing, the bidder will confirm that he has read and understood the terms of the annexes as stated and that he accepts them in full.** For the avoidance of doubt, it is clarified and emphasized that at the stage of submitting bids for the tender, bidders are not required to submit **annexes E-1H, K, X, X, X, 2K, 2K** to the contract.

4.1.2.3 The appendices as stated in section 4.1.2.2 above will be attached by the Authority as an integral part of the contract subject to the tender, which will be signed with the winning bidder, as detailed in section 15 below.

4.1.3 Any clarification document and/or addition to the tender that will be issued in writing by the Authority, as part of the tender process.

#### 4.2 Review of the tender documents

4.2.1 Any person wishing to participate in the tender may review **the invitation to submit bids** only via the Authority's website: **il.gov.iaa.www** ( in this invitation: "**Website**"), under the "Tenders and Contracts" tab. Any person wishing to participate in the tender may review **the tender documents**

(including the invitation to submit bids, the contract, the annexes to the contract, and any document that will be distributed as part of the tender, as detailed in Section 4.2.2 below ) via the **SourcingVision** system of Mashik Ltd. (above and hereinafter: **the "System"**) by clicking on the "Link to the Mashik website for viewing documents and submitting bids" on the website under the "Tenders and Contracts" tab (the link refers to the tender documents as published

4.2.2 Any clarification and/or change and/or update that will be distributed within the framework of the tender will also be attached as an integral part of the tender documents in the system, in such a way that any person can review the tender documents at any time, as well as any clarification and/or change and/or update that will be distributed within the framework of the tender as of the said review date.

4.2.3 For the convenience of bidders in the tender, a link is attached that appears in every Authority tender, on the website, under the name "Link to the Instruction Manual for Submitting Bids", under the "Tenders and Contracts" tab. The booklet provides guidance to bidders, among other things, regarding submitting documents and price bids in the digital box (hereinafter: **the "Instruction Manual"**).

4.3 The Authority shall be entitled, at its sole discretion, to make changes and/or amendments to any of the tender documents, prior to the conclusion of the tender process, all without the bidder having any claim and/or claim in this regard. The bidder shall not be entitled in any way

or manner to make any changes, of any kind whatsoever, to the tender documents (including any clarification published within the framework thereof). Any changes or additions made to the tender conditions or tender documents by the bidder, or any reservations made by the bidder regarding them, whether by an addition to the tender documents or in an accompanying letter or in any other way, may result in the rejection of the bid, all in accordance with and subject to the sole discretion of the Authority. **Furthermore, the bidder hereby declares and undertakes that he is aware of and**

**agrees to the authority's powers as stated in the instructions of the invitation above and below, and he hereby waives them finally, fully and irrevocably, and will also be prevented and silenced from raising any claim and/or claim and/or demand, of any kind whatsoever, in connection with the exercise of the authority's powers and/or as a result of the consequences of exercising such authority.**

4.4 The copy kept in the Authority's offices is the binding copy for the purpose of this tender, and no document will constitute a substitute for it and no version will prevail over it, including any document that the Authority allows the bidder to draft himself, to the extent that it allows this.

#### 5. Methods of contacting the bidder

As part of entering the tender in the system, by clicking on the "Link to the launching site for viewing documents and submitting bids" on the website, under the "Tenders and Contracts" tab, and approving the regulations, as detailed on page 6 of the instruction booklet, the bidder's latest details will be provided to the Authority, including full name, address, telephone number, fax number, and email address.

#### 6. Preliminary and additional conditions for participation in the tender

6.1 Only bidders who cumulatively meet all the preliminary conditions detailed below may submit bids:

6.1.1 A bidder who, as of the deadline set for submitting bids in the tender, is a corporation legally registered in Israel, or a legally licensed dealer in Israel who is not a registered corporation.

6.1.2 The aforementioned bidder, who, during the last 5 years, preceding the deadline set for submitting bids in the tender, cumulatively meets all of the following conditions:

.6.1.2.1 Has experience in providing maintenance services for at least one control system, for at least 3 years;

And also -

.6.1.2.2 Has experience in establishing at least 2 control systems.

It is clarified that in order to prove the bidder's compliance with the prerequisite conditions 6.1.2 above, the bidder is required to prove work with at least one control system that includes controllers manufactured by the company.

6.1.3 The aforementioned bidder, who, as of the last date set for submitting bids in the tender, employs at least 5 professional employees, who are at least holders of an engineering or engineering certificate, registered in the Register of Engineers and Technicians or in the Register of Architects and Engineers, in accordance with the provisions of Section 9 of the Engineers and Architects Law, 5718-1958 (as applicable), in at least one of the following fields:

machinery and/or electricity and electronics and/or mechatronics

and/or software and/or control. For the purposes of Sections 6.1.2 and 6.1.3 above (as applicable), and elsewhere in the order form, the following terms shall have the

following meanings: **"Control System"** - a building or industrial control system that includes at least 30 control panels and 5000 I/O .

**"Employer"** - employees of the Bidder, who belong to its workforce and are employed by it on a permanent basis (and are subject to an employee-employer

relationship). **"During"** - during the period as stated and not necessarily a continuous period.

6.1.4 The aforementioned bidder, who, as of the last date set for submitting bids in the tender, meets the requirements of sections 2, 2B. and 2-B1. of the Public Bodies Transactions Law, 5736-1976 (hereinafter: **the "Public Bodies Transactions Law"**).

6.1.5 The aforementioned bidder, who himself and/or someone on his behalf, participated in the meeting/tour for bidders in the tender.

**6.2. Restrictions on participation in the tender**

Bids may not be submitted jointly, meaning one bid submitted by two or more bidders, jointly. **6.2.1**

**6.2.2** Each bidder may submit only one bid.

**6.2.3. Restrictions regarding employees and former retirees: 6.2.3.1.**

**Restriction regarding the refund of funds in the event of early retirement:**

A bidder who, or someone on his behalf proposed by him to serve as a service provider, retired from the Authority through early retirement during the 3 years preceding the deadline set for submitting bids in the tender, and received benefits from the Authority as part of the early retirement (to which he would not have been entitled if it were not for the early retirement from the Authority) (hereinafter: **"the retiree"**), may submit his bid only subject to his signature and the signature of the service provider on his behalf on the undertaking attached as **Appendix F** to the invitation, according to which, if he wins the tender, he undertakes to return the early retirement benefits or part of them to the Authority, taking into account the date of early retirement and according to the terms of the undertaking. In cases where the retiree is a majority shareholder or CEO of a proposing company, which is not proposed to serve as a service provider to the Authority personally, the Authority reserves the discretion to apply this clause in relation to him.

**6.2.3.2 Restriction on Conflict of Interest: The**

Authority may reject a proposal from a bidder who, or someone on his behalf proposed by him to serve as a service provider, is a former employee of the Authority, for reasons related to concerns about a conflict of interest and/or a violation of integrity and/or maintaining public trust. In addition, the Authority

may reject, without limitation, a proposal from someone who has retired from the Authority and, upon termination of his employment with the Authority, handled a particular matter of

A certain person and a service provider represented that certain person's matter before the Authority. In addition, the Authority may reject a proposal for the provision of services that includes representing a person before an Authority employee who was subordinate to a service provider and/or someone on his behalf on the eve of the termination of his employment with the Authority, and the services include a request to grant a right (in an agreement or act of the Authority), with the granting being at the discretion of that employee; as long as one year has not passed from the date on which the subordination relationship between the service provider and/or someone on his behalf and the Authority

employee as aforesaid ceased. In addition, the Authority may reject a proposal from a bidder who, or the person proposed to serve as a service provider on his behalf, is/are a former employee of the Authority who was/were authorized (by himself or together with others) to grant a right and/or recommend granting it and/or was in charge of another employee who was authorized as aforesaid and who, as the provider of the services and/or on behalf of the service provider, will receive a right from the person who needed his decision or recommendation as aforesaid. This provision shall apply for a period of up to 12 months from the date of termination of the employee's employment. Formerly in the PA.

In this section, "**offeror**" – includes a majority shareholder of a corporation and/or a CEO of a corporation.

#### 6.2.3.3 Restrictions regarding contracting with Authority retirees: The

Authority shall be entitled to reject a bidder's proposal or limit the duration of the contract and/or its scope and/or terminate the contract, insofar as it concerns a service provider on its behalf or the employee assigned on its behalf to provide the services is a retiree of the Authority. The decision in this matter shall be made, inter alia, taking into account the date of retirement, the position held as an employee, as well as the nature and/or essentiality and/or uniqueness and/or location of the services and/or the tasks that will be required for them in the framework of providing the services, all at the discretion of the Authority and taking into account the limitations and rules applicable to contracting with a service provider who has retired from the civil service, with the necessary adjustments.

6.2.4 A participant who has provided goods/services to the Authority, and whose contract was canceled by the Authority due to his failure to comply with the terms of the contract and his breach of the contract, during the 3 years preceding the date of publication of this tender, is not entitled to submit a bid for this tender. In the event that he has submitted a bid, the bid will be rejected outright and will not be discussed.

6.2.5 The Authority may reject a bid from a bidder who withdrew his bid in a tender published by the Authority or from his bid in another competitive procedure published by the Authority, after being declared the winner of that procedure, or who provided the Tender Committee with misleading information, or who acted fraudulently during the tender, during the 3 years preceding the date of publication.

This tender.

6.2.6 The Authority shall be entitled, at its sole discretion and subject to the granting of the right to argue, to reject a bid and/or participation in the procedure, of a participant with whom the Authority has had and/or has a negative, bad and/or failed experience, including lack of trust, significant lack of satisfaction with the performance of works/provision of services by him and/or anyone on his behalf, and/or unfair and improper conduct on his part, etc., within the framework of one or more previous and/or existing engagements between the Authority and that participant for the type of services or works that are the subject of the procedure. The entity that has accumulated that negative/bad/failed experience will be referred to hereinafter as: "**the contracting party**".

The aforementioned

restriction shall apply (a) also in relation to a participant that is a "**related entity**": (i) a legal entity that holds holdings, directly or indirectly, in the contracting party; (ii) a legal entity in which the contracting party holds holdings (iii) in it, directly or indirectly;

A legal entity with which the contracting party is jointly owned, directly or indirectly, and (b) even if there is a change in the contracting party's holdings in the relevant related entity/in the holdings of the relevant related entity in the contracting party, between the deadline set for submitting bids in the tender and the date on which that negative/bad/failed experience was accumulated.

#### 6.2.7 Violation of tender conditions

A bidder who (a) provides the Tender Committee with misleading information; and/or (b) acts fraudulently during the tender; and/or (c) withdraws his bid for the tender, after being declared the winner; and/or (d) after entering into a contract with him, the contract is canceled by the Authority due to his failure to comply with the terms of the contract and his breach of the contract, the Authority will be entitled to prevent him from participating in future tenders of the Authority and/or in any other contracting procedure, for a period of up to 3 years from the date of the Authority's decision in his case, in accordance with the Authority's sole discretion, and without this detracting from and/or harming any other right of the Authority to claim from the bidder any other and/or additional damage and/or to take any procedure against the bidder under any law and/or under the tender documents, including under the provisions of this section, if any of its circumstances exist, and including forfeiture of the guarantee (to the extent it exists). In connection with the exercise of the Authority's rights as aforesaid. The Authority will exercise its right under this subsection

after providing the bidder with written notice thereof, and subject to the holding of an inquiry procedure. In addition, the Authority will be entitled to prevent

participation as aforesaid, not only from that bidder, but also from a related entity (as defined in Section 6.2.6 above). In addition, the Authority will be entitled to prevent participation as aforesaid, even in the event that there is a change in the parties holding the holdings in that bidder/in the holdings of that bidder himself, between the date on which any of the events specified above occurred, and the deadline set for submitting bids in the future tender to which the incentives will apply.

#### 6.2.8 Criminal background check

In accordance with the provisions of the Criminal Information Law, 5779-2019 (hereinafter: **the "Criminal Information Law"**), the Tenders Committee shall be entitled to bring criminal information at its discretion as specified in the Fourth Schedule to the Criminal Information Law regarding the Bidder and/or any officer of the Bidder concerned and/or any controlling party of the Bidder and/or proposed service providers (if any), inter alia as brought to its attention in accordance with the provisions of **Appendices C/C1** to the Invitation, and it shall be entitled, but not obliged, in accordance with its absolute discretion, to reject a bid or not to reject a bid, inter alia, for considerations relating to the reliability and integrity of the Bidder and/or any officer of the Bidder concerned and/or controlling party of the Bidder, and for this purpose it shall consider considerations as specified in Section 36 of the Criminal Information Law relating, inter alia, to the nature of any offense that is the subject of the aforementioned criminal information and its circumstances (including the scope of the offense). and the date of its execution, with emphasis on the time that has passed since the date of the commission of the offense, the moral turpitude and the profit that arose from the commission of the offense), the age of the person on the day the offense was committed, the existence of criminal record details or additional police record details, the number and nature of the registration details (as far as the Authority knows of such), the stage in which the criminal proceedings are, the known evidentiary infrastructure, the behavior of the bidder after the commission of the offense or the disclosure of suspicions, and so on.
