1. The Government of Samoa has provided funding towards the procurement of Vehicle Tracking Services for MOH Vehicles 2025-2027 as part of the initiative to improve the health service delivery. The Ministry of Health (MOH) is responsible for delivery of publicly funded health services in Samoa. Transport services managed under the Finance, Asset and Procurement Division in MOH, provides transportation of staff that work after normal hour shifts, community outreach programs, daily transport required tasks as well as ambulance services in both Upolu and Savaii.
2. Interested eligible bidders may obtain further information and inspect the bidding documents from the MOH Finance and Procurement Division from Monday to Friday from 9am – 4pm local time. Additional details are provided in the Bidding Documents.
