- 3. Tenderers meeting the above eligibility criteria can upload the detailed tender document on the CPP Portal https://eprocure.gov.in/eprocure/app with effect from 23.08.2024 to 12.09.2024. The tender documents to be accompanied along with all documents as mentioned above should be submitted as on the due date mentioned in para 1 above.
- 4. The documents furnished by the tenderers will be subjected to verification subsequently by the Institute. If found not meeting the requirements, such offers will be rejected.
- 5. Tenders should be accompanied with Earnest Money Deposit for value specified in Para 1 above, in the form of Demand Draft/Deposit at Call receipt/ Term Deposit Receipt of any Scheduled Bank issued in favour of *Director*, *NIT MeghalayaShillong*, *payable at SBI Malki (Dhanketi)*, *Shillong* (or) in the form of Bank Guarantee issued by a scheduled bank. Earnest Money Deposit shall be valid for 180 daysfrom the due date of receipt of tenders.
- 6. The bidders should download the **BoQ.xIs** from CPP Portal and filled in the blank spaces provided for mentioning the name of bidder and rates. Bidders need not modify any other text or background shown in the BOQ template or replace it with any other copy of same **BOQ in .xIs format**. NIT Meghalaya /Central Public Procurement Portal (www.eprocure.gov.in) will accept the BOQ template only and hence the rate should not be quoted in any other place except BOQ template
- 7. The technical bids will be opened online by a committee of members duly constituted for the purpose at the time and date as specified in the tender document. All statements, documents, certificates, Affidavits, etc uploaded by the bidders will be verified and downloaded for technical evaluation and the result of technical bid evaluation will be displayed on www.eprocure.gov.in. in which can be seen by all bidders who participated in the tender.
- 8. The Financial bid (price bid) i.e. Bill of Quantity (BOQ) of only technically qualified bidders will be opened by a committee of members and the result will be displayed on the www.eprocure.gov. in which can be seen by all bidders who participated in the tender.

- 9. The offer must be submitted in Two Bid Two Files/Covers only through uploading in the CPP Portal, before the last date & time for bid submission. Bidders must submit their digitally signed bids. The covers will contain the following documents:
 - Cover 1 which consists of technical requirements and general terms & conditions along with credentials.
 - ii. Cover 2 which consist of the Price Bid (BoQin Ms-Excel format).
 - 10. Tenderer(s) quoted below the tender value of the work shall not be accepted.
 - 11. Tenderers shall sign all the pages of Technical & Commercial Bid and Price Bid without fail. The full set of tender document, duly filled in at required pages, along with drawings (if supplied) should be submitted along with the tender.
 - 12. On the due date of opening, the Cover (i) will be opened initially of those tenderers who furnished valid EMD. On opening of Technical&Commercial Bid, further detailed scrutiny / evaluation will be carried out. During the evaluation of techno-commercial bids, the documents furnished by the tenderers will be scrutinized in detail. Any tender, found as not fulfilling the eligibility criteria will be rejected at this stage and such offers will not be considered for further processing. At this stage, the competency of the tenderers will be further evaluated by a Technical Evaluation Committee (TEC), The price bid of only those tenderers who have been qualified during the scrutiny and technical evaluation will be opened separately on a specified date (with due intimation to the qualified bidders) and further processed, as per tender procedure/ stipulations.
 - 13. The contractor, whose offer is accepted, will be required to furnish performance guarantee of 5% of the tendered amount within 15 days from the date of issue of letter of intent/ work order. This guarantee shall be in the form of Deposit at Call receipt/ Term Deposit Receipt of any Scheduled Bank issued in favour of *Director, NITMeghalayaShillongpayable at SBI Malki (Dhanketi,Shillong* (or) in the form of Bank Guarantee issued by a scheduled bank in accordance with the prescribed form. In case the contractor fails to deposit the said performance guarantee within the period specified including the extended period if any, the Earnest Money deposited by the contractor will be forfeited and letter of intent/ work order cancelled automatically without any notice to the contractor. The Earnest Money deposited along with tender shall be refunded only after receiving the aforesaid performance guarantee.
 - 14. Intending tenderers may inspect the site before submitting the tenders, with the prior permission of *Director*, *NIT Meghalaya*.
 - 15. The **Director**, **NIT Meghalaya** is not bound to accept the lowest or any other tender and reserves the authority to reject any or all the tenders received without assigning any reason. All tenders in which any of the prescribed condition is not fulfilled or any condition including that of conditional rebate is put forth by the tenderer shall be summarily rejected.
 - 16. The **Director**, **NIT Meghalaya** reserves the right to alter the scope/ or reduce quantum of work before issue of work order and the tenderer shall not have any claim what so ever on this account.

- 17. The **Director**, **NIT Meghalaya** reserves the right of accepting the whole or any part of the tender and the tenderer shall be bound to perform the same at the rate quoted.
- 18. Canvassing directly or indirectly, in connection with tender is strictly prohibited and the tenders submitted by the contractors who resort to canvassing will be liable for rejection.
- 19. The tenderer shall submit along with the tender all the mandatory documents required for construction works;viz; Registration Certificate, GST Registration, Valid Tax Clearance Certificate, PAN Card, EPIC, ST Certificate, Trading License (as applicable) ,TIN/TAN,Labour License,EPFO Registration Certificate, etc. are to be submitted along with the tender; failing which tender(s) will summarily be rejected.
- 20. Non-Tribal contractors shall produce/furnish valid "Trading License" issued by the competent authority for undertaking work in Meghalaya as per the extant rules of statutory authority; without which tender shall be disqualified.
- 21. Contractor shall follow all laws, regulations and acts of Central/ State Government and other statutory bodies relating to engaging labourers in work, wages and all related provisions and indemnify Government/Institute against payment to be made under and for the observance of the said labour laws.
- 22. The **Director, NIT Meghalaya** reserves the option to give preferences to the offers in accordance with the policies of the Government from time to time.
- 23. The acceptance of the tender will rest with the **Director, NIT Meghalaya** who does not bind himself to accept the lowest or any other tender. No reasons will be furnished for the acceptance or rejection of any tender. NIT Meghalaya reserves the right to accept or reject any tender without assigning any reason (s) thereof
- 24. The contractor shall not be permitted to tender for works in the particular Centre/Section/Department of the Institute responsible for award and execution of contracts for which his/her near relative is working. He/she shall also intimate the names of persons who are working with him in any capacity or are subsequently employed by him and who are near relatives to any Gazetted Officer in the Institute. Any breach of this condition by the contractor would render him liable for rejection of tender or cancellation of contract.
- 25. The tender should be valid for **minimum period of 120days** from the due date of receipt of the tender specified in Para 1 above. If any tenderer withdraws the offer within the validity period or makes any modifications in the terms and conditions of the tender which are not acceptable to the Institute, the Government shall without prejudice to any other right or remedy, be at liberty to forfeit 50% (Fifty Percent) of the Earnest Money Deposit absolutely. Further, the tenderer shall not be allowed to participate in the re-tendering process of the work.
- 26. On concluding the tender, an agreement shall be drawn with the successful tenderer.

C.DEFINITIONS

DEFINITIONS

1. CONTRACT:

The 'Contract' means the documents forming the tender and acceptance thereof and the formal agreement executed between the Director, NITMeghalaya and the Contractor, together with the documents referred to therein including these conditions, the specifications, design, drawings and instructions issued from time to time by the Engineer-in-charge and all these documents taken together shall be deemed to form one contract and shall be complementary to one another.

2. CONTRACTOR:

The 'Contractor' means the individual or firm or company, whether incorporated or not, undertaking the work and shall include the legal personal representatives of such individual or the persons composing such firm or the successors of such firm or company and the permitted assignee of such individual or firm or firms or company.

3. DEPARTMENT:

'Department' means NIT Meghalaya.

4. ENGINEER-IN-CHARGE:

The 'Engineer-in-charge' means the Executive Engineer/Junior Engineer as the case may be, or the appropriate competent authority declared by the Institute who shall supervise and be in charge of the work and who shall sign the contract on behalf of the Director, NITMeghalaya.

5. WORK (S):

The expression 'Works' or 'Work' shall unless there is something either in the subject or context repugnant to such construction, be construed and taken to mean the works by or by virtue of the contract contracted to be executed whether temporary or permanent and whether original, altered, substituted or additional.

6. SITE:

The 'Site' means the land/or other places on, into or through which work is to be executed under the contract or any adjacent land, path or street through which work is to be executed under the contract or any adjacent land, path or street which may be allotted or used for the purpose of carrying out the contract.

7. MARKET RATE:

'Market Rate' shall be the rate as decided by the Engineer-in-charge on the basis of the cost of materials and labour at the site including applicable taxes, duties and also the transportation charge to where the work is to be executed plus the percentage mentioned in schedule `F' to cover all overheads and profits.

8. SCHEDULE (S): 'Schedule(s)' referred to in these conditions shall mean the relevant schedule (s) annexed to the tender papers.

9. SCHEDULE OF RATES (SOR):

Meghalaya PWD SOR (Building Works) 2021-22 mentioned in the schedule `F' here under, with the amendments thereto issued upto the date of receipt of tender.

10. TENDERED VALUE:

CLAUSE 1

PERFORMANCE GUARANTEE

- The contractor shall submit an irrevocable Performance Guarantee of 5% of the (i) 'tendered amount' in addition to other deposits mentioned elsewhere inthe contract for his proper performance of the contract agreement, (not withstandingand/or without prejudice to any other provisions in the contract) within period of 15days from the date of issue of letter of acceptance. This period can be furtherextended by the Engineer-in-charge upto a maximum period of 15 days on writtenrequest of the contractor stating the reason for delays in furnishing the Guarantee, tothe satisfaction of the Engineer-in-charge. This guarantee shall be in the form of Cash(in case guarantee amount is less than Rs.10,000/-) or Deposit at Call receipt of anyscheduled bank/Banker's Cheque of any scheduled bank/Demand Draft of anyscheduled/Pay Order of any scheduled bank (in case quarantee amount is less than Rs. 1,00,000/-) or Government Securities or Fixed Deposit Receipts or GuaranteeBonds of any Scheduled Bank or the State Bank of India in accordance with the formannexed hereto. In case a fixed deposit receipt of any Bank is furnished by the contractor to the Government as part of the performance guarantee and the Bank isunable to make payment against the said fixed deposit/receipt, the loss causedthereby shall fall on the contractor and the contractor shall forthwith on demand furnishadditional security to the Government to make good the deficit.
- (ii) The Performance Guarantee shall be initially valid upto the stipulated date of completion plus 60 days beyond that. In case the time for completion of work getsenlarged, the contractor shall get the validity of Performance Guarantee extended to cover such enlarged time for completion of work. After satisfactory taking over the building/facility, with no defects, the performance guarantee shall be returned to the contractor without any interest within 14 days.
- (iii) Incase of works where high value equipments under AC/ Electrical/ Mechanical areinvolved and wherever explicitly mentioned in this contract, for such works, thePerformance Guarantee shall be refunded only after the defect liability period of oneyear from the date of completion.
- (iv) The Engineer-in-Charge shall not make a claim under the performance guaranteeexcept for amounts to which the President of India/Director, NIT Meghalaya is entitled under the contract(not withstanding and/or without prejudice to any other provisions in the contractagreement) in the event of :
 - a) Failure by the contractor to extend the validity of the Performance Guarantee asdescribed herein above, in which event the Engineer-in-Charge may claim the fullamount of the Performance Guarantee.
 - b) Failure by the contractor to pay President of India/Director, NIT Meghalaya any amount due, either as agreedby the Contractor or determined under any of the Clauses/Conditions of theagreement, within 30 days of the service of notice to this effect by Engineer-in-Charge.
- (v) In the event of the contract being determined or rescinded under provision of any ofthe Clause/Condition of the agreement, the performance guarantee shall standforfeited in full and shall be absolutely at the disposal of the President of India/Director, NIT Meghalaya.

CLAUSE 1A SECURITY DEPOSIT

The security deposit of 5% shall be deducted from each RA bill of the contractor and the same shall be valid/retained for the entire defect liability period mentioned in Clause 17A.

All compensations or the other sums of money payable by the contractor under the terms of this contract shall be deducted from this security deposit.

CLAUSE 2A COMPENSATION FOR DELAY

If the contractor fails to maintain the required progress in terms of clause 5 or to complete the work and clear the site on or before the contract or extended date of completion, he shall, without prejudice to any other right or remedy available under the law to the Government on account of such breach, pay as agreed compensation, the amount calculated as stipulated below for every completed day/ month (as applicable) that the progress remains below that specified in Clause 5 or that the work remains incomplete. This will also apply to items or group of items for which a separate period of completion has been specified.

Provided always that the total amount of compensation for delay to be paid under this Condition shall not exceed 10% of the total tendered value of work or of the tendered value of the item or group of items of work for which a separate period of completion is originally given. The amount of compensation may be adjusted or set-off against any sum payable to the contractor under this or any other contract with the Government.

CLAUSE 2B MILESTONES

In case the contractor does not achieve a particular milestone mentioned in schedule 'F', or the re-scheduled milestone(s) in terms of Clause 5.4, the amount shown against that milestone shall be withheld, to be adjusted against the compensation levied at the final grant of Extension of time. Withholding of this amount on failure to achieve a milestone shall be automatic without any notice to the contractor. However, if the contractor catches up with the progress of work on the subsequent milestone(s), the withheld amount shall be released. In case the contractor fails to make up for the delay in subsequent milestone(s), amount mentioned against each milestone missed subsequently also shall be withheld. However, no interest, whatsoever, shall be payable on such withheld amount.

CLAUSE 3 DETERMINATION OF CONTRACT

Subject to other provisions contained in this clause, the Engineer-in-charge may, without prejudice to his any other rights or remedy against the contractor in respect of any delay,inferior workmanship, any claims for damages and/or any other provisions of this 1 contract or otherwise, and whether the date of completion has or has not elapsed, by notice in writing absolutely determine the contract in any of the following cases:

i) If the contractor having been given by the Engineer-in-Charge a notice in writingto rectify, reconstruct or replace any defective work or that the work is beingperformed in an inefficient or otherwise improper or un-workman like manner shallomit to comply with the requirement of such notice for a period of seven daysthereafter.

- ii) If the contractor has, without reasonable cause, suspended the progress of the workor has failed to proceed with the work with due diligence so that in the opinion ofthe Engineer-in-Charge (which shall be final and binding), he will be unable tosecure completion of the work by the date for completion and continues to do so after notice in writing of seven days from the Engineer-in-Charge.
- iii) If the contractor fails to complete the work within the stipulated date or items of workwith individual date of completion, if any stipulated, on or before such date(s) of completion and does not complete them within the period specified in a notice givenin writing in that behalf by the Engineer-in-Charge.
- iv) If the contractor persistently neglects to carry out his obligations under the contractand/ or commits default in complying with any of the terms and conditions of the contract and does not remedy it or take effective steps to remedy it within 7 days after anotice in writing is given to him in that behalf by the Engineer-in-Charge.
- v) If the contractor shall offer or give or agree to give to any person in Governmentservice or to any other person on his behalf any gift or consideration of anykind as an inducement or reward for doing or forbearing to do or for having done orforborne to do any act in relation to the obtaining or execution of this or anyother contract for Government.
- vi) If the contractor shall enter into a contract with Government in connection with whichcommission has been paid or agreed to be paid by him or to his knowledge, unlessthe particulars of any such commission and the terms of payment thereof have been previously disclosed in writing to the Engineer-in-Charge.
- vii) If the contractor had secured the contract with Government as a result ofwrong tendering or other non-bonafide methods of competitive tendering or commitsbreach of Contract or Integrity Agreement.
- viii) If the contractor being an individual, or if a firm, any partner thereof shall at any timebe adjudged insolvent or have a receiving order or order for administration of hisestate made against him or shall take any proceedings for liquidation or composition(other than a voluntary liquidation for the purpose of amalgamation or reconstruction)under any Insolvency Act for the time, being in force or make any conveyance orassignment of his effects or composition or arrangement for the benefit of hiscreditors or purport so to do, or if any application be made under any Insolvency Actfor the time being in force for the sequestration of his estate or if a trust deed beexecuted by him for benefit of his creditors.
- ix) If the contractor being a company shall pass a resolution or the court shall make anorder that the company shall be wound up or if a receiver or a manager on behalf of creditor shall be appointed or if circumstances shall arise which entitle the court orthe creditor to appoint a receiver or a manager or which entitle the court to make a winding up order.
- x) If the contractor shall suffer an execution being levied on his goods and allow it to becontinued for a period of 21 days.
- xi) If the contractor assigns, transfers, sublets (engagement of labour on a piece-workbasis or of labour with materials not to be incorporated in the work, shall not bedeemed to be subletting) or otherwise parts with or attempts to assign, transfer, sublet or otherwise parts with the entire works or any portion thereof without priorwritten approval of the Engineer-in-charge.

When the contractor has made himself liable for action under any of the cases aforesaid, the Engineer-in-charge on behalf of the President of India/Director, NIT Megha; aya shall have powers:

a) To determine the contract as aforesaid (of which termination notice in writing to the contractor under the hand of the Engineer-in-charge shall be conclusive evidence). Upon such

- determination, Performance Guarantee under the contract shall be liableto be forfeited and shall be absolutely at the disposal of the Government.
- b) After giving notice to the contractor to measure up the work of the contractor and totake such whole, or the balance or part thereof, as shall be un-executed out of hishands and to give it to another contractor to complete the work. The contractor, whose contract is determined as above, shall not be allowed to participate in the tendering process for the balance work.

In the event of above courses being adopted by the Engineer-in-charge, the contractor shall have no claim to compensation for any loss sustained by him by reasons of his having purchased or procured any materials or entered into any engagements or made any advances on account or with a view to the execution of the work or the performance of the contract. And in case action is taken under any of the provision aforesaid, the contractor shall not be entitled to recover or be paid any sum for any work thereof or actually performed under the contract unless and until the Engineer-in-charge has certified in writing the performance of such work and the value payable in respect thereof and he shall only be entitled to be paid the value so certified.

CLAUSE 3A

CLOSING OF CONTRACT BY EITHER PARTY

In case the work cannot be started due to reasons not within the control of the contractor within 1/8th of the stipulated time for completion of work or one month whichever is higher, either party may close the contract. In case contractor wants to close the contract, he shall give notice to the department stating the failure on the part of department. In such eventuality, the Performance Guarantee of the contractor shall be refunded within following time limits, without any interest. The contractor will not be eligible for any compensation for any damages what so ever caused due to closing of contract.

If the Tendered value of work is, upto Rs. 45 lac: 15 days.

more than Rs.45 lac& upto Rs.2.5 Cr : 21 days.

exceeds Rs. 2.5 Cr: 30 days.

CLAUSE 4

CONTRACTORS REMAIN LIABLE TO PAY COMPENSATION, EVEN IF ACTION NOTTAKEN UNDER CLAUSE 3

In any case in which any of the power conferred upon the Engineer-in-charge by clause-3 thereof shall have become exercisable and the same shall not be exercised, the non-exercise hereof shall not construe a waiver of any of the conditions hereof and such powers shall not be withstanding exercisable in the event of any future case of default by the contractor and the liability of the Contractor for compensation shall remain unaffected (for which by any clause or clause hereof, he is declared liable to pay compensation amounting to the extent of his security deposit and the liability of the Contractor for past and future compensations shall remain unaffected). In the event of the Engineer-in-charge putting in force all or any of the powers vested in him under the preceding clauses he may, if he so desires after giving a notice in writing to the Contractor, take possession of (or at the sole discretion of Engineer-in-charge which shall be final) use as on hire (the amount of the hire money being also in the final determination of the Engineer-in-charge) all or any tools, plant, materials and stores in or upon the words or the site then of belongings to the Contractor or procured by the Contractor and intended to be used for the execution of the work or any part thereof paying or allowing for the same in account at the contract rates, or in case of these not being applicable at current market rates to be certified by the Engineer-in-charge whose certificate thereof shall be final, otherwise the Engineer-incharge may by notice in writing to the Contractor or his clerk of the works, foreman or authorised agents requesting him/them to remove such tools, plant,

materials or stores from the premises (within a time to be specified in such notice) and in the event of the

Contractor failing to comply with any such requisition, the Engineer-in-charge may remove them at the Contractor's expenses or sell by auction or private sale on account of the Contractor and at his risk in all respects and the certificate of the Engineer-in-charge as to the expenses of any such removal and the amount of the proceeds and expenses of any such sale shall be final and conclusive against the Contractor.

CLAUSE 5

TIME AND EXTENSION FOR DELAY

The time allowed for execution of the Works as specified in the Schedule 'F' or the extended time in accordance with these conditions shall be the essence of the Contract. The execution of the works shall commence from such time period as mentioned in schedule 'F' or from the date of handing over of the site whichever is later. If the Contractor commits default in commencing the execution of the work as aforesaid, Government shall without prejudice to any other right or remedy available in law, be at liberty to forfeit the Performance Guarantee absolutely.

5.1As soon as possible after the Contract is concluded, the Contractor shall submit aTime and Progress Chart for each mile stone and get it approved by the Department. The Chart shall be prepared in direct relation to the time stated in theContract documents for completion of items of the works. It shall indicate theforecast of the dates of commencement and completion of various trades of sections of the work and may be amended as necessary by agreement between theEngineer-in-Charge and the Contractor within the limitations of time imposed inthe Contract documents, and further to ensure good progress during the execution of the work, the contractor shall in all cases in which the time allowed for any work, exceeds one month (save for special jobs for which a separate programme hasbeen agreed upon) complete the work as per mile stones given in Schedule 'F'.

- a) Project Management shall be done by using project management software forworks costing more than Rs.5 Crore.
- b) The project management shall be done using MS Project software for works costingmore than Rs. 5 Crore and up to Rs. 20 Cr.

For works costing more than Rs. 20 Crore, project management shall be done using Primavera Software.

Programme Chart

- The Contractor shall prepare an integrated programme chart in MSProject/Primavera software for the execution of work, showing clearly all activities from the start of work to completion, with details of manpower, equipment &machinery required for the fulfillment of the programme within the stipulated periodor earlier and submit the same for approval to the Engineer-in-Charge within tendays of award of the contract. A recovery of Rs. 2500/- (for works costing upto Rs.20Crores)/ Rs. 5000/- (for works costing more than Rs. 20 Crores) shall be made onper day basis in case of delay in submission of the above programme.
- (ii) The programme chart should include the following:
 - a) Descriptive note explaining sequence of the various activities.
 - b) Network (PERT/CPM/BAR CHART).
 - c) Programme of procurement of machinery/equipments having adequate capacity, commensurate with the quantum of work to be done within the stipulated period,by the contractor. In addition to above to achieve the progress of Work as

perprogramme, the contractor must bring at site adequate shuttering materialrequired for cement, Concrete and R.C.C. works etc. for three floors within onemonth from the date of start of work till the completion of RCC work as perrequirement of work. The contractor shall submit shuttering schedule adequateto complete structure work within laid down physical milestone.

- (iii) If at any time, it appears to the Engineer-in-Charge that the actual progress of workdoes not conform to the approved programme referred above or after reschedulingof milestones, the contractor shall produce a revised programme within 7 (seven)days, showing the modifications to the approved programme to ensure timelycompletion of the work. The modified schedule of programme shall be approved bythe Engineer in Charge. A recovery of Rs. 2500/-(for works costing upto Rs. 20Crores)/Rs. 5000/- (for works costing more than Rs. 20 Crores) shall be made onper day basis in case of delay in submission of the modified programme.
- (iv) The submission for approval by the Engineer-in-Charge of such programme or such particulars shall not relieve the contractor of any of the duties or responsibilities under the contract. This is without prejudice to the right of Engineer-in-Charge to take action against the contractor as per terms and conditions of the agreement.
- (v) The contractor shall submit the progress report using MS Project/Primavera softwarewith base line programme referred above for the work done during previous monthto the Engineer-In-charge on or before 5th day of each month failing which arecovery Rs. 2500/- (for works costing upto Rs. 20 Crores)/Rs. 5000/- (for workscosting more than Rs. 20 Crores) shall be made on per day basis in case of delay insubmission of the monthly progress report.

5.2If the work(s) be delayed by:

- i) force majeure, or
- ii) abnormally bad weather, or
- iii) serious loss or damage by fire, or
- iv) civil commotion, local commotion of workmen, strike or lockout, affecting any of thetrades employed on the work, or
- v) delay on the part of other contractors or tradesmen engaged by Engineer-in-Charge in executing work not forming part of the Contract, or
- (vi) non-availability of stores, which are the responsibility of Government to supply or
- (vii) non-availability or break down of tools and Plant to be supplied or supplied byGovernment or
- (viii) Any other cause which, in the absolute discretion of the Engineer-in-Charge is beyond the Contractor's control.

Then upon the happening of any such event causing delay, the contractor shallimmediately give notice thereof in writing to the authority as indicated in schedule 'F'

but shall nevertheless use constantly his best endeavors to prevent or make good thedelay and shall do all that may be reasonably required to the satisfaction of the Engineer-in-charge to proceed with the works.

5.3 Request for rescheduling of milestones and extension of time, to be eligible forconsideration, shall be made by the Contractor in writing within fourteen days of thehappening of the event causing delay on the prescribed form Engineer-in-charge. The Contractor may also, if practicable, indicate in such a request the period for which extension is desired.

5.4 In any such case, Engineer-in-charge may give a fair and reasonable extension of time and reschedule the mile stones for completion of work. Such extension or rescheduling of the milestones shall be communicated to the Contractor by Engineer-in-charge in writing, within 3 months or 4 weeks of the date of receipt of such requestrespectively. Non application by the contractor for extension of time/ rescheduling of the milestones shall not be a bar for giving a fair and reasonable extension/rescheduling of the milestones by Engineer-in-charge and this shall be binding on the contractor.

CLAUSE 6 MEASUREMENT OF WORKDONE

Engineer-in-charge shall, except as other wise provided, ascertain and determine bymeasurement, the value in accordance with the contract of work done. All measurement of all items having financial value shall be entered in Measurement Book and / or level fieldbook so that a complete record is obtained of all works performed under the contract.

All measurements and levels shall be taken jointly by the Engineer-in-charge or hisauthorized representative and by the contractor or his authorized representative from timeto time during the progress of the work and such measurements shall be signed and datedby the Engineer-in-charge and the contractor or their representatives in token of theiracceptance. If the contractor objects to any of the measurements recorded, a note shall bemade to that effect with reason and signed by both the parties. If for any reason the contractor or his authorized representative is not available and thework of recording measurements is suspended by the Engineer-in-charge or hisrepresentative, the Engineer-in-charge and the Department shall not entertain any claimfrom contractor for any loss or damages on this account. If the contractor or his authorized representative does not remain present at the time of such measurements after the contractor or his authorized representative has been given a notice in writing three (3) daysin advance or fails to countersign or to record objection within a week from the date of themeasurement, then such measurements recorded in his absence by the Engineer-in-chargeor his representative shall be deemed to be accepted by the contractor.

The contractor shall, without extra charge, provide all assistance with every appliance, labour and other things necessary for measurements and recording levels. Except where any general or detailed description of the work expressly shows to the contrary, measurements shall be taken in accordance with the procedure set forth in the specifications notwithstanding any provisions in the relevant Standard Method of measurement or any general or local custom. In the case of items which are not coveredby specifications, measurements shall be taken in accordance with the relevant standardmethod of measurement issued by the Bureau of Indian Standards and if for any item nosuch standard is available, then a mutually agreed method shall be followed.

The contractor shall give, not less than seven days notice to the Engineer-in-Charge or hisauthorized representative in-charge of the work, before covering up or otherwise placing beyond the reach of measurement any work in order that the same may be measured and correct dimensions thereof be taken before the same covered up or placed beyond thereach of

measurement and shall not cover up and place beyond reach of measurementany work without consent in writing of the Engineer-in-charge or his authorized representative in-charge of the work who shall within the aforesaid period of seven days inspect the work, and if any work shall be covered up or placed beyond the reach of measurements without such notice having been given or the Engineer-in-charge's consentbeing obtained in writing, the same shall be uncovered at the Contractor's expense or indefault thereof no payment or allowance shall be made for such work or the materials with which the same was executed.

Engineer-in-charge or his authorized representative may cause either themselves orthrough another officer of the Department to check the measurements recorded jointly orotherwise as aforesaid and all provisions stipulated herein above shall be applicable tosuch checking of measurements or levels. It is also a term of this contract that recording of measurements of any item of work in themeasurement book and /or its payment in the interim, on account or final bill shall not beconsidered as conclusive evidence as to the sufficiency of any work or material to which itrelates nor shall it relieve the contractor from liabilities from any over measurement ordefects noticed till completion of the defects liability period.

CLAUSE 6A COMPUTERIZED MEASUREMENT BOOK

Engineer-in-charge shall, except as other wise provided, ascertain and determine bymeasurement the value of work done in accordance with the contract. All measurements of all items having financial value shall be entered by the contractor and compiled in the shape of the Computerized Measurement Book having pages of A04 sizeas per the format of the Department so that a complete record is obtained of all the items of works performed under the contract.

All such measurements and levels recorded by the contractor or his authorized representative from time to time, during the progress of the work shall be got checked bythe contractor from the Engineer-in-charge or his authorized representative as per intervalor programme fixed in consultation with Engineer-in-charge or his authorized representative. After the necessary corrections made by the Engineer-in-charge, themeasurement sheets shall be returned to the contractor for incorporating the corrections and for resubmission to the Engineer-in-charge for the dated signature by the Engineer-in-chargeand the contractor or their representatives in token of their acceptance.

Whenever bill is due for payment, the contractor would initially submit draft computerizedmeasurement sheets and these measurements would be got checked/ test checked from the Engineer-in-charge and /or his authorized representative. The contractor will, thereafter, incorporate such changes as may be done during these checks/test checks inhis draft computerized measurements, and submit to the Institute a computerizedmeasurement book, duly bound, and with its pages machine numbered. The Engineer-in-chargeand/or his authorized representative would thereafter check this MB, and record thenecessary certificates for their checks/test checks.

The final, fair, computerized measurement book given by the contractor, duly bound, withits pages machine numbered, should be 100% correct, and no cutting or over writing in themeasurements would thereafter be allowed. If at all any error is noticed, the contractorshall have to submit a fresh computerized MB with its pages duly machine numbered andbound after getting the earlier MB cancelled by the Institute. Thereafter, the MB shallbe taken in the Engineering Section Office records, and allotted a number as per the Register ofComputerized MBs. This should be done before the corresponding bill is submitted to theAccounts Section for payment. The contractor shall submit two spare copies of suchcomputerized MBs for the purpose of reference and record by the various officers of theInstitute.

The contractor shall also submit to the Institute separately his computerized Abstract ofCost and bill based on these measurements, duly bound, and its pages machine numberedalong with two spare copies of the 'bill'. Thereafter, this bill will be processed by Engineering Section Office and allotted a number as per the computerized record in the same way as done forthe measurement book meant for measurements.

The contractor shall, without extra charge, provide all assistance with every appliance, labour and other things necessary for checking of measurements/levels by the Engineer-in-chargeor his representative. Except where any general or detailed description of the work expressly shows to the contrary, measurements shall be taken in accordance with the procedure set forth in the specifications notwithstanding any provision in the relevant Standard Method of measurement or any general or local custom. In the case of items which are not coveredby specifications, measurement shall be taken in accordance with the relevant standardmethod of measurement issued by the Bureau of Indian Standards and if for any item nosuch standard is available, then a mutually agreed method shall be followed.

The contractor shall give not less than seven days notice to the Engineer-in-charge or hisauthorized representative in charge of the work before covering up or otherwise placingbeyond the reach of checking and /or test checking the measurement of any work in orderthat the same may be checked and /or test checked and correct dimensions thereof betaken before the same is covered up or placed beyond the reach of checking and /or testchecking measurement and shall not cover up and place beyond reach of measurementany work without consent in writing of the Engineer-in-charge or his authorizedrepresentative in-charge of the work who shall within the aforesaid period of seven daysinspect the work, and if any work shall be covered or placed beyond the reach of checkingand/or test checking measurements without such notice having been given or the Engineer-in-charge's consent being obtained in writing the same shall be uncovered at the Contractor's expense, or default thereof no payment or allowance shall be made for suchwork or the materials with which the same was executed.

Engineer-in-charge or his authorized representative may cause either themselves orthrough another officer of the Institute to check the measurements recorded bycontractor and all provisions stipulated herein above shall be applicable to such checkingof measurements or levels. It is also a term of this contract that checking and/or test checking the measurements of any item of work in the measurement book and/or its payment in the interim, on account offinal bill shall not be considered as conclusive evidence as to the sufficiency of any work ormaterial to which it relates nor shall it relieve the contractor from liabilities from any overmeasurement or defects noticed till completion of the defects liability period.

CLAUSE 7 PAYMENT

Payments will be made through running account bills based on the works executed on the basis of recorded measurements. The running account bills shall besubmitted by the contractor for the works executed on the basis of recorded measurements on the format of the Institute in triplicate.

Engineer-In-Charge shall arrange to have the bills verified by taking or causing to be taken wherever required the requisite measurement of the work. Payments on account of the amounts admissible shall be made by the Engineer-In-Charge certifying the sum to whichcontractor is considered entitled by way of running account bill at such rates decided by the Engineer-In-Charge.

The amount admissible shall be paid by tenth working day after the day of presentation of the bill by the contractor, together with all details. In the event of failure of the contractor to submit the bill, Engineer-In-Charge shall prepare or cause to be prepared such bill in which event no claim or what so ever on delay in payments shall be entertained.

However in respect of i) AC works and ii) Mechanical works viz., cranes, Monorail, specialconveyor system, sliding doors, platforms, passenger/service lifts, compressed air facility,hot water guarantors, rotors, flash mixers and agitators etc., a) 76.5% pro-rata payment will be made on delivery of equipment and subject to acceptance by conducting necessary tests. b) 13.5% pro-rata payment on completion of installation and c) 10.0% on completionof testing, commissioning and handing over.

All payments made against running accounts will be treated as intermediate advances which will finally be adjusted in the final bill, prepared on completion of the work and shall not preclude the requiring of bad, unsound and imperfect or unskilled work to be rejected, removed, taken away and reconstructed or re-erected. Any certificate given by the Engineer-in-Charge relating to the work done or materials delivered forming part of suchpayment, may be modified or corrected by any subsequent such certificate(s) or by the final certificate and shall not by itself be conclusive evidence that any work or materials towhich it relates is/are in accordance with the contract and specifications. Any such interimpayment, or any part thereof shall not in any respect conclude, determine or affect in anyway powers of the Engineer-in-Charge under the contract or any of such payments betreated as final settlement and adjustment of accounts or in any way vary or affect the contract.

Pending consideration of extension of date of completion, interim payments shall continue to be made as herein provided without prejudice to the right of the department to takeaction under the terms of this contract for delay in the completion of work, if the extension of date of completion is not granted by the competent authority.

Engineer-in-Charge in his sole discretion to the effect that the work has been completed upto the level in question make interim advance payments without detailed measurements for work done (other than foundations, items to be covered under finishing items) up to lintel level (including sunshade etc.) and slab level, for each floor working out at 75% of the assessed value. The advance payments so allowed shall be adjusted in the subsequent interim bill by taking detailed measurements thereof.

CLAUSE 8 COMPLETION CERTIFICATE

Within ten days of the completion of work, the Contractor shall give notice of such completion to the Engineer-in-charge and within ten days of receipt of such notice the Engineer-in-charge shall inspect the work and if there is no defect in the work, shall furnishthe Contractor with a certificate of completion, otherwise a provisional certificate of completion indicating the defects (a) to be rectified by the Contractor and/or (b) for whichpayment will be made at reduced rates shall be issued but no such certificate of completion provisional or otherwise shall be issued nor shall the work be considered to be completeuntil the Contractor shall have removed from the premises on which the work shall be been executed all scaffolding surplus material and rubbish and all huts and sanitary arrangements required for this or their work people on the site in connection with execution of works shall have been erected or constructed by the Contractor and cleaned off the dirtfrom all the wood works, doors, windows, walls, floors or which other parts of any building in upon or about the work is to be executed or any of which he may had possession for the purpose of execution thereof and not until the work shall have been measured by the Engineer-in-charge. If the Contractor shall fail to comply with requirements of this clauseas to removal of scaffoldings, surplus materials and

rubbish and all huts and sanitaryarrangements as aforesaid and cleaning of dirt on or before the date fixed for thecompletion of the work, the Engineer-in-charge may, at the expense of the Contractor remove such scaffolding, surplus materials and rubbish etc., and dispose off the same ashe thinks fit clean of such dirt as aforesaid, and the Contractor shall forthwith pay the amount of all expense so incurred and shall have no claim in respect of any suchscaffolding or surplus materials as aforesaid except for any sum actually realized by thesale thereof.

CLAUSE 8A

CONTRACTOR TO KEEP SITE CLEAN

When the annual repair and maintenance work is carried out, the splashes and droppingsfrom whitewashing, color washing, painting etc., on walls, floors, doors, windows etc., shallbe removed and the surface cleared simultaneously with the completion of these items ofwork in the individual rooms, quarters or premises etc., where the work is done withoutwaiting for the actual completion of all the other items or work in the contract. In case the Contractor fails to comply with requirement of this clause, the Engineer-in-charge shallhave the right to get this work done at the cost of the Contractor either Departmentally orthrough another agency. Before taking such action, the Engineer-in-charge shall give tendays notice in writing to the Contractor.

CLAUSE 8B COMPLETION PLAN

The contractor shall submit completion plan for all services viz., water, sewerage, drainage, Electrical, A/c works etc., within thirty days of the completion of the work.

In case, the contractor fails to submit the completion plan as aforesaid, she/ he shall beliable to pay a sum equivalent to 2.5% of the value of the work subject to a ceiling ofRs.15,000 (Rs. Fifteen Thousand only) as may be fixed by the EIC concerned and in this respect the decision of the EIC shall be final and binding on the contractor.

CLAUSE 9 PAYMENT OF FINAL BILL

The final bill shall be submitted by the contractor in the same manner as specified in interim bills within three months of physical completion of the work or within one month of the date of the final certificate of completion furnished by the Engineer-in-Chargewhichever is earlier. No further claims shall be made by the contractor after submission ofthe final bill and these shall be deemed to have been waived and extinguished. Paymentsof those items of the bill in respect of which there is no dispute and of items in dispute, forquantities and rates as approved by Engineer-in-Charge, will, as far as possible-be madewithin the period specified herein under, the period being reckoned from the date of receiptof the bill by the Engineer-in- Charge or his authorized persons, complete with account ofmaterials issued by the Institute and dismantled materials.

If the Tendered value of work is,

upto Rs. 45 lac : 2 months. more than Rs.45 lac& upto Rs.2.5 Cr : 3 months. exceeds Rs. 2.5 Cr : 6 months.

CLAUSE 9A

PAYMENT OF CONTRACTOR'S BILL TO BANKS

Payments due to the Contractor may, if so desired by him, be made to his bank instead of direct to him provided that Contractor furnishes to the Engineer-in-charge;

- 1) an authorization in the form of legally valid documents such as a power of attorneyconferring authority on the bank to receive payment and
- 2) his own acceptance of the correctness of the account made out as being due to himby Government or his signature on the bill or other claims preferred againstGovernment before settlement by the Engineer-in-charge of the account or claim bypayment to the Bank. While the receipt given by such bank shall constitute a full andsufficient discharge for the payment, the Contractor should whenever possible present his bills duly receipted and discharged through his bankers.

Nothing herein contained shall operate to create in favour of the bank any rights or equitiesvis-à-vis the President of India/Director, NIT Meghalaya.

CLAUSE 10

MATERIALS SUPPLIED BY THE INSTITUTE

If the specification or schedule of items provided for the use any special description ofmaterials to be supplied from Engineer-in-charge's stores, or if it is required that the Contractor shall use certain stores to be provided by the Engineer-in-charge as shown inschedule of materials hereto annexed (Schedule-B), the Contractor shall be bound toprocure and shall be supplied such materials and stores as are from time to time required to be used by him for the purpose of the Contract only and the value of the quantity ofmaterials so supplied at the rates specified in the said schedule of materials may be set offor deducted from any sum then due, or thereafter to become due to the Contractor underthe Contract, or otherwise or the proceeds of sale thereof if the same is held inGovernment securities, the same or a sufficient portion thereof being in this case sold forthe purpose. All materials so supplied to the Contractor shall remain absolute property of Government, and shall not be removed on any account from the site of work, and shall beall times open to inspection by the Engineer-in-charge. Any such materials remainingunused and in perfectly good condition at the time of the completion or determination of the contract shall be returned to the Engineer-in-charge at a place directed by him, if by anotice in writing under his hand he shall so required, but the Contractor shall not be entitled to return any such materials unless with such consent and shall have no claim forcompensation of any such materials so supplied to him as aforesaid not being used by himor for any wastage in or damage to any such material. Provided that the Contractor shall inno case be entitled to any compensation or damages on account of any delay in supply ornon-supply thereof all any such materials and stores provided further that the Contractorshall be bound to execute the entire work if the materials are supplied by the Governmentwithin the scheduled time for completion of work plus 50% thereof (scheduled time plus 6months if time of completion of the work exceeds 12 months) but if a part only of thematerials has been supplied within the aforesaid period then the Contractor shall be boundto do so much of the work as may be possible with the materials and stores supplied in theaforesaid period. For the completion of the rest of the work, the Contractor shall be entitled to such extension of time as may be determined by EIC whose decision in this regard shallbe final.

CLAUSE 10A

MATERIALS TO BE PROVIDED BY THE CONTRACTOR

The contractor shall, at his own expense, provide all materials, required for the work otherthan those which are stipulated to be supplied by the Government.

The contractor shall, at his own expense and without delay; supply to the Engineer-in-chargesamples of materials to be used on the work and shall get these approved inadvance. All such materials to be provided by the Contractor shall be in conformity withthe specifications laid down or referred to in the contract. The contractor shall, if requestedby the Engineer-in-charge furnish proof, to the satisfaction of the Engineer-in-charge thatthe materials so comply. The Engineer-in-charge shall within thirty days of supply ofsamples or within such further period as he may require intimate to the Contractor in writingwhether samples are approved by him or not. If samples are not approved, the Contractorshall forthwith arrange to supply to the Engineer-in-charge for his approval, fresh samplescomplying with the specifications laid down in the contract. When materials are required tobe tested in accordance with specifications, approval of the Engineer-in-charge shall beissued after the test results are received.

The Contractor shall at his risk and cost submit the samples of materials to be tested oranalyzed and shall not make use of or incorporate in the work any materials represented by the samples until the required tests or analysis have been made and materials finally accepted by the Engineer-incharge. The Contractor shall not be eligible for any claim or compensation either arising out of any delay in the work or due to any corrective measures required to be taken on account of and as a result of testing of materials.

The contractor shall, at his risk and cost, make all arrangements and shall provide allfacilities that the Engineer-in-charge may require for collecting, and preparing the requirednumber of samples of such tests at such time and to such place or places as may bedirected by the Engineer-in-charge and bear all charges and cost of testing unlessspecifically provided for otherwise elsewhere in the contract or specifications. The Engineer-in-charge or his authorized representative shall at all times have access to theworks and to all workshops and places where work is being prepared or from wherematerials, manufactured articles or machinery are being obtained for the works and the contractor shall afford every facility and every assistance in obtaining the right to suchaccess.

The Engineer-in-charge shall have full powers to require the removal from the premises allmaterials which in his opinion are not in accordance with the specifications and in case ofdefault, the Engineer-in-charge shall be at liberty to employ at the expense of thecontractor, other persons to remove the same without being answerable or accountable forany loss or damage that may happen or arise to such materials. The Engineer-in-chargeshall also have full powers to require other proper materials to be substituted thereof and incase of default, the Engineer-in-charge may cause the same to be supplied and all costwhich may attend such removal and substitution shall be borne by the Contractor.

The contractor shall at his own expense, provide a material testing lab at the site forconducting routine field tests. The lab shall be equipped atleast with the testing equipmentas specified in schedule F.

CLAUSE 10B (i) SECURED ADVANCE

The contractor, on signing an indenture in the form to be specified by the Engineer-in-charge, shall be entitled to be paid during the progress of the execution of the work upto 90% of the assessed value of any materials which are in the opinion of the Engineer-in-charge non-perishable, non-fragile and non-combustible and are in accordance with the contract and which have been brought on the site in connection therewith and areadequately stored and/ or protected against damage by weather or other causes but whichhave not at the time of advance been incorporated in the works. When materials on account of which an advance has been made under this sub-clause are incorporated in

thework, the amount of such advance shall be recovered/ deducted from the next payment made under any of the clause or clauses of this contract.

Such secured advance shall also be payable on other items of perishable nature, fragileand combustible with the approval of the Engineer-in-charge, provided the contractorprovides a comprehensive insurance cover for the full cost of such materials. The decision of the Engineer-in-charge shall be final and binding on the contractor in this matter. Nosecured advance shall however, be paid on high-risk materials such as ordinary glass, sand, petrol, diesel, etc.

CLAUSE 10B (ii)

MOBILIZATION ADVANCE, INTEREST & RECOVERY

a) Mobilization advance at the rate of 10% of the tendered value, if requested by the contractor in writing within one month of the order to commence the work or if considered reasonable by the Engineer-in-charge. If circumstances are considered reasonable by the Engineer-In-charge, this period forrequest by the contractor in writing for grant of mobilization advance may be extended in the discretion of Engineer-In-Charge.

Such advance shall be made in two or more installments to be determined by the Engineer-in-charge at his sole discretion. The first installment of such advance shall bereleased by the Engineer-in-Charge to the contractor, on a request made by the contractor to the Engineer-In-Charge in this behalf. The second and subsequentinstallments shall be released by the Engineer-In-Charge only after the contractor furnishes a proof of the satisfactory utilization of the earlier installment to the entire satisfaction of the Engineer-In-Charge.

Before any installment of advance is released, the contractor shall execute a BankGuarantee Bond from Scheduled Bank for the amount equal to 110% of the amount of advance and valid for the contract period. The above bank guarantee shall be keptrenewed from time to time to cover the balance amount and likely period of completerecovery.

Provided always that provision of Clause 10 B (ii) shall be applicable only when so explicitly provided in Schedule 'F'.

b) Interest and recovery: The mobilization advance at (a) above bear a simple interest at the rate of 10% per annum and shall be calculated from the date of payment to the date of recovery, both dates inclusive, on the outstanding amount of advance. Recovery of such sums advance shall be made by deduction from the contractors bills commencing after first ten percent of the gross value of work is executed and paid on pro-rata percentage basis to the gross value of work billed beyond ten percent in such a way that the entire advance is recovered by the time eighty percent of the gross value of the contractor is executed and paid together with interest due on the entire outstanding amount upto the date of recovery of the installment.

CLAUSE 10C (i)

REIMBURSEMENT OF ESCALATION CAUSED AS A DIRECT RESULT OF COMING INTO FORCE ANY FRESH LAW OR STATUTORY RULE OR ORDER

All tendered rates shall be inclusive of all taxes, duties, royalties and levies payable under respective statutes.

If the prices of any materials incorporated in the works (not being a material supplied from the Engineer-in-charge stores in accordance with clause 10 thereof) and/or wages of labour increases/ decreases as a direct result of the coming into force of any fresh law or statutory rules or order and

such increase/ decrease exceeds 10% of the price and/or wages prevailing at the time of receipt of the tender for the work and the Contractor there upon necessarily and properly pays in respect of the materials (incorporated in the work) such increased/ decreased price and/or in respect of labour engaged on the execution of the work at such increased/ decreased wages then the amount of the contract shall accordingly be varied provided always that any increase/ decrease so payable/ deduction is not in the opinion of the Engineer-in-charge (whose decision is final and binding) attributable to delay in the execution of the contract within the control of the Contractor.

Provided however no reimbursement/ deduction shall be made if the increase/ decrease is not more than 10% of the said prices/ wages and if so the reimbursement/ deduction shall be made only on the excess over 10% and provided further that any such increase/decrease shall not be payable/ deduction, if such increase/ decrease has becomeoperative after the contract or extended date of completion of the works in question.

The Contractor shall for the purpose of this condition keep such books of accounts andother documents as are necessary to show the amount increased claim or reductionavailable and shall allow inspection of the same by a duly authorized representative of the Government and further shall at the request of Engineer-in-charge, furnish any documentso kept and such other information as the Engineer-in-charge may require.

The Contractor shall within a reasonable time of his becoming aware of any alteration in the price of any such materials and or wages of labour give notice thereof to the Engineer-in-charge stating that the same is given pursuance to this condition together with allinformation relating there to which he may be in a position to supply.

CLAUSE 10C (ii)

PAYMENT DUE TO INCREASE/ DECREASE IN PRICES/ WAGES AFTER RECEIPT OF TENDER FOR WORKS (APPLICABLE ONLY FOR WORKS WITH STIPULATED PERIOD OF COMPLETION MORE THAN 12 MONTHS)

If the prices of materials (not being materials supplied at fixed prices by the Institute inaccordance with clause 10) and/ or wages of labour required for execution of the workincrease, the contractor shall be compensated for such increase as per provisions detailedbelow and the amount of the contract shall accordingly be varied, subject to the conditionthat such compensation for escalation in prices shall be available only for the work doneduring the stipulated period of the contract including the justified period extended under theprovisions of clause 5 of the contract without any action under clause 2A.

No such compensation shall be payable for a work for which the stipulated period of completion is equal to or less than **12 (twelve) months**. Such compensation for escalation in the prices of materials and labour, when due, shall be worked out based on the following provisions.

- (i) The base date for working out such escalation shall be the last stipulated date ofreceipt of tenders including extension, if any,
- (ii) The cost of work on which escalation will be payable shall be reckoned as below :-

- (iii) Components of materials and labour shall be predetermined for every work andincorporated in the condition of contract attached to the tender papers included inschedule 'F'. The decision of the Engineer-in-charge in working out such percentageshall be binding on the contractors.
- (iv) The compensation for materials shall be worked as per the formula given below :-
- (a) Adjustment for Materials

Where,

V_m = Variation in material cost i.e. increase or decrease in the amount in rupees to bepaid or recovered.

W = Cost of Work done worked out as indicated in sub-para (ii)

MI = All India Wholesale Price Index for all commodities *for the period under consideration* published by Economic Advisor to Govt. of India, Ministry of Industry & Commerce.

MI₀= All India Wholesale Price Index for all commodities *valid on the last stipulated date of receipt of tender including extension*, *if any*, as published by the Economic Advisor to Govt. of India, Ministry of Industry & Commerce.

(v) The following principles shall be followed while working out the indices mentioned inPara (iv) above

- (a) The compensation for escalation shall be worked out at quarterly intervals and shallbe with respect to the cost of work done as per bills paid during the three calendarmonths of the said quarter. The first such payment shall be made at the end of threemonths after the month (excluding) in which the tender was accepted and thereafterat three months interval. At the time of completion of the work, the last period forpayment might become less than 3 months, depending on the actual date ofcompletion.
- (b) The index (MI) relevant to any quarter/ period for which such compensation is paidshall be the arithmetical average of the indices relevant to the three calendar months. If the period upto date of completion after the quarter covered by the last suchinstallment of payment is less than three months, the index MI shall be the average of the indices for the months falling within the period.
- (vi) The compensation for escalation for **labour** shall be worked out as per the formulagiven below:-

V_L =Variation in labour cost i.e. amount of increase or decrease in rupees to be paid orrecovered.

LI = Minimum daily Wage in rupees of an unskilled adult male mazdoor, fixed under anylaw, statutory rule or order as applicable on the last date of the quarter previous tothe one under consideration.

Ll_o = Minimum daily wage in rupees of an unskilled adult male mazdoor fixed under anylaw, statutory rule or order as applicable *on the last stipulated date of receipt oftender including extension*, *if any.*

- (vii) The following principles will be followed while working out the compensation as persub-para (vi) above.
- (a) The minimum wage of an unskilled male mazdoor mentioned in sub-para (vi) aboveshall be the higher of the wage notified by Government of India, Ministry of Labourand that notified by the local administration both relevant to the place of work and theperiod of reckoning.
- (b) The escalation for labour also shall be paid at the same quarterly intervals whenescalation due to increase in cost of materials is paid under this clause. If suchrevision of minimum wages takes place during any such quarterly intervals, theescalation compensation shall be payable at revised rates only for work done insubsequent quarters.
- (c) Irrespective of variations in minimum wages of any category of labour, for thepurpose of this clause, the variation in the rate for an unskilled adult male mazdooralone shall form the basis for working out the escalation compensation payable onthe labour component.

(viii) In the event, the price of materials and/ or wages of labour required for execution of the work decrease/s, there shall be a downward adjustment of the cost of work so that such price of materials and/or wages of labour shall be deductible from the cost of work under this contract and in this regard the formula herein before stated underthis Clause 10C (ii) shall mutatis mutandis apply.

CLAUSE 10D DISMANTLED MATERIALS ARE GOVERNMENT PROPERTY

The Contractor shall treat all materials obtained during dismantling of a structure, excavation of the site for a work etc., as Government's property and such materials shall be disposed off to the best advantage of Government according to instructions in writing issued by the Engineer-in-charge.

CLAUSE 10E - DELETED

CLAUSE 11

WORK TO BE EXECUTED IN ACCORDANCE WITH SPECIFICATIONS, DRAWINGS, ORDERS, ETC.,

The contractor shall execute the whole and every part of the work in the most substantial and workmanlike manner both as regards materials and otherwise in every respect in strict accordance with the specifications. The contractor shall also conform exactly, fully and faithfully to the design, drawings and instructions in writing in respect of the work signed by the Engineer-in-Charge and the contractor shall be furnished free of charge one copy of the contract documents together with specifications, designs, drawings and instructions as are not included in the standard specifications of Central Public Works Department or in any Bureau of Indian Standard or any other, published standard or code or, Schedule of Rates or any other printed publication referred to elsewhere in the contract. The contractor shall comply with the provisions of the contract and with the care and diligence execute and maintain the works and provide all labour and materials, tools and plants including for measurements and supervision of all works, structural plans and other things of temporary or permanent nature required for such execution and maintenance in so far as the necessity for providing these, is specified or is reasonably inferred from the contract. The Contractor shall take full responsibility for adequacy, suitability and safety of all the works and methods of construction.

CLAUSE 11A ACTION WHERE NO SPECIFICATION

In the case of any class of work for which there is no standard specifications such work shall be carried out generally in accordance with CPWD specification and if there is no details of CPWD specification book then it shall be executed as per Bureau of Indian Standard specification. In case there is no such specification in Bureau of Indian Standards the work shall be carried out in all respects in accordance with the instruction and requirement of the Engineer-in-charge.

CLAUSE 12

DEVIATIONS/ VARIATIONS EXTENT AND PRICING

The Engineer-in-charge shall have power (i) to make alteration in, omissions from, additions to, or substitutions for the original specifications, drawings, designs and instructions that may appear to him to be necessary or advisable during the progress of the work, and (ii) to omit a part of the work(s) in case of non-availability of a portion of the site or for any other reasons and the contractor shall be bound to carry out the works in accordance with any instructions given to him in writing signed by the Engineer-in-charge and such alterations, omissions, additions or substitutions shall

form part of the contract as if originally provided therein and any altered, additional or substituted work which the contractor may be directed to do in the manner specified above as part of the works, shall be carried out by the contractor on the same conditions in all respects including price on which he agreed to do the main work except as hereafter provided:

- 12.1: The time for completion of the works shall, in the event of any deviations resulting in additional cost over the tendered value sum being ordered, be extended, if requested by the contractor, as follows:
- i) In the proportion which the additional cost of the altered, additional or substituted work, bears to the original tendered value plus.
- ii) 25% of the time calculated in (i) above or such further additional time as may be considered reasonable by the Engineer-in-charge.
- 12.2: Extra items and pricing

A. For major works:

In the case of Extra items (items that are completely new, and are in addition to the items contained in the contract), the contractor may within 15 days of receipt of order or occurrence of the item(s), claim rate supported by proper analysis, for the work and the Engineer-in-charge shall within prescribed time limit of the receipt of the claims supported by analysis after giving consideration to the analysis of the rates submitted by the contractor, determine the rates on the basis of market rates and the contractor shall be paid in accordance with the rates so determined.

B. For Maintenance works including works of up-gradation, aesthetic, special repair, addition/alteration:

In the case of Extra item(s) being the schedule items (SOR as mentioned in schedule 'E'), these shall be paid as per the schedule rate plus plus/ minus percentage above/ below quoted contract amount. Payment of Extra items in case of nonscheduled items (Non-SOR items) shall be made as per the prevailing market rate.

12.3: Substituted item, pricing

A. For major/ capital works:

In the case of substituted items (items that are taken up with partial substitution are in lieu of items of work in the contract), the rate for the agreement item (to be substituted) and substituted item shall also be determined in the manner as mentioned in the following para.

- i) If the market rate for the substituted item so determined is more than the market rate of the agreement item (to be substituted), the rate payable to the contractor for the substituted item shall be the rate for the agreement item (to be substituted) so increased to the extent of the difference between the market rates of substituted item and the agreement item (to be substituted).
- ii) If the market rate for the substituted item so determined is less than the market rate of the agreement item (to be substituted), the rate payable to the contractor for the substituted item shall be the rate for the agreement item (to be substituted) so decreased to the extent of the difference between the market rates of substituted item and the agreement item (to be substituted).
- B. For Maintenance works including works of up-gradation, aesthetic, special repair, addition/alteration:

In the case of Substituted item(s) being the schedule items (SOR as mentioned inSchedule 'E'), these shall be paid as per the schedule rate plus, plus/minus percentageabove/ below quoted contract amount. Payment of Substituted items in case of nonscheduled items (Non – SOR as mentioned in Schedule 'E') shall be made as per theprevailing market rate.

12.4: Deviated quantities, pricing

A. For major/ capital works:

In the case of contract items, substituted items, contract cum substituted items, which exceed the limits as below, the contractor may within fifteen days of receipt of order of occurrence of the excess, claim revision of the rates, supported by proper analysis for the work in excess of the above mentioned limits, provided that if the rates so claimed are in excess of the rates specified in the schedule of quantities, the Engineer-in-charge shall within prescribed time limit of receipt of the claims supported by analysis, after giving consideration to the analysis of the rates submitted by the contractor, determine the rates on the basis of market rates and the contractor shall be paid in accordance with the rates so determined.

Prescribed time limits are as under:

If the Tendered value of work is

upto Rs.45 lac : 30 days. more than Rs.45 lac and up to Rs. 2.5 Cr : 45 days. exceeds Rs. 2.5 Cr : 60 days.

B. For Maintenance works including works of up- gradation, aesthetic, special repair, addition/alteration:

In the case of contract items, which exceed the deviation limits as specified in Schedule 'E', the contractor shall be paid with rates specified in the schedule of quantities.

12.5:

A. For major/ capital works:

The provisions of the preceding paragraph shall also apply to the decrease in the rates of thems for the work in excess of limits laid down in Schedule 'E', and the Engineer-inchargeshall after giving notice to the contractor within one month of occurrence of theexcess and after taking into consideration any reply received from him within fifteen days of the receipt of the notice, revise the rates for the work in question within one month of theexpiry of the said period of fifteen days having regard to the market rates.

B. For Maintenance works including works of up-gradation, aesthetic, special repair, addition/alteration:

In case of decrease in the rates prevailing in the market of items for the work in excess ofthe limits laid down in Schedule E, the Engineer-in-Charge shall after giving notice to the contractor within one month of occurrence of the excess and after taking into considerationany reply received from him within fifteen days of the receipt of the notice, revise the ratesfor the work in question within one month of the expiry of the said period of fifteen dayshaving regard to the market rates

For the purpose of operation of deviation limit, the following works shall be treated asworks relating to foundation unless & otherwise defined in the contract:

- i) For Buildings: All works upto 1.2 metres above ground level or upto floor 1 levelwhichever is lower.
- ii) For abutments, piers and well steining: All works up to 1.2 m above the bed level.
- For retaining walls, wing walls, compound walls, chimneys, over headreservoirs/tanks and other elevated structures: All works upto 1.2 metres above the ground level.

- iv) For reservoirs/ tanks (other than overhead reservoirs/ tanks): All works upto 1.2metres above the ground level.
- v) For basement: All works upto 1.2 m above ground level or up to floor 1 levelwhichever is lower.
- vi) For Roads, all items of excavation and filling including treatment of sub base.

vii)

12.6:

The contractor shall send to the Engineer-in-charge once every three months, an up-to dateaccount giving complete details of all claims for additional payments to which the contractor may consider himself entitled and of all additional work ordered by the Engineer-in-charge which he has executed during the preceding quarter failing which the contractorshall be deemed to have waived his right. However, the Director, NIT Meghalayamay authorize consideration of such claims on merits.

12.7:

Any operation incidental for proper execution of the item included in the Schedule ofquantities or in the Schedule of rates mentioned above, whether or not, specifically indicated in the description of the item and the relevant specifications, shall be deemed tobe included in the rates quoted by the tenderer or the rate given in the said schedule of rates as the case may be. Nothing extra shall be admissible for such operations.

CLAUSE 13 FORE CLOSURE OF CONTRACT DUE TO ABANDONMENT OR REDUCTION IN SCOPE OF WORK

If at any time after acceptance of the tender, Engineer-in-Charge shall decide to abandonor reduce the scope of the works for any reason whatsoever and hence not require thewhole or any part of the works to be carried out, the Engineer-in-Charge shall give notice inwriting to that effect to the contractor and the contractor shall act accordingly in the matter. The contractor shall have no claim to any payment of compensation or otherwisewhatsoever, on account of any profit or advantage which he might have derived from theexecution of the works in full but which he did not derive in consequence of the foreclosure of the whole or part of the works.

The contractor shall be paid at contract rates, full amount for works executed at site and, inaddition, a reasonable amount as certified by the Engineer-in-Charge for the itemshereunder mentioned which could not be utilized on the work to the full extent in view of theforeclosure;

- (i) Any expenditure incurred on preliminary site work, e.g. temporary access roads, temporary labour huts, staff quarters and site office, storage accommodation andwater storage tanks.
- (ii) Government/Institute shall have the option to take over contractor's materials orany part thereof either brought to site or of which the contractor is legally bound toaccept delivery from suppliers (for incorporation in or incidental to the work)provided, however Government/ Institute shall be bound to take over thematerials or such portions thereof as the contractor does not desire to retain. Formaterials taken over or to be taken over by Government/ Department, cost of suchmaterials as detailed by Engineer-in- Charge shall be paid. The cost shall,however, take into account purchase price, cost of transportation and deteriorationor damage which may have been caused to materials whilst in the custody of thecontractor.
- (iii) If any materials supplied by Government/Institute are rendered surplus, thesame except normal wastage shall be returned by the contractor to Government/Institute at rates not exceeding those at which these were originally issued, lessallowance for any deterioration or damage which may have

been caused whilst the materials were in the custody of the contractor. In addition, cost of transporting such materials from site to Government/ Institute stores, if so required byGovernment/ Institutet, shall be paid.

- (iv) Reasonable compensation for transfer of T & P from site to contractor's permanentstores or to his other works, whichever is less. If T & P are not transported to either of the said places, no cost of transportation shall be payable.
- (v) Reasonable compensation for repatriation of contractor's site staff and imported abour to the extent necessary.

The contractor shall, if required by the Engineer- in-Charge, furnish to him, books ofaccount, wage books, time sheets and other relevant documents and evidence as may benecessary to enable him to certify the reasonable amount payable under this condition.

The reasonable amount of items on (i), (iv) and (v) above shall not be in excess of 2% of the cost of the work remaining incomplete on the date of closure, i.e. total stipulated cost of the work as per accepted tender less the cost of work actually executed under the contractand less the cost of contractor's materials at site taken over by the Government/Institute as per item (ii) above. Provided always that against any payments due to the contractor on this account or otherwise, the Engineer-in-Charge shall be entitled to recoveror be credited with any outstanding balances due from the contractor for advance paid inrespect of any tool, plants and materials and any other sums which at the date of termination were recoverable by the Government/ Institute from the contractor under the terms of the contract.

CLAUSE 14 RISK AND COST

If contractor:

- (i) At any time makes default during currency of work or does not execute any part of the work with due diligence and continues to do so even after 7 days of notice inwriting, in this respect from the Engineer-in-Charge; or
- (ii) Commits default in complying with any of the terms and conditions of the contractand does not remedy it or takes effective steps to remedy it within 7 days even after notice in writing is given in that behalf by the Engineer-in-Charge; or
- (iii) Fails to complete the work(s) or items of work with individual dates of completion,on or before the date(s) so determined, and does not complete them within theperiod specified in the notice given in writing in that behalf by EIC.

Engineer- in-Charge without invoking action under clause 3 may, without prejudice to anyother right or remedy against the contractor which have either accrued or accruethereafter to Government/Institute, by a notice in writing to take the part work/partincomplete work of any item(s) out of his hands and shall have powers to:

- (a) Take possession of the site and any materials, constructional plant, implements, stores, etc., thereon; and/or
- (b) Carry out the part work / part incomplete work of any item(s) by any means at therisk and cost of the contractor.

The Engineer-in-Charge shall determine the amount, if any, is recoverable from the contractor for completion of the part work/ part incomplete work of any item(s) taken out of his hands and execute at the risk and cost of the contractor, the liability of contractoron account of loss or damage suffered by Government/Institute because of actionunder this clause shall not exceed 10% of the tendered value of the work.

In determining the amount, credit shall be given to the contractor with the value of workdone in all respect in the same manner and at the same rate as if it had been carriedout by the original contractor under the terms of his contract, the value of contractor'smaterials taken over and incorporated in the work and use of plant and machinerybelonging to the contractor. The certificate of the Engineer-in-Charge as to the value of work done shall be final and conclusive against the contractor provided always that action under this clause shall only be taken after giving notice in writing to the contractor. Provided also that if the expenses incurred by the department are less than the amount payable to the contractor at his agreement rates, the difference shall not be payable to the contractor.

Any excess expenditure incurred or to be incurred by Government/ Institute in completing the part work/ part incomplete work of any item(s) or the excess loss of damages suffered or may be suffered by Government/Institute as aforesaid after allowing such credit shall without prejudice to any other right or remedy available to Government/Institute in law or per as agreement be recovered from any money due to the contractor or any account, and if such money is insufficient, the contractor shall be called upon in writing and shall be liable to pay the same within 30 days.

If the contractor fails to pay the required sum within the aforesaid period of 30 days, the Engineer-in-Charge shall have the right to sell any or all of the contractors' unused materials, constructional plant, implements, temporary building at site etc. and adjust the proceeds of sale thereof towards the dues recoverable from the contractor under the contract and if thereafter there remains any balance outstanding, it shall be recovered in accordance with the provisions of the contract.

In the event of above course being adopted by the Engineer-in-Charge the contractor shall have no claim to compensation for any loss sustained by him by reason of his having purchased or procured any materials or entered into any engagements or made any advance on any account or with a view to the execution of the work or the performance of the contract.

CLAUSE 15 SUSPENSION OF WORK

The Contractor shall suspend the execution of work or any part or parts thereof, wherever called upon in writing by the Engineer-in-charge to do so and shall not resume work thereon until so directed in writing by him. The Contractor will be allowed an extension of time for completion not less than the period of suspension but no other claims in this respect for compensation or otherwise, however will be admissible.

CLAUSE 16

ACTION IN CASE WORK NOT DONE AS PER SPECIFICATIONS

All works under or in course of execution or executed in pursuance of the contract, shall at all times be open and accessible to the inspection and supervision of the Engineer-in-charge, his authorized subordinates in charge of the work and all the superior officers, officer of the Quality Assurance unit of the Government or any organization engaged by the Institutefor Quality Assurance and of the Chief Technical Examiner's office and the contractor shall, at all times, during the usual working hours and at all other times at which reasonable notice of the visit of such officers has been given to the contractor, either himself be present to receive orders and instructions or have a responsible

agent duly accredited in writing, present for that purpose. Orders given to the contractor's agent shall be considered to have the same force as if they had been given to the contractor himself.

If it shall appear to the Engineer-in-charge or his authorized subordinate in-charge of the work or to the Authority in charge of Quality Assurance or his subordinate officers or the officers of the organization engaged by the Institute for Quality Assurance or to the Chief Technical Examiner or his subordinate officers that any work has been executed with unsound, imperfect, or unskillful workmanship, or with materials or articles provided by him for the execution of the work which are unsound or of a quality inferior to that contracted or otherwise not in accordance with the contract, the contractor shall, on demand in writing which shall be made within twelve months (six months in the case of work costing Rs.10 lakhs and below except road work) of the completion of the work from the Engineer-in-charge specifying the work, materials or articles complained of notwithstanding that the same may have been passed, certified and paid for forthwith rectify, or remove and reconstruct the work so specified in whole or in part, as the case may require or as the case may be, remove the materials or articles so specified and provide other proper and suitable materials or articles at his own charge and cost. In the event of the failing to do so within a period specified by the Engineer-in-charge in his demand aforesaid, then the contractor shall be liable to pay compensation at the same rate as under clause 2 of the contract (for non-completion of the work in time) for this default.

In such case the Engineer-in-charge may not accept the item of work at the rate applicable under the contract but may accept such items at reduced rates as the authority specified in Schedule `F' may consider reasonable during the preparation, of on account bills or final bill if the item is so acceptable without detriment to the safety and utility of the item and the structure or he may reject the work outright without any payment and/or get it and other connected and incidental items rectified, or removed and re-executed at the risk and cost of the contractor. Decision of the Engineer-in-charge to be conveyed in writing in respect of the same will be final and binding on the contractor.

CLAUSE 16A NOTICE TO BE GIVEN BEFORE COVERING UP

The Contractor shall give not less than seven days notice in writing to the Engineer-in-charge or his authorized subordinate in charge of the work before covering up or otherwise placing beyond the reach of measurement any work in order that the same may be measured and correct dimensions thereof be taken before the same is covered up or placed beyond the reach of measurement and shall not cover up and placed beyond the reach of measurement any work without the consent in writing of the Engineer-in-charge or his authorized subordinate in charge of the work shall within the aforesaid period of seven days inspect the work and if any work shall be covered up or placed beyond the reach of measurement without such notice having been given or the Engineer-in-charge's consent be obtained the same shall be uncovered at the Contractor's expense, or in default thereof no payment or allowance shall be made for such work or the materials with which the same was executed.

CLAUSE 17A

CONTRACTOR LIABLE FOR DAMAGES, DEFECTS DURING MAINTENANCE PERIOD

If the Contractor or his working people shall break, deface, injure or destroy any part of a building in which they may be working or any buildings, road, kerbs, fence, enclosure, water pipes, cables, drains, electric and telephone posts or wire, trees, grass or grass land or cultivated ground contiguous to the premises on which the work or any part of it is being executed, or if any damage shall happen to the work while in progress from any cause whatever or if any defects shrinkage or other faults appear in the work within **twelve months** after a certificate of final or otherwise of its

completion shall have been given by the Engineer-in-charge as aforesaid arising out of defective or improper materials or workmanship, the Contractor shall after receipt of notice in writing in that behalf make the same good at his own expense, or in default the Engineer-in-charge may cause the same to be made good by other workmen and deduct the expense (of which the certificate of the Engineer-in-charge shall be final) from any sums that may then, or at any time thereafter become due to the Contractor, or from his Security Deposit or the proceeds of sale thereof, or of a sufficient portion thereof the Security Deposit of the Contractor shall not be refunded before the expiry of twelve calendar months after the issue of the certificate of final or otherwise of completion of work, or till the final bill has been prepared and passed whichever is later.

Engineer-in-Charge shall give notice to the contractor of any defects before the end of theDefect Liability Period, which begins on the date of completion. The Defect Liability Periodshall stand automatically extended for as long as defects remain to be rectified. Every time notice of defect is given, the contractor shall correct the notified defects within the periodspecified by Engineer-in-charge.

However, for contract exclusively for earth work or jungle clearance where defect liability period is not relevant, Security Deposit if any paid may be refunded along with payment offinal bill subject to labour clearance vide Clause 45.

Further in case where the contract provides for completion in phases, the Engineer-in-chargeat his discretion may allow part refund of Security Deposit after expiry of 12 months(6 months in case of any works other than road work costing Rs.10,00,000 and below) from the date of completion for each phase but not before the payment of final bill for the entirecontract.

CLAUSE 17B SPECIAL CONDITION ON TAKING INSURANCE POLICY FOR THE WHOLE WORK ORDER VALUE BY THE CONTRACTORS'

As per Clause 17A of the Conditions of Contract, the Contractors' have to make good attheir own expense the damages occurred due to any accident from any cause during thework in progress or nearing completion of the work. In order to fulfill this clause and also totake the responsibility of handing over the site to the full satisfaction of the Engineer-in-Charge and till the contractor gets the certificate or a letter of taking over the site facility/building/works, the contractor shall be responsible to re-do the works damaged from anycause. For this purpose, the contractor shall insure the whole work the moment the workorder is received and before agreement is signed for the entire work order value undercontractor's all risk insurance policy [CAR]. The third party liability and Cross-liability shallalso be covered under the policy. The Contractors' shall consult the insurance companiesand also the principal employer i.e. the Engineer-in-Charge and take the insurance policyfor CAR. In case of any accidents during the work or nearing completion of the work [otherthan during the defect liability period for which Clause-17A is applicable], the Contractors'are totally responsible to re-do the damages and hand over site in acceptable condition to the Engineer-in-Charge and await a letter from the Department that the site has been takenover. Till such time, the Contractors' are responsible for all the damages from any cause.

<u>Note:</u> Contractor should also obtain insurance policy to cover all the laborers engaged inthe work. In the event of contractor failing to keep insurance alive, Institute reserves right to takeappropriate action including withholding the payments due to the Contactor.

CLAUSE 18

CONTRACTOR TO SUPPLY TOOLS AND PLANTS ETC.,

The Contractor shall supply and provide at his own cost all materials (except such specialmaterials, if any as may in accordance with the contract be supplied from the Engineer-incharge'sstores) plant, tools, appliances, implements, ladders, cartage, tackle, scaffoldingand temporary works requisite for the proper execution of the work, whether original, altered or substituted and whether included in the specification or other documents formingpart of the contract or referred to in these conditions or not or which may be necessary forthe purpose of satisfying or complying with the requirements of the Engineer-in-charge asto any matters as to which under these conditions he is entitled to be satisfied or which heis entitled to require together with carriage thereof to and from the work.

The Contractor shall also supply without charge the requisite number of persons with themeans and materials necessary for the purpose of setting out works and counting, weighing and assisting in the measurement or examination at any time and from time totime of the work or materials failing his so doing the same may be provided by the Engineer-in-charge at the expenses of the Contractor and the expense may be deducted from any money due to the Contractor under the contract or the proceeds of sale thereof orof a sufficient portion thereof.

CLAUSE 18A

RECOVERY OF COMPENSATION PAID TO WORKMEN

In every case which by virtue of the provisions of section 12 sub-section (i) of theworkman's compensation act, 1923, Government/Institute is obliged to pay compensation toworkmen employed by the Contractor in execution of the work, Government will recoverfrom the Contractor the amount of the compensation so paid and without prejudice to therights of Government under section-12 sub-section (2) of the said act, Government/Institute shall beat liberty to recover such amounts or any part thereof by deducting it from the securityDeposit or from any sum due by the Government/Institute to the contract whether under thiscontract or otherwise, Government/Institute shall not be bound to contest any claim made against itunder section 12, sub-section (1) of the said act except on the written request of theContractor and upon his giving to Government/Institute full security for all costs for whichGovernment/Institute might become liable in consequence of contesting such claim.

CLAUSE 18B

ENSURING PAYMENT AND AMENITIES TO WORKERS IF CONTRACTOR FAILS

In every case in which by virtue of the provisions of the contract Labour (Regulation and Abolition Act 1970) and of the Contract Labour Regulation and Abolition Central Rules,1971, Government/Institute is obliged to pay any amounts of wages to workman employed by the Contractor in execution of the works, or to incur any expenditure in providing welfare and health amenities required to be provided under the above said act and the rules underclause 19 or under the rules framed by Government/Institute from to time for the protection of healthand sanitary arrangements for workers employed by Government Contractor, Government/Institutewill recover from the Contractor the amount of wages so paid or the amount of expenditureso incurred and without prejudice to the right of the Government/ Institute under section 20 subsection(2) and section 21 sub-section (4) of the Contract Labour (R&A) act 1970

Government/Institute shall be at liberty to recover such amount or any part thereof by deducting it from any sum due by the Government/Institute to the contractor whether under this agreement or otherwise Government/Institute shall not be bound to contest any claim made against it undersection 20 sub-section (1) and section 21 sub section (4) of the said Act except on thewritten request of the Contractor and upon his giving to the Government/Institute full security for all costs for which Government/Institute might become liable in contesting such claim.

CLAUSE 19

LABOUR LAWS/ SAFETY PROVISIONS TO BE COMPLIED BY THE CONTRACTOR

Contractor shall follow all laws, regulations and acts of Central/ State Government andother statutory bodies relating to engaging labourers in work, wages and all relatedprovisions and indemnify Government/Institute against payment to be made under and for the observance of the said labour laws.

Engineer-in-Charge concerned shall have the right to deduct from the money due to the contractor, any sum required or estimated to be required for making good the loss suffered by a worker or workers by reason of non-fulfillment of any of the conditions of the contractfor the benefit of the workers, non-payment of wages or of deductions made from his ortheir wages which are not justified by their terms of the contract or non-observance of the Regulations.

Further, contractor at his own expense shall arrange and comply with the safety provisionsas per Standard safety manual and health & sanitary arrangements for theworkers as per the extant rules.

CLAUSE 20

MINIMUM WAGES ACT

Contractor shall comply with all the provisions of the Minimum Wages Act 1948, ContractLabour (Regulation and Abolition) act, 1970 and rules framed thereunder and other labourlaws affecting Contract Labour that may be brought into force from time to time.

CLAUSE 21

WORK NOT TO BE SUBLET - ACTION IN CASE OF INSOLVENCY

The contract shall not be assigned or sublet without the written approval of the Engineer-in-charge and if the Contractor shall assign or sublet this contract or attempt to do so or become insolvent or commence any insolvency proceedings or make any composition withhis creditors or attempt to do so or if any bribe gratuity, gift, loan, perquisite reward oradvantage, pecuniary or otherwise shall either directly or indirectly be given, promised or offered by the Contractor or any of his employees or agents to any public officer or personin the employ of the Government/Institute in any way relating to his Officer or Employment, or if anysuch officer or person shall become in any way directly or indirectly interested in thecontract, the Engineer-in-charge may thereupon on behalf of the President of India/Director, NIT Meghalaya shallhave power to adopt any of the course specified in Clause 3 as he may best deem suited inthe interest of Government/Institute, in the event of any of those courses being adopted theconsequences specified in the said clause 3 shall ensure.

CLAUSE 22

COMPENSATION PAYABLE ARE WITHOUT REFERNCE TO ACTUAL LOSS ORDAMAGES

All sums payable by way of compensation under any of these conditions shall beconsidered as reasonable compensation to be applied to the use of Government without reference to the actual loss or damage sustained and whether or not any damage shall have been sustained.

CLAUSE 23

CHANGE IN FIRM'S CONSTITUTION TO BE INTIMATED.

Where the Contractor is a partnership firm, the previous approval in writing of the Engineer-incharge shall be obtained before any change is made in the constitution of the firm. Where the Contractor is an individual or a Hindu undivided family business concern suchapproval as aforesaid shall like wise be obtained before the Contractor enters into any partnership agreement where under the partnership firm would have the right to carryout the work hereby undertaken by the Contractor. If previous approval as aforesaid is notobtained, the contractor shall be deemed to have been assigned in contravention ofclause 21 hereof and the same action may be taken and the same consequences shallensure as provided in the said clause 21.

CLAUSE 24 – DELETED

CLAUSE 25

SETTLEMENT OF DISPUTES AND ARBITRATION

- a) If any dispute or differences of any kind whatsoever were to arise between the Engineer-incharge or Institute and the Contractor regarding the following matters namely.
 - i) The meaning of the specifications, designs, drawings and instructions hereinbefore mentioned.
 - ii) The quality of workmanship or materials used on the work and
 - iii) Any other question, claim, right, matters, thing whatsoever in any way arising outof or relating to the contract, designs, drawings, specifications, estimates, instructions or orders, or those conditions or failure to execute the same whether arising during the progress of the work after the completion, termination orabandonment thereof, the dispute shall, in the first place be referred to the Executive Engineer/ Director, NIT Meghalaya who has Jurisdiction over the work specified in the contract with the details of claims, justification for the same with supporting documents such as analysis of rates, cash vouchers and other relevant particulars. The Executive Engineer/ Director, NIT Meghalaya shall within a period of sixty days from the date of being requested by the Contractor to do so or from the date of furnishing of required particulars whichever is later shall give written notice of his decision to the contractor.

If the Engineer-in-Charge/Executive Engineer fails to give notice of his decision within a period of 60 days from the date of receipt of (i) the Contractor's request in writing forsettlement of dispute or difference as aforesaid or (ii) relevant particulars from the Contractor in support of his claims whichever is later. (OR)

If the decision of the Engineer-in-Charge/Executive Engineer is not acceptable to the Contractor, he may approach the Director of the Institute within a period of 15 days from the date of expiry of 60 days specified above. The Director of the Institute shall within a period of further 90 days from the date of receipt of requestfrom the contractor or from the date of receipt of relevant particulars from the contractor in support of claims whichever is later give notice of his decision (s) to the Contractor.

b) Subject to other forms of settlement hereinafter provided the Director of the Institutedecision in respect of every dispute or difference so referred shall be final andbinding upon the Contractor. The said decision shall forthwith be given effect to andContractor shall proceed with the execution of the work with all due diligence.

c) Remedy

- 1. When Director of the Institute decision is not acceptable to Contractor OR
- 2. Director of the Institute fails to give decision within 90 days.

In case the decision of the Director of the Institute is not acceptable to the Contractor or Director of the Institute fails to give decision within 90 days specified above, the Contractor may approach the Law court specified in Schedule 'F' forsettlement of dispute after giving due written notice in this regard to the Director of the Institute.

d) Whether the claim is referred to the Engineer-in-Charge/Executive Engineer/ Director of the Institute or to the Law Courts, as the case may be, the Contractor shall proceed to execute and complete the works with all due diligence pending settlement of the said dispute or differences.

Obligations of the Engineer-in-charge and Contractor shall remain unsettled duringconsiderations of dispute.

e) The reference of any dispute or dispute (s) or difference(s) to Engineer-in-Charge/Executive Engineer or the Director of the Institute or the Law Court may proceed notwithstanding that the work shall then be or be alleged to be complete provided alwaysthat the obligations of the Engineer-in-charge and the Contractor shall not be alteredby reason of the said dispute or difference being referred to Engineer-in-Charge/Executive Engineer / Director of the Institute or the Law Court during the progress of the works.

CLAUSE 25A

SETTLEMENT OF DISPUTES BETWEEN CMG AND CENTRAL GOVERNMENTENTERPRISES

In the event of the contract being entered into between National Institute of Technology Meghalaya and a Central Government Public Enterprises, supersession of above clause 25 of condition of Contract the following clause shall apply 'In the event of any dispute or difference relatingto the interpretation and application of the provisions of the contracts, such dispute or difference shall be referred by either party to the arbitration of one of arbitrators in the Department of Public Enterprises to be nominated by the Secretary to the Government of India, in charge of the Bureau of Public Enterprises. The arbitration Act, 1940 shall not beapplicable to the arbitration under this clause. The award of the arbitration shall be bindingupon the parties to the dispute provided; however any party aggrieved by such award maymake further reference for setting aside or revision of the award to the Law Secretary, Additional Secretary, when so authorized by the Law secretary, Department of LegalAffairs, Ministry of Law and Justice, Government of India. Upon such reference the disputeshall be decided by the Law Secretary or the Secretary, whose decision shall bind theparties finally and conclusively. The parties to the dispute will share equally the cost of Arbitration as intimated by the Arbitrator.

Provisions of clause 25 shall not be applicable to contracts where this clause 25A isapplicable and the contracts for which clause 25A is not applicable clause 25 will beapplicable.

CLAUSE 26 PATENT RIGHTS

The Contractor shall fully indemnify the President of India/Director, NIT Meghalaya against any action, claim orproceeding relating to infringement or use of any patent or design on any alleged patent ordesign right and shall pay any royalties which may be payable in respect of any article orpart thereof included in the contract. In the event of any claims made under or actionbrought against Government in respect of such matters as aforesaid the Contractor shallbe immediately notified thereof and the Contractor shall be at liberty, at his own expense,to settle any dispute or to conduct any litigation that may arise there from. Provided thatthe Contractor shall not be liable to indemnify the President of India/Director, NIT Meghalaya if the infringement ofthe patent or design of any alleged patent or design right is the direct result of an orderpassed by the Engineer-in-charge in this behalf.

CLAUSE 27 – DELETED

CLAUSE 29

WITHHOLDING AND LIEN IN RESPECT OF SUMS DUE FROM CONTRACTOR

(i) Whenever any claim or claims for payment of a sum of money arises out of or underthe contract or against the contractor, the Engineer-in-Charge or theGovernment/Institute shall be entitled to withhold and also have a lien to retainsuch sum or sums in whole or in part from the security, if any deposited by thecontractor and for the purpose aforesaid, the Engineer-in-Charge or theGovernment/Institute shall be entitled to withhold the security deposit, if any,furnished as the case may be and also have a lien over the same pending finalizationor adjudication of any such claim. In the event of the security being insufficient tocover the claimed amount or amounts or if no security has been taken from thecontractor, the Engineer-in-Charge or the Government/Institute shall be entitled towithhold and have a lien to retain to the extent of such claimed amount or amountsreferred to above, from any sum or sums found payable or which may at any timethereafter become payable to the contractor under the same contract or any othercontract with the Engineer-in-Charge of the Government/ Institute or anycontracting person through the Engineer-in-Charge pending finalization of adjudication any such claim.

It is an agreed term of the contract that the sum of money or moneys so withheldretained under the lien referred to above by the Engineer-in-charge or Government/Institute will be kept withheld or retained as such by the Engineer-in-charge or Government till the claim arising out of or under the contract is determined by the competent court and that the contractor will have no claim for interest or damageswhatsoever on any account in respect of such withholding or retention under the lienreferred to above and duly notified as such to the contractor. For the purpose of this clause, where the contractor is a partnership firm or a limited company, the Engineer-in-charge or the Government shall be entitled to withhold and also have a lien to retain towards such claimed amount or amounts in whole or in part from any sum found payable to any partner/limited company at the case may be, whether in his individual capacity or otherwise.

(ii) Government/Institute shall have the right to cause an audit and TechnicalExamination of the work and the final bills of the Contractor including all supportingvouchers abstract etc., to be made after payment of the final bill and if as a result of such audit and Technical Examination any sum is found to have been over paid inrespect of any work done by the Contractor under the contract or any work claimed byhim to have been done by him under contract and found not to have been executed, the Contractor shall be liable to refund the amount of over payment and it shall belawful for Government/Institute to recover the same from him in the mannerprescribed in sub clause (1) of this clause or in any other manner equally permissibleand if it is found that the Contractor was paid less than what was due to him under the Contract in respect of any work executed by him under it, the amount of such underpayment shall be duly paid by Government/Institute to the contractor, without anyinterest thereon whatsoever.

Provided that the Government/Institute shall not be entitled to recover any sumoverpaid, nor the contractor shall be entitled to payment of any sum paid short where suchpayment has been agreed upon between the Engineer-in-Charge on the one hand and thecontractor on the other under any term of the contract permitting payment for work afterassessment by the Engineer in Charge.

CLAUSE 29A

LIEN IN RESPECT OF CLAIMS IN OTHER CONTRACTS

Any sum of money due and payable to the Contractor (including Security Depositreturnable to him) under the contract may be withheld or retained by way of lien by the Engineer-in-charge or the Government/ Institute or any other contracting person orpersons through Engineer-in-charge against any claim of the Engineer-in-charge or the Government/ Institute or such other person or persons in

respect of payment of a sumof money arising out of or under any other contract made by the Contractor with the Engineer in charge or Government/Institute or with such other person or persons.

It is an agreed term of the contract that the sum of the money so withheld or retained underthis clause by the Engineer-in-charge or the Government/ Institute will be kept withheldor retained as such by the Engineer-in-charge or the Government/ Institute or till hisclaim arising out of the same contract or any other contract is either mutually settled ordetermined by the competent court, as the case may be and that the contractor shall haveno claim for interest or damages whatsoever on this account or on any other ground inrespect of any sum of money withheld or retained under this clause and duly notified assuch to the contractor.

CLAUSE 30

TERMINATION OF CONTRACT ON DEATH OF THE CONTRACTOR

Without prejudice to any of the rights or remedies under this contract, if the Contractor dies, the Engineer-in-charge on behalf of the President/Director, NIT Meghalaya shall have the option of terminating the contract without compensation to the Contractor.

CLAUSE 31 WATER SUPPLY

The contractor(s) shall make his/their own arrangements for water required for the work and nothing extra will be paid for the same. This will be subject to the following conditions.

- i) That the water used by the contractor(s) shall be fit for construction purposes to the satisfaction of the Engineer-in-Charge.
- ii) The Engineer-in-Charge shall make alternative arrangements for supply of water at therisk and cost of contractor(s) if the arrangements made by the contractor(s) for procurement of water are in the opinion of the Engineer-in- Charge, unsatisfactory.

Institute Supply, if available:

Water, if available and sparable, may be supplied to the contractor by Institute only at the single point subject to the following conditions:-

- i) The water charges @1 % shall be recovered on gross amount of the work done.
- ii) The contractor(s) shall make his/their own arrangement of water connection and laying of pipelines from existing main of source of supply.
- iii) The Institute do not guarantee to maintain uninterrupted supply of water and it willbe incumbent on the contractor(s) to make alternative arrangements for water at his/their own cost in the event of any temporary break down in the Government/Institutewater main so that the progress of his/their work is not held up for want of water. Noclaim of damage or refund of water charges will be entertained on account of suchbreak down.

Alternative water arrangements:

- i) Where there is no piped water supply arrangement and the water is taken by the Contractor from the wells or hand pump constructed by the Government/Institute no charge shall be recovered from the Contractor on that account. The Contractor shall,however, draw water at such hours of the day that it does not interfere with the normaluse for which the hand pump and wells are intended. He will also be responsible for all damage and abnormal repairs arising out of his use, the cost of which shall berecoverable from him. The Engineer-in-charge shall be the final authority to determine the cost recoverable from the Contractor on this account.
- ii) The Contractor shall be allowed to construct temporary wells in Government/Institute land for taking water for construction purposes only after he has gotpermission of the Engineer-in-charge in writing. No charges shall be recovered from the Contractor on this account, but the Contractor shall be required to provide necessary safety arrangements to avoid any accidents or damage to

adjacentbuildings, roads and service lines. He shall also be responsible, for any accidents ordamage caused due to construction and subsequent maintenance of the wells and shall restore the ground to its original condition after the wells are dismantled oncompletion of the work.

CLAUSE 32 ELECTRICITY

Electricity, if available in the premises and sparable, may be provided to the contractor by the Institute only at the single point subject to the following conditions:-

- i) The Contractor has to make his own arrangement to tap Electricity from a 3 phase/single phase supply from location decided by Engineer-in-charge. Electricity supply willbe made available only on metered basis. Electric charges will be recovered at actuals.
- ii) In all cases where/when the energy meter is not installed, defective energy meter is not replaced or not rectified immediately, the consumption charges towards electricity willbe recovered on the basis of the total wattage of the load multiplied by the number of hours utilized. In all such cases the Contractor shall maintain a log book indicating wattage of the load and hours of consumption and get the same attested by Engineer-in-charge at appropriate time without fail. The decision of Engineer-in-charge in thematter shall be final.

CLAUSE 33

RETURN OF GOVERNMENT SURPLUS MATERIALS TO GOVERNMENT

Not with standing any thing contained to the contrary in any or all the clauses of thiscontract where any materials for the execution of the contract are procured with theassistance of Government/Instituteeither by issue from Government/Institute stocks or purchase underorders made or permits or licenses issued by the Government, the Contractor shall hold thesaid material as trustee for Government/Institute and use such materials economically and solelyfor the purpose of the contract and not dispose off them without the permission of theGovernment/Institute and return, if required by Engineer-in-charge all surplus, serviceable materialsthat may be left with him after the completion of the contract or at its termination for anyreason whatsoever on being paid or credited such price as the Engineer-in-charge shalldetermine having due regard to the condition of the material. The price allowed to theContractor, however, shall not exceed the amount charged to him excluding the storagecharges, if any. The contractor shall also not be entitled to cartage and incidental chargesfor returning the surplus materials from and to the stores where from they were issued. The decision of Engineer-in-charge shall be final and conclusive.

In the event of breach of aforesaid conditions the contractor shall in addition to throwinghimself open to action for contravention of the terms of licenses or permits and/or forcriminal breach of trust, be liable to compensate the Government/Institute for all money,advantages or profits resulting or which in the usual course would have resulted to him byreason of such breach.

Contractors Superintendence, Supervision, Technical Staff & Employees

(i) The contractor shall provide all necessary superintendence during execution of thework and all along thereafter as may be necessary for proper fulfilling of the obligations under the contract.

The contractor shall immediately after receiving letter of acceptance of the tender andbefore commencement of the work, intimate in writing to the Engineer-in-Charge, thename(s), qualifications, experience, age, address(s) and other particulars along withcertificates, of the principal technical representative to be in charge of the work and othertechnical representative(s) who will be supervising the work. Minimum requirement of suchtechnical representative(s) and their qualifications and experience shall not be lower thanspecified in Schedule 'F'. The Engineer-in-Charge shall within 3 days of receipt of suchcommunication intimate in writing his approval or otherwise of such a representative(s) tothe contractor. Any such approval may at any time be withdrawn and in case of suchwithdrawal, the contractor shall appoint another such representative(s) according to the provisions of this clause. Decision of the tender accepting authority shall be final andbinding on the contractor in this respect. Such a principal technical representative andother technical representative(s) shall be appointed by the contractor soon after receipt of the approval from Engineer-in-charge and shall be available at site before start of work.

All the provisions applicable to the principal technical representative under the Clause willalso be applicable to other technical representative(s). The principal technicalrepresentative and other technical representative (s) shall be present at the site of work forsupervision at all times when any construction activity is in progress and also presenthimself/themselves, as required, to the Engineer-in-Charge and/or his designatedrepresentative to take instructions. Instructions given to the principal technicalrepresentative or other technical representative(s) shall be deemed to have the same forceas if these have been given to the contractor. The principal technical representative andother technical representative(s) shall be actually available the decision of the Engineer-in-Charge as recorded in the site order book and measurement recorded checked/testchecked in Measurement Books shall be final and binding on the contractor.

Further if the contractor fails to appoint suitable technical Principal technical representative and/or other technical representative(s) and if such appointed persons are not effectively present or are absent by more than two days without duly approved substitute or do notdischarge their responsibilities satisfactorily, the Engineer-in-Charge shall have full powersto suspend the execution of the work until such date as suitable other technical representative(s) is/are appointed and the contractor shall be held responsible for the delayso caused to the work. The contractor shall submit a certificate of employment of thetechnical representative(s) along with every on account bill/ final bill and shall produceevidence if at any time so required by the Engineer-in-Charge at site fully during all stages of execution of work, during recording/checking/ test checking of measurements of worksand whenever so required by the Engineer-in-Charge and shall also note down instructionsconveyed by the Engineer-in- Charge or his designated representative(s) in the site orderbook and shall affix his/ their signature in token of noting down the instructions and in tokenof acceptance of measurements/ checked measurements/test checked measurements.The representative(s) shall not look after any other work. Substitutes, duly approved by Engineer-in-Charge of the work in similar manner as aforesaid shall be provided in event of absence of any of the representative(s) by more than two days.

If the Engineer-in-Charge, whose decision in this respect is final and binding on thecontractor, is convinced that no such technical representative(s) is/are effectively appointedor is/are effectively attending or fulfilling the provision of this clause, a recovery (nonrefundable)shall be effected from the contractor as specified in Schedule 'F' and

(ii) The contractor shall provide and employ on the site only such technical assistantsas are skilled and experienced in their respective fields and such foremen and supervisorystaff as are competent to give proper supervision to the work.

The contractor shall provide and employ skilled, semiskilled and unskilled labour as isnecessary for proper and timely execution of the work.

The Engineer-in-Charge shall be at liberty to object to and require the contractor to removefrom the works any person who in his opinion misconducts himself, or is incompetent ornegligent in the performance of his duties or whose employment is otherwise consideredby the Engineer-in-Charge to be undesirable. Such person shall not be employed again atworks site without the written permission of the Engineer-in-Charge and the persons soremoved shall be replaced as soon as possible by competent substitutes.

This contract is liable to be cancelled if either the Contractor or any of his employees is found at any time to be such a person who had not obtained the permission of Government of India as aforesaid before submission of the tender or engagement in the Contractor's service as the case may be.

 - c. Theoretical quantity of G.I. & C.I. or other pipes, conduits, wires and cables, piglead and G.I./M.S. sheets shall be taken as quantity actually required andmeasured plus 5% for wastage due to cutting into pieces (except in the case of G.I./M.S. sheets it shall be 10%), such determination & comparison being madediameter wise & category wise.

- d. For any other material as per actual requirements.
- ii) Over the theoretical quantities of materials so computed a variation shall be allowed sspecified in Schedule 'F'. The difference in the net quantities of material actually issued to the contractor and the theoretical quantities including such authorized variation, if not returned by the contractor or if not fully reconciled to the satisfaction of the Engineer-in- Charge, within fifteen days of the issue of written notice by the Engineer-in-charge to this effect shall be recovered at the rates specified in Schedule 'F', without prejudice to the provision of the relevant conditions regarding return of materials governing the contract. Decision of Engineer-in-Charge in regard to theoretical quantities of materials, which should have been actually used as perthe Annexure of the standard schedule of rates and recovery at rates specified in Schedule 'F', shall be final & binding on the contractor.

For non scheduled items, the decision of the Engineer-in-Charge regarding theoretical quantities of materials which should have been actually used, shall be final and binding on the contractor.

iii) The said action under this clause is without prejudice to the right of the Government/Institute to take action against the contractor under any other conditions of contract for not doing the work according to the prescribed specifications.
