**Title of the Contract :** Rehabilitation works (i) of the Bujumbura-Gitaza road section (RN 3 of 25 km), with laying of fiber optic pipes, as well as (ii) of the Mwambutsa and Ndayaye Melchior boulevards, over 4 km, taking into account Non-Motorized Transport (TNM) and the laying of fiber optic pipes over 4 km.

1. The Government of Burundi has obtained a grant from the World Bank to finance the cost of the Burundi Transport Resilience Project (PRT-P172988) and intends to use part of the proceeds from this financing to make the payments planned under the contract for the **rehabilitation works (i) of the Bujumbura-Gitaza road section (RN 3 of 25 km), with laying of fiber optic pipes, as well as (ii) of the Mwambutsa and Ndayaye Melchior boulevards, over 4 km, taking into account Non-Motorized Transport (TNM) and the laying of optical pipes 4 km.** For this contract, the Borrower must use for payments the disbursement method entitled "Direct Payment", as defined in the Guidelines

**of the fibre on**

World Bank Disbursement Facility for Investment Project Financing.

2. The Burundi Transport Resilience Project (PRT-P172988) hereby invites Bidders to submit their Offers in a sealed envelope for the rehabilitation works of (i) the Bujumbura-Gitaza road section (RN 3 of 25 km), with the laying of fiber optic pipes, as well as (ii) the Mwambutsa and Ndadaye Melchior boulevards, over 4 km, taking into account Non-Motorized Transport (TNM) and the laying of fiber optic pipes over 4 km.

The works consist of site installation and removal work, execution of preliminary works and clearance of rights-of-way, execution of general earthworks, construction of sanitation works, implementation of the roadway, construction of engineering structures, installation of signage and equipment, installation of lighting and implementation of environmental and social measures.

3. The procedure will be conducted through international competition using a Call for Bids as defined in the World Bank Procurement Regulations for REIT Borrowers of September 2023 and open to all Bidders countries as defined in the Procurement Regulations. (« from eligible

4. Eligible Bidders may obtain additional information from the Burundi Transport Resilience Project (PRT-P172988) and examine the Bidding Documents during office hours from 8:00 a.m. to 12:00 p.m. and from 2:00 p.m. to 5:00 p.m. at the address indicated below.

5. The French Tender Documents may be purchased by any interested eligible Bidder by making a written request to the address below against a non-refundable payment of one million Burundi Francs (BIF 1,000,000). The method of payment will be by direct bank deposit in equal parts of five hundred thousand Burundi Francs (BIF 500,000) to be made into account CC138241 No. 02104582384 entitled PRT/BIF opened at the Bank of the Republic of Burundi and into account No. 1101/001.04 (sub-account for transit of non-tax revenues) opened at the Bank of the Republic of BURUNDI in the name of the Burundian Revenue Office. The tender documents will be collected from the address indicated below upon presentation of the payment slips on these accounts as proof of purchase of the tender documents.

6. Bids must be delivered to the address indicated below no later than **28/03/2025 at 10:00 a.m., Bujumbura time, i.e. GMT+2**. Electronic submission of bids will not be permitted. Any Bid received late will be rejected. The outer envelopes of the Bid marked "ORIGINAL OF THE BID", and the inner envelopes marked "TECHNICAL PART" will be opened in the presence of the Bidders' representatives and any other person who wishes to attend the **opening of the bids at the address indicated below, on 28/03/2025 at 10:30 a.m., Bujumbura time, i.e. GMT+2**. All envelopes marked "FINANCIAL PART" will remain unopened and will be kept in a secure location by the Transport Resilience Project until the second public opening of the Bids.

7. Bids must be accompanied by a bid security in the amount of **six billion Burundi Francs (BIF 6,000,000,000) or an equivalent amount in any other freely convertible currency.**
8. Offers must be accompanied by a Declaration relating to the Operation and to Sexual Abuse (SEA) and/or Sexual Harassment (SH).
9. Please note that the Procurement Regulations require the Borrower to disclose information on the beneficial owners of the successful Bidder, as part of the Contract Award Notification notice, by completing the Beneficial Ownership Disclosure Form included in the Bidding Documents.
