WBSETCL invites single stage double folder bids from eligible and qualified bidders through e-tender for procurement of service as follows:

Brief scope of work:

- i) **Construction of foundation of 50m Lightning Mast structures and its allied works as per approved drawing & specification.**
- ii) Supply of all required materials, namely cement, reinforcing steel, Coarse/Fine aggregates etc. and all other items required for completion of the work by the vendor.
- iii) Site cleaning including removal of all the residual material supplied by the party.

Cost of the Bidding document (**non-refundable**) as mentioned above in the form of a **Demand Draft/Pay Order/Banker's Cheque** drawn in favour of **“WEST BENGAL STATE ELECTRICITY TRANSMISSION COMPANY LIMITED”** from any scheduled bank payable at Kolkata shall have to be deposited physically at the office the Chief Engineer: (O&M) - II, D- Block, 10<sup>th</sup> Floor, WBSETCL, Bidyut Bhawan on or before **20.02.2024 up to 01.00 P.M.**

5.0 Downloading the bidding documents shall not automatically construe that the bidder fulfils the Qualifying Requirements which shall be determined during bid evaluation based on data/documents uploaded by the bidder.

6.0 All bids must be supported by **bid security (EMD)** for an amount of **Rs. 30,000=00 (Rupees thirty thousand Only)**. Details guidelines here under for submission of bid-security in online mode:

a. The bidder shall login to the e-Procurement portal of Government of West Bengal <https://wbtenders.gov.in> using his login Id and password.

b. The bidder shall select the tender to bid and initiate payment of EMD. Following payment options are available for paying EMD amount through online mode:

i. Net-banking through Payment Gateway.

ii. ~~Submission of EMD through BG: For submission of EMD in the form of BG, bidders will have to opt for EMD Exemption in e tender portal and upload scanned copy of BG (i.e. **Bank Guarantee of an amount of Rs.1,52,700=00 (Rupees One lakh fifty two thousand seven hundred Only) with validity for a period of 180 days from the date of opening of Technical Bids with a claim period of another 90 days thereafter**) along with requisite testimonials for proportional EMD in the EMD exemption document upload section. Physical copy of BG shall be submitted within the stipulated date at the office of **the Chief Engineer (O&M) II, 10th Floor, D-Block, Bidyut Bhawan.**~~

- c. EMD amount can be paid either in online mode or submitted through Bank Guarantee (BG) in full. Partial payment through online mode and remaining submission through BG is not allowed.

**d. GENERAL INSTRUCTIONS FOR ONLINE PAYMENT:**

- The bidder will have to mandatorily pay through Net-banking facility once Net banking mode is opted for payment.
- Only a single value can be entered as EMD amount in e-tender portal for each tender. However, in case tender has fixed EMD on line item (multiple items) basis, then, for the cases when actual EMD value calculated as per NIT by the bidder is less than the one mentioned in e-tender portal, bidders shall mandatorily opt for Exemption for payment of actual EMD amount and upload the requisite testimonials for proportional EMD and its proportional amount is to be paid in form BG/ online mode.
- The bank account used for payment of EMD by the bidders shall be maintained operative until the completion of tendering process. All refunds will be made mandatorily to the Bank A/c from which the payment of EMD has been initiated.

**e. Refund/Settlement of EMD Amount:**

- For unsuccessful bidders, EMD amount submitted against the tender shall be refunded automatically, through an automated process, by NIC portal on receipt of updated status of any bid.
- For successful bid(s), EMD will be refunded from WBSETCL authority after completion of tendering process and following due procedures.
- The bank account used for payment of EMD by the bidders shall be maintained operative until the completion of tendering process. All refunds will be made mandatorily to the Bank A/c from which the payment of EMD has been initiated.

- 7.0 Bid shall be rejected by the WBSETCL if the bidder fails to submit original Bank Guarantee /Demand Draft /Pay order against tender fees & original Bank Guarantee against Earnest Money Deposit (EMD) physically to the office of the Chief Engineer, Transmission (O&M-II), WBSETCL under sealed cover on or before the scheduled date & time as specified above.

**8.0 Qualifying Requirements for bidders:**

- 8.1. Following shall be the qualification requirements:

**A. Technical qualifying requirement:** The bidder should have the past experience of executing **Works and services similar nature such as** Construction of foundation of 33 KV or 132 KV or 220 KV or 400 KV Switchyard equipment structures/ Construction of foundation of 33 KV or 132 KV or any higher voltage class Bays / Construction of foundation of Transmission Line Tower or L.M structure/Construction of residential or commercial Building of value not less **than Rs.17.97 Lac excluding taxes** in the preceding 5 (five) financial years under Central/ State Government, or reputed power utilities of PSU's.

**B. Financial** Financial QR for the tender are as follows:

<b>Net Worth:</b>	Net Worth should be positive.
<b>Liquid Asset:</b>	<b>Rs 7.49 lac</b> Bidder should have liquid assets (L.A) and/or evidence of access to or availability of credit facilities of equivalent amount.
<b>MAAT:</b>	<b>Rs. 44.92 lac</b>

**Note: 1.) MAAT:** Minimum average annual turnover for the best three years out of the last five financial years.

**2.) 'Liquid Asset'** shall be as per the last audited accounts available.

8.2. The bidder shall furnish, as part of his bid, scanned copies of documents to be uploaded for establishing the bidder's qualifications. In particular, the following documents need to be uploaded by the bidder:

- a. List of contracts for similar Works and services executed in the past three years with copies of LoAs and execution status of each contract supported by client's certificate.
- b. Audited Annual Accounts of the company for the last five (5) years (in case of companies)

or

IT Return duly acknowledged by the tax department for the last five (5) years (in case of bidders other than companies)

- c. **Copies of Professional Tax Clearance Certificate, E.S.I and E.P.F registration numbers, PAN and/or TAN Card, Registration Certificate (Form GST REG - 06) issued under Goods and Services Tax Laws.**

8.3. In addition to above, the bidder shall also be required to meet the eligibility conditions and submit a declaration as per Annexure: 5 of Section VI-A of the bidding documents

8.4. Notwithstanding anything stated herein, WBSETCL reserves the right to inquire and review the bidder's capability and capacity to execute the Works and services

9.0 WBSETCL reserves the right to accept or reject any bid partly or fully or cancel the bidding process without assigning any reasons there for and in such case no bidder shall have any claim arising out of such action.
