“Construction of foundation for switchyard equipments i.r.o 02(two) nos 33KV LV side Bays at Asansol 220/132/33KV sub-station and 01(one) no 33KV Feeder Bay at Ukhra 132/33/11KV sub-station under Durgapur 400KV Area office WBSETCL”

0.0 WBSETCL invites single stage double folder bids from eligible and qualified bidders through e-tender for procurement of service as follows:

1.0 Brief scope of work:

- i) Earthwork in excavation as per specification and drawings.
- ii) Construction of foundation of different 33 KV equipment structures, associated Land development as per specification.
- iii) Supply of all required materials, namely cement, reinforcing steel, Coarse/Fine aggregates, bricks, Steel, etc. and all other items required for completion of the work by the vendor.
- iv) Site cleaning including removal of all the residual material supplied by the party.

2.0 Detailed Specifications, scope of supply and terms and conditions of supply are given in the bidding documents, which are available at the online e-tendering portal <https://wbtenders.gov.in/> or <https://etender.wb.nic.in> as per the following schedule:

- 3.0 A complete set of bidding documents may be downloaded by any interested bidder. Cost of the Bidding document (non-refundable) as mentioned above in the form of a Demand Draft/Pay Order/Banker’s Cheque drawn in favour of **“WEST BENGAL STATE ELECTRICITY TRANSMISSION COMPANY LIMITED”** from any scheduled bank payable at Kolkata shall have to be deposited physically at the Office of the Superintending Engineer & Area Manager, Durgapur 400 KV Area office ,1st Floor, Administrative Building, Durgapur 400KV Sub-Station Complex, Bidhannagar, Durgapur-713206 on or before **12.02.2024 up to 01.00 P.M.**
- 4.0 Downloading the bidding documents shall not automatically construe that the bidder fulfils the Qualifying Requirements which shall be determined during bid evaluation based on data/documents uploaded by the bidder

5.0 Following points shall be included in NIT REP floated through e-tender website :-

- a. A bidder desirous of taking part in tender invited by offices of WBSETCL shall login to the e-procurement portal of Government of west Bengal <https://wbtenders.gov.in> using its loginId and password.
- b. The bidder shall select the tender to bid and initiate payment of EMD. Following payment options are available for paying EMD amount through online mode:-
 - i. Net –banking through payment gateway.
 - ii. Submission of EMD through BG:- For submission of EMD in the form of BG, bidders will have to opt for EMD Exemption in e-tender portal and upload scanned copy of BG along with requisite testimonial for proportional EMD in the EMD exemption document upload section. Physical copy of BG shall be submitted at the office of tender inviting authority as per respective clauses of NIT.
- c. EMD amount can be paid either in online mode or submitted through Bank Guarantee (BG) in full. **Partial payment through online mode and remaining submission through BG is not allowed.**
- d. **General Instructions for Online Payment:**
 - ▶ The bidder will have to mandatorily pay through Net-banking facility once Net- banking mode is opted for payment.
 - ▶ Only a single value can be entered as EMD amount in e-tender portal for each tender. However, in case tender has fixed EMO on line item (multiple items) basis, then, for the cases when actual EMD value calculated as per NIT by the bidder is less than the one mentioned in e-tender portal, bidders shall mandatorily opt for Exemption for payment of actual EMD amount and upload the requisite testimonials for proportional EMD and its proportional amount is to be paid **in form BG/ online mode.**

- ▶ The bank account used for payment of EMD by the bidders shall be maintained operative until the completion of tendering process. All refunds will be made mandatorily to the Bank A/C from which the payment of EMD has been initiated.

e. Refund/settlement of EMD amount:-

- ▶ For unsuccessful bidders EMD amount submitted against the tender shall be refunded automatically, through an automated process by NIC portal on receipt of updated status of any bid.
- ▶ For successful bid(s) EMD will be refunded from WBSETCL authority after completion of tendering process and following due procedures.
- ▶ The bank account used for payment of EMD by the bidders shall be maintained operative until the completion of tendering process. All refunds will be made mandatorily to the Bank A/C from which the payment of EMD has been initiated.
- ▶ For any queries related to payments and refunds bidders will have to communicate with ICICI customer support Viz 9836547320 and 8017094744 since payment gateway facility used by E tender portal maintained by ICICI

6.0 For technically rejected bids EMD amount will be automatically returned to the bidders after the bid is technically rejected in e-tender portal .

7.0 Qualifying Requirements for bidders:

7.1 Following shall be the qualification requirements:

7.2

a. Technical Qualifying Requirement:

The bidder should have the past experience of executing works and services similar nature such as **Construction of foundation of 33 KV or 132 KV or 220 KV or 400 KV Switchyard equipment structures/ Construction of foundation of 33 KV or 132 KV or any higher voltage class Bays / Construction of foundation of Transmission Line Tower or L.M structure of value not less than Rs.19.00 lac excluding taxes** in the preceding 5 (five) financial years under Central/ State Government, or reputed power utilities of PSUs.

b. Financial

Financial QR for the tender are as follows:

Net Worth:	Net Worth should be positive.
Liquid Asset:	Rs 4.84 lac Bidder should have liquid assets (L.A) and/or evidence of access to or availability of credit facilities of equivalent amount.
MAAT:	Rs.28.50 lac

Note: 1.) MAAT: Minimum average annual turnover for the best three years out of the last five financial years.

2.) 'Liquid Asset' shall be as per the last audited accounts available.

7.3 The bidder shall furnish, as part of his bid, scanned copies of documents to be uploaded for establishing the bidder's qualifications. In particular, the following documents need to be uploaded by the bidder:

- a. List of contracts for similar Works and services executed in the past three years with copies of LoAs and execution status of each contract supported by client's certificate.
- b. Audited Annual Accounts of the company for the last three (3) years (in case of companies)

or

IT Return duly acknowledged by the tax department for the last three (3) years (in case of bidders other than companies)

- c. **Copies of Professional Tax Clearance Certificate, E.S.I and E.P.F registration numbers, PAN and/or TAN Card, Registration Certificate (Form GST REG - 06) issued under Goods and Services Tax Laws.**

7.4 In addition to above, the bidder shall also be required to meet the eligibility conditions and submit a declaration as per Annexure: 5 of Section VI-A of the bidding documents

7.5 Notwithstanding anything stated herein, WBSETCL reserves the right to inquire and review the bidder's capability and capacity to execute the Works and services

8.0 WBSETCL reserves the right to accept or reject any bid partly or fully or cancel the bidding process without assigning any reasons there for and in such case no bidder shall have any claim arising out of such action.
