(+374 - 10) 59-13-67 e-mail: Karapetyan_HG @ena .am , Sargsyan_SM@ena.am , petrosyan_ak@ena.am) hereby invites legal entities and individual entrepreneurs (hereinafter referred to as <Participants>) to participate in the Open Request for Proposals for the needs of the Client, in 3 lots, for the performance of works on the repair of the roofs of substations belonging to “ENA” CJSC throughout the territory of the Republic of Armenia, replacement of 0.4, 6(10) kV cable lines, replacement of 0.4, 6(10) kV overhead lines, with the right to conclude a contract for the performance of works on the selection of a new contractor (hereinafter referred to as <Works>):

LOT 1 – Repair of the roofs of substations belonging to “ENA” CJSC throughout the territory of the Republic of Armenia,

LOT 2 - Replacement of 0.4. 6(10)kV cable lines belonging to “ENA” CJSC throughout the territory of the Republic of Armenia.

LOT 3 - Replacement of 0.4. 6(10)kV overhead lines belonging to “ENA” CJSC throughout the territory of the Republic of Armenia.

2. The requirements for participants in the open request for proposals and a detailed description of the work and the procedure for the open request for proposals are included in the Open Request for Proposals documents, which will be provided to any participant upon their written request in accordance with the following procedure. The package of documents provided for participation in the Open Request for Proposals can be obtained by submitting a copy of the participant's identity document (a copy of the state registration certificate of a commercial organization or individual entrepreneur, a power of attorney of the person directly receiving the invitation (if it is not a person authorized to act without a power of attorney) and his/her identity document.

3. Applications for the open request for proposals shall be submitted in sealed envelopes to the address of the Client specified in point 1 of this Notice no later than May 22, 2025 at 10:00 (local time), in accordance with the requirements of the open request for proposals documents. The Client will conduct the public opening of

envelopes on May 22, 2025 at 11:00 (local time) at the address specified in point 1 of this Notice. Representatives of the Participants in the open request for proposals may be present during this procedure.

4. This notice, as well as the request for proposals documents, do not constitute an offer.
