TYPE AND NUMBER OF CONTRACT: Public Tender No. 13/2025.

PURPOSE: Hiring of a Private Security and Surveillance Service for various buildings of this Public Defense Ministry, all located in this Autonomous City of Buenos Aires.

OPENING CEREMONY : It will be held on April 30, 2025, at 11:00 a.m. in the Purchasing and Contracting Department, located at Tacuarí No. 139/43/47, 5th floor, in this Autonomous City of Buenos Aires.

DOWNLOAD OF THE TERMS AND CONDITIONS : The Tender Documents and other tender documents will be available for free download by interested parties from the official website of the Office of the Public Defender.

For the purposes of presenting themselves as bidders, personal collection of the Specific and General Terms and Conditions is not mandatory. Notwithstanding the foregoing, those interested in receiving notifications related to administrative acts issued up to the bid opening must complete and submit the "POSTAL AND EMAIL ADDRESS PROOF OF ESTABLISHMENT" form available on the official website for each contractor selection procedure.

DAY, PLACE AND DEADLINE FOR SUBMISSION OF OFFERS: until the day, time and place indicated for the opening.

TECHNICAL AND/OR ADMINISTRATIVE INQUIRIES : They must be made in writing up to three (3) business days before the date set for the opening ceremony, to the Purchasing and Contracting Department located at Tacuarí 139/43/47, 5th Floor, Autonomous City of Buenos Aires, Monday through Friday from 9:30 a.m. to 4:00 p.m., tel.: (011) 7093-2050. They may also be sent by email to the following address: contrataciones@mpd.gov.ar indicating the number and purpose of the contract in the subject line.

Any inquiries from interested parties must be submitted along with ANNEX IV of the Single General Terms and Conditions. If the inquirer fails to attach the aforementioned annex, the email address from which the inquiry is made will be deemed the registered address for the purposes set forth in Articles 3 and 4 of said Terms and Conditions and 17 and 18 of the "REGISTER FOR THE ACQUISITION, DISPOSAL, AND CONTRACTING OF GOODS AND SERVICES OF THE PUBLIC DEFENSE PROSECUTOR'S OFFICE."

MANDATORY VISIT TO THE WORK SITE: A budget must be prepared after visiting all buildings where services will be provided, so that bidders can learn about the locations where the work will be performed, as well as any information that may influence the bid price. Consequently, they may not, for any reason, invoke ignorance or the existence of unforeseen factors.

This Department will issue the corresponding visit certificate, which must be attached to the offer.

GUARANTEES : The guarantee of maintenance of offer or fulfillment of the contract may be implemented by means of a promissory note, provided that the amount of the guarantee does not exceed the sum of TWENTY THOUSAND PESOS (\$20,000).
