1. A bank guarantee in the same form specified in the tender document for a lump sum amount of (\$2,000), valid for (90 days) from the date of opening the envelopes, or an acceptable check. Any bid not accompanied by a tender guarantee will be excluded
2. A copy of a valid commercial register
3. A copy of a valid tax card
4. A copy of a valid insurance card + zakat card
5. A copy of a valid professional certificate or license
6. Documents proving previous experience in implementing similar projects
7. Documents proving the bidder's registration with the Ministry of Social Affairs and Labor
