The project will also implement a SCADA (Supervisory, Control, and Data Acquisition) system for Line 2 of the Santo Domingo Metro. This system will allow the FDI (Fire Detection and Control) and ventilation equipment to be controlled from their respective centers, collect and record operating data, and display it at the Central Command Post (CCP). The main objective is to ensure efficient supervision and management.
