Quotations are due by March 21st, 2025, 9AM East African Time. No quotations will be accepted after this time. Proposals must be in English and incomplete proposals will not be accepted.

Your quotation must be submitted electronically to NairobiGSO-bids@state.gov.


It is important to make sure the submission is made in specific size and format; in MS-Word 2007/2010 or MS-Excel 2007/2010 or Adobe Acrobat (pdf) file format. The file size must not exceed 30MB. If the file size should exceed the 30MB, the submission must be made in separate files and attached to separate emails with less than 30MB each.

4. Additional information as required in Section 3
5. Proof of SAM Registration

Failure to be registered at time of proposal submission may deem the offeror's proposal to be considered non-responsible and no further consideration will be given. Therefore, offerors are highly encouraged to register immediately if they are interested in submitting a response to this requirement.

1.0 DESCRIPTION

The American Embassy in **Nairobi, Kenya** requires preventive maintenance services for the Water Treatment of Potable Water Systems. These services shall result in all systems being serviced under this agreement being in good operational condition when activated.

1.1. TYPE OF CONTRACT

This is a firm fixed price contract payable entirely in US Dollars. Prices for all Contract Line-Item Numbers (CLIN) shall include proper disposal of toxic substances as per Item 8.4 where applicable. No additional sums shall be payable for any escalation in the cost of materials, equipment, or labor, or because of the contractor's failure to properly estimate or accurately predict the cost or difficulty of achieving the results required. The contract price shall not be adjusted due to fluctuations in currency exchange rates.

1.2. PERIOD OF PERFORMANCE

The contract shall be for a period of one-year, with a maximum of two one-year optional periods of performance and shall be expected to commence no later than April 1, 2025.

2.0 PRICING

The rates below include all costs associated with providing preventive maintenance services in accordance with the attached scope of work, and the manufacturer's recommended method of preventive maintenance including materials, labor, insurance (see FAR 52.228-4 and 52.228-5), overhead, profit and GST (if applicable).

2.1. Base Year. The Contractor shall provide the services shown below for the base period of the contract and continuing for a period of 12 months starting from the date of the NTP. Visits to Embassy Nairobi for delivery of services are represented in the schedules below.

2.7 Repair option. Repairs are NOT included under this agreement (see 7.1.3) and are to be done outside this contract. The Contractor shall provide daily rates for labor to undertake repairs; these rates shall be used when such repairs are required. As stated in 7.1.3 any necessary repairs or parts shall be submitted for approval and then billed against a separate PO. The Contractor is not approved to do any additional work without approval from the Contracting Officer.

2.8 Emergency Service Option. Emergency Service is NOT included under this agreement and shall be billed outside this contract. The Contractor shall provide daily rates for providing such emergency services when required; these rates shall be used when such emergency repairs are required. The Contractor shall provide a breakdown of how the rates has been developed for the COR/CO to undertake a review of such rates. Emergency Service, with a maximum 24-hour response time, must be available 24-hours per day 365 days a year. Submit cost for Emergency Services below. Typical situations (but not limited to) deemed as requiring emergency services are:

- Loss of triplex booster pump controllers.
- Loss of transfer pump controller
- Loss of potable water treatment panel skid
- Loss of raw water treatment panel skid

3.0 NOTICE TO PROCEED

After Contract award and submission of acceptable insurance certificates and copies of all applicable licenses and permits, the Contracting Officer shall issue a Notice to Proceed. The Contractor shall mobilize to site to commence performance of the work no later than twenty-one (21) days from the Notice to Proceed (NTP). -

DESCRIPTION/SPECIFICATION/WORK STATEMENT

4.0 EQUIPMENT AND PERFORMANCE REQUIREMENTS

4.1. The American Embassy in Nairobi requires the Contractor to maintain the following systems in a safe, reliable, and efficient operating condition. Please see equipment list included in Exhibit A for detailed description.

1) Water Treatment of Potable Water Systems.

4.2. The Contractor shall provide all necessary managerial, administrative, and direct labor personnel, including transportation, equipment, tools, supplies, and materials required to perform all services as described in inspection, maintenance, and component replacement as required to maintain the systems in accordance with this work statement. Under this Contract the Contractor shall provide:

- The services of trained and qualified personnel to inspect, adjust, and perform scheduled preventive maintenance; and provide consumable materials.

4.3. Performance Standards

All work in this agreement shall be completed in a professional and timely manner. Those working on the equipment should be certified and the quality of work should reflect that. The Contractor shall schedule all preventive maintenance work with the post Facility Manager to avoid disrupting the business operation of the Embassy.

5.0 HOURS OF PERFORMANCE

5.1. The Contractor shall schedule all preventive maintenance and repair work during normal building hours which are defined as 7.30 a.m. to 16.30 p.m. Monday and Friday. Request for work conducted outside the Embassy normal working hours (including weekends, local and American holidays) shall be made to the COR at least 36 hours prior to commencing such work.

6.0 ACCESS TO GOVERNMENT BUILDINGS AND STANDARDS OF CONDUCT

6.1 General. The Contractor shall designate a representative who shall supervise the Contractor's technicians and be the Contractor's liaison with the American Embassy, Nairobi. The Contractor's employees shall be on-site only for contractual duties and not for any other business or purpose. Contractor employees shall be always escorted by authorized Embassy staff during the employee's presence within the Embassy compound. -

6.2 Personnel Security. The Government reserves the right to deny access to U.S.-owned and U.S.-operated facilities to any individual. The Contractor shall provide the names, biographic data and police clearance on all Contractor personnel who shall be used on this Contract prior to their utilization. Submission of information shall be made within 5 days of award of contract. -

6.2.1 Vehicle Access: Contractor vehicles can access the Embassy compound only through the written approval from the Regional Security Office at post. Such request for access shall be submitted to the Facilities Manager/COR at least 48 hours prior to access date/time and shall include (at minimum) the vehicle make, model, registration number, reason for access, driver's name/nationality/national ID and/or a valid passport. -

6.3.1 The Contractor must comply with all the following requirements relating to the protection of U.S. Embassy Diplomatic personnel, property and compound project information and cooperate fully in all security matters Sensitive But Unclassified (SBU) and information that may arise relating to this contract.

6.4 Standards of Conduct

6.4.1 General. The Contractor shall maintain satisfactory standards of employee competency, conduct, cleanliness, appearance, and integrity and shall be responsible for taking such disciplinary action with respect to employees as may be necessary. Each Contractor employee shall adhere to standards of conduct that reflect credit on themselves, their employer, and the United States Government. The Government reserves the right to direct the Contractor to remove an employee from the worksite for failure to comply with the standards of conduct. The Contractor shall immediately replace such an employee to maintain continuity of services at no additional cost to the Government.

6.4.2 Uniforms and Personal Equipment. The Contractor's employees shall wear clean, neat, and complete uniforms when on duty. All employees shall wear uniforms approved by the Contracting Officer's Representative

(COR). The Contractor shall provide, to each employee and supervisor, uniforms, and personal equipment. The Contractor shall be responsible for the cost of purchasing, cleaning, pressing, and repair of the uniforms. The Contractor shall provide all its employees with personal protective equipment (PPE) as guided by the Health & Safety codes and standards for PPE.

6.4.3 Neglect of Duties. Neglect of duties shall not be condoned. This includes sleeping while on duty, unreasonable delays or failures to carry out assigned tasks, conducting personal affairs during duty hours and refusing to render assistance or cooperate in upholding the integrity of the worksite security.

6.4.4 Disorderly Conduct. The Contractor shall not condone disorderly conduct, use of abusive or offensive language, quarreling, and intimidation by words, actions, or fighting. Also included is participation in disruptive activities that interfere with normal and efficient Government operations.

6.4.5 Intoxicants and Narcotics. The Contractor shall not allow its employees while on duty to possess, sell, consume, or be under the influence of intoxicants, drugs or substances which produce similar effects.

6.4.6 Criminal Actions. Contractor employees may be subject to criminal actions as allowed by law in certain circumstances. These circumstances include but are not limited to the following actions: falsification or unlawful concealment, removal, mutilation, or destruction of any official documents or records or concealment of material facts by willful omission from official documents or records; unauthorized use of Government property, theft, vandalism, or immoral conduct; unethical or improper use of official authority or credentials; security violations; organizing or participating in gambling in any form; and possession of weapons.

6.4.7 Key Control. The Contractor **shall not** be issued any keys. The keys shall be checked out from Post 1 by a "Cleared American" escort on the day of service requirements.

6.4.8 Notice to the Government of Labor Disputes. The Contractor shall inform the COR of any actual or potential labor dispute that is delaying or threatening to delay the timely performance of this contract.

7.0 SCHEDULED PREVENTIVE MAINTENANCE

7.1. General

7.1.1. The Contractor shall perform preventive maintenance as outlined in Exhibit A - STATEMENT OF WORK. The objective of scheduled preventive maintenance is to eliminate system malfunction, breakdown, and deterioration when units are in activated/running mode. Contract maintenance of the Water Treatment of Potable Water Systems must assure continuous, safe, and satisfactory operation of all the elements, their parts, and components.

7.1.2. The Contractor shall inventory, supply, and replace expendable parts that have become worn down due to wear and tear. The Contractor shall maintain a supply of expendable and common parts on site so that these are readily available for normal maintenance to include (but not limited to): Fuses, cartridge filters, bag filters, chlorine test kits, PH test kits, temperature sensors, pressure transducers, communication switches, varieties of resistors; in addition to the appropriate tools, testing equipment, safety shoes and apparel for technicians, personal protective equipment (hands, hearing, eye protection). The contractor should inventory the supply after each visit and order replacement supplies and have them delivered to post.

7.1.3. Exclusion. This contract does NOT include repair of equipment and replacement of hardware (e.g., motors, pumps & equipment controllers) Hardware **replacements shall be separately priced out by the Contractor for**

the Government's approval and acceptance. The Government has the option to accept or reject the Contractor's quote for parts and reserves the right to obtain similar spare parts from other competitive sources. If required by the Government, the Contractor shall utilize Government-purchased spare parts, if awarded the work. Such repairs/replacements shall be accomplished by a separate purchase order. However, this exclusion does not apply if the repair is to correct damage caused by Contractor negligence.

7.1.4. Replacement/repair of any electronic or electrical parts must be approved by the COR prior to installation of the part. If the Contractor proceeds to replace any parts without COR approval, the Contractor shall de-install the parts at no cost to the Government.

7.2 Checklist Approval

The Contractor shall submit to the COR a schedule and description of preventive maintenance tasks which the Contractor plans to provide. The Contractor shall prepare this schedule and task description in a checklist format for the COR's approval prior to contract work commencement.

7.2.1. The Contractor shall provide trained technicians to perform the service at frequencies stated in Exhibit A and on the equipment called out in this SOW. The technician shall sign off on every item of the checklist and leave a copy of this signed checklist with the COR or the COR's designate after the maintenance visit.

7.2.2. It is the responsibility of the Contractor to perform all manufacturers recommended preventive maintenance including preventive maintenance recommended by the manufacturer's technical manuals for the respective equipment.

8.0 PERSONNEL, TOOLS, CONSUMABLE MATERIALS AND SUPPLIES

The Contractor shall provide trained personnel with the appropriate tools and testing equipment for scheduled maintenance, safety inspection, and safety testing as required by this Contract. The Contractor shall provide all necessary materials and supplies to maintain, service, inspect and test all the systems to be maintained.

8.1 Contractor furnished materials shall include but not limited to appropriate tools, testing equipment, safety shoes and apparel for technicians, hands, hearing and eye protection. See 7.1.2.

8.2 Repairs. Repairs are not included in this contract. See Item 7.1.3. Exclusions.

8.3 Disposal of used controllers, battery, and any other toxic substances. The Contractor is responsible for proper disposal of toxic/hazardous substances. All material shall be disposed of according to Government and Local law. After proper disposal the contractor must show proof of authorized disposal of these toxic/hazardous substances.

9.0 EXCLUSIONS

The Contractor shall not assume responsibility for the following items which are not included in this contract:

- Fire alarm annunciators.
- Fuel system.
- Fire pump engine
- Fire alarm system.
- Exhaust fans
- Lighting controls

11.0 INSURANCE REQUIREMENTS

11.1 Personal Injury, Property Loss, or Damage (Liability). The Contractor assumes absolute responsibility and liability for all personal injuries or death and property damage or losses suffered due to negligence of the Contractor's personnel in the performance of this Contract.

The Contractor's assumption of absolute liability is independent of any insurance policies.

11.2 Insurance. The Contractor, at its own expense, shall provide and maintain during the entire period of performance of this Contract, whatever insurance is legally necessary. The **Contractor shall carry the following minimum insurance:**

11.3 Workers' Compensation and Employer's Liability

The Contractor agrees to provide all employees with worker's compensation benefits as required under local laws (see FAR 52.228-4 "Worker's Compensation and War-Hazard Insurance Overseas").

12.0 LOCAL LAW REGISTRATION

If the local law or decree requires that one or both parties to the contract register the contract with the designated authorities to ensure compliance with this law or decree, the entire burden of this registration shall rest upon the Contractor. Any local or other taxes which may be assessed against the Contract shall be payable by the Contractor without Government reimbursement.

13.0 QUALITY ASSURANCE PLAN (QAP).

13.1 Plan. This plan is designed to provide an effective surveillance method to promote effective Contractor performance. The QAP provides a method for the Contracting Officer's Representative (COR) to monitor Contractor performance, advise the Contractor of unsatisfactory performance, and notify the Contracting Officer of continued unsatisfactory performance. The Contractor, not the Government, is responsible for management and quality control to meet the terms of the Contract. The role of the Government is to conduct quality assurance to ensure that Contract standards are achieved.

13.2 Surveillance. The COR will receive and document all complaints from Government personnel regarding the services provided. If appropriate, the COR shall send the complaints to the Contractor for corrective action.

13.3 Standard. The performance standard is that the Government receives no more than two (2) customer complaint per month. The COR shall notify the Contracting Officer of the complaints so that the Contracting Officer may take appropriate action to enforce the inspection clause (FAR 52.212-4, Contract Terms and Conditions-Commercial Items), if any of the services exceed the standard.

13.4. Procedures.

13.4.1 If any Government personnel observe unacceptable services, either incomplete work or required services not being performed, they should immediately contact the COR.

13.4.2 The COR shall complete appropriate documentation to record the complaint.

13.4.3 If the COR determines the complaint is invalid, the COR shall advise the complainant. The COR shall retain the annotated copy of the written complaint for his/her files.

13.4.4 If the COR determines the complaint is valid, the COR shall inform the Contractor and give the Contractor additional time to correct the defect, if additional time is available. The COR shall determine how much time is reasonable.

13.4.5 The COR shall, as a minimum, orally notify the Contractor of any valid complaints.

13.4.6 If the Contractor disagrees with the complaint after investigation of the site and challenges the validity of the complaint, the Contractor shall (in writing) notify the COR. The COR shall review the matter to determine the validity of the complaint.

13.4.7 The COR shall consider complaints as resolved unless notified otherwise by the complainant.

13.4.8. Repeat customer complaints are not permitted for any services. If a repeat customer complaint is received for the same deficiency during the service period, the COR shall contact the Contracting Officer for appropriate action under the Inspection clause.

14. TRANSITIONS/CONTACTS

The Contractor shall submit to the CO no later than 10 days after contract award, a plan to assume all responsibilities for preventive maintenance services. The plan shall establish the projected period for completion of all clearances of contractor personnel, and the projected start date for performance of all services required under this contract. The plan shall assign priority to the selection of all supervisors to be used under the contract.

14.1 Water treatment plant service contractor minimum requirement:

The Contractor must: -

- Have proof of minimum of 5 years' experience in water treatment system maintenance, especially for state or federal facilities.
- Local/ State license/ Certifications; Valid licenses specific to water treatment operations or certified from relevant organizations that is Association of boards of certifications or American water works association that verifies the contractor's capability to operate and maintain water treatment systems.

15. SUBMISSION OF INVOICES

The Contractor shall submit an invoice after each preventive maintenance service has been performed as identified under the CLIN schedule. Invoices must be accompanied by a signed copy of the Maintenance Checklist for the work performed including parts replacement and break down calls, where applicable. No invoice for preventive maintenance services shall be considered for payment unless accompanied by the relevant documentation.

Exhibit A - - STATEMENT OF WORK

I. GENERAL INFORMATION:

The American Embassy in **Nairobi, Kenya** requires preventive maintenance services for Potable water treatment plant. These services shall result in all systems being serviced under this agreement being in good, operational condition when activated.

II. PROJECT REQUIREMENTS:

DESCRIPTION OF EQUIPMENT

Water treatment system has a capacity of producing 175 liters per minute (Lpm) of treated water and be able operate up to 18 hours per day to produce a daily total of up to 189,000 L. The system automatically produces potable water with the largest unit of each process out of service. System includes the following:

1. Two transfer pumps.
2. Three-stage cartridge filters.
3. Granular activated carbon (GAC) filters
4. Calcite adsorption filters
5. Chlorination system and feeds to raw water and potable water recirculation loops.
6. Carbon dioxide feed systems to raw water and potable water recirculation loops
7. Raw and treated water flow meters
8. Control system.
9. System accessories, including water quality and other monitoring instruments, sample taps, spare parts, and tools
10. Testing and monitoring equipment.

III. GENERAL REQUIREMENTS:

The Contractor under this SOW shall be responsible for labor, tools, and materials required to carry out all preventive maintenance as outlined in this SOW. The COR may be in possession of the service manuals and other manufacturer's data including equipment model/make, installation manual, manufacturer's Point of Contact, components specifications, As built drawings, equipment controls data and historical PM records. Such information (once available) will be made available (for viewing under the COR's presence) to the Contractor provided that such information is required for the service required. Hard and/or soft copies will be considered for issue on a case-by-case basis as determined by the COR.

If any discrepancies are found with the system that are not covered under this scope of work, then the contractor must provide the following:

1. Detailed report noting the discrepancy found.
2. Bill of Materials (BOM) to include component name, quantity, part #, and price for any repair material required and material lead time.
3. Price quote for repair labor.

At a minimum, the following preventive maintenance services shall be performed per visit:

SCOPE OF WORK - PREVENTIVE MAINTENANCE

Contractor shall provide all materials, supervision, labor, tools, and equipment to perform preventive maintenance. All personnel working in the vicinity shall wear and /or use safety protection while all work is performed. Any questions or injuries shall be brought to the attention of the Post Occupation Safety and Health Officer (POSHO). Safety Data Sheets (SDS) shall be provided by the Contractor for all HAZMAT materials. Copies will be provided to the COR for approval.

At a minimum, the contractor shall:

I. Potable Water Treatment System

1. Maintenance Description:

- a. On every service visit the contractor shall check and record pressures and chemical levels.
- b. Clean chemical dosing detection probes. Report malfunctioning probes to the COR.

2. Safety and Special Handling Description:

- a. Chemicals must comply with the Environmental Protection Agency (EPA) regulations, ANSI/NSF Standard 60 Certification and be handled in accordance with occupational safety requirements. Employ PPE against injuries caused by corrosive or hazardous treatment chemicals as appropriate.
- b. Be familiar with the Safety Data Sheets (SDS) of any chemicals used in the water treatment program.
- c. Assure that post water treatment specialists/technicians understand the proper operation and maintenance of the equipment and correct any deficiencies found with on-site personnel's familiarizations with equipment.
- d. Water treatment must be based on proven standard engineering practices and post specific water treatment goals.
- e. Follow treatment as directed by manufacturer.
- f. Maintenance includes chemicals, chemical feeding, maintaining proper water conditions, controlling bleed off, protecting idle equipment, and record-keeping.
- g. All tests shall conform to the manufacturer test procedures and standard values.
- h. On every service visit the contractor shall provide service records and test results.

3. Maintenance Procedures:

- a. Check chemical levels in the chemical addition tanks. Adjust chemical level and clean tank if necessary.
- b. Check system for any signs of leakage.
- c. Check all tubing for tightness.
- d. Inspect and clean metering pumps:
 - i. Check the pump diaphragm for damage, clean if needed.
 - ii. Check chemical seepage at vent hole.
 - iii. Check that the discharge tubing is connected firmly to the liquid end.
 - iv. Check that the liquid end is generally watertight (especially vent hole)
 - v. Check for correct feed.
 - vi. Check electrical connections for wear.

4. Clean the sensors (pH, chlorine, as applicable).

- a. Clean filters, flow cell, and fittings.

5. Calibrate the sensors. Report any malfunctioning sensors to the COR.

6. Check chemical addition tanks to ensure no damage or leakage.

7. Test unit safety functions:

- a. Ensure the alarm relay works.
- b. Check the function of the flow sensor and ensure the controller stops.

8. Verify post maintenance records for all components of the water treatment system.
9. Check total and free chlorine and pH in all domestic water tanks.
10. Check backwash filter.
11. Check hardness after Calcite.
12. Check Chlorine after Carbon
13. Flush Calcite and Carbon
14. Check dosage/metering.
15. Adjust dosage/metering.
16. Measure water hardness and adjust system to achieve desired hardness level.
17. Measure water conductivity
18. Measure water pH number
19. Check pressure gauges for proper operation.
20. Check density of brine solution in salt tank
21. Check operation of float control in brine
22. Inspect water treatment piping, fittings, and valves for leaks.
23. Lubricate valves and motors.
24. Inspect Calcite and Carbon base and tank for corrosion.
25. Check operation of automatic fill valve in brine tank
26. Check electrical wiring and phasing.
27. Check cleanliness of all the systems and storage tanks and clean if required.
28. Check control system.
29. Check system functioning.
30. Measure turbidity, free chlorine residual, iron, total dissolved solids (TDS), alkalinity, and temperature of finished water

II. Pumps: Raw and Potable Booster; Raw and Potable Recirculation

1. Safety & Special Instructions:
 - a. Follow site and manufacturer's safety procedures.
 - b. Perform applicable lockout/tag-out steps of site safety procedures.
 - c. Schedule outage with operating personnel.
 - d. Record and report equipment damage or deficiencies.
 - e. Obtain and review manufacturer operation and maintenance instructions.
 - f. All tests shall conform to the manufacturer test procedures and standard values.
2. Maintenance Description:
 - a. Inspect & service the booster pump.
 - b. Inspect & service the motor.
3. Maintenance Procedures:
 1. Lock out and tag out unit.
 2. Clean and inspect pump.
 - a. Clean accumulated dirt and grime from pump casing, shaft coupling, and motor.
 - b. Inspect electrical wiring, motor, and controls for signs of over-heating, broken insulation, loose or corroded connections, or damaged conduit.
 - c. Check for evidence of leaks.
 - d. Check alignment of coupling and security of baseplate mounting bolts.
 3. Lubricate pump (if applicable).
 4. Conduct operational test of the circulating pump.
 - a. Start pump. Check flanges and fittings for leaks.
 - b. Check for unusual noise or vibration.

- c. Return the unit to service.
- 5. Check the motor.
 - a. Inspect electrical wiring, motor, and controls for signs of over-heating, broken insulation, loose or corroded connections, or damaged conduit.
 - b. Check running current and voltage for each phase, record results.
- 6. Lubricate the motor (if applicable). NOTES: Do not over grease the motor or use pump grease.

III. Water Tanks with Controls

Safety & Special Instructions:

1. Perform applicable lockout/tag-out steps of site safety procedures to ensure machinery will not start.
 2. Schedule outage with operating personnel.
 3. Follow site and manufacturer's safety procedures.
 4. Record and report to the post any equipment damage or deficiencies found while performing this maintenance task.
 5. Record all test results in the component maintenance log.
 6. Obtain and review manufacturer operation and maintenance instructions.
 7. All tests shall conform to the manufacturer test procedures and standard values.
- i. Maintenance Description:
 - a. Test operation of sluice gate.
 - b. Operational test of the water tank
 - c. Test operation of controls.
 - ii. Maintenance Procedures:
 1. Examine visible interior of tank including fittings, hatches, ladders, manholes, and hand-holes for signs of corrosion, and correct as indicated.
 2. Clean, test and inspect sight glasses, valves, fittings, drains and controls.
 3. Clean and inspect tank level control panel.
 - a. Clean exterior of panel and inspect front panel components for damage.
 - b. Clean interior panel components of dust and foreign material.
 - c. Inspect electrical wiring for damage and loose connections.
 - d. Inspect relays for damaged contacts and signs of over-heating.
 4. Operational Test panel/electronic control units and mechanical level control equipment.
 - a. Verify that all alarm, control, and communication circuits operate correctly.
 - b. Verify that mechanical level-indicating and control devices are functioning properly.
 5. Look for presence of contamination (bugs, frogs, snakes, paper, plastic, etc.). Notify the post if found.
 6. Tanks should be drained, cleaned, and disinfected as per current U.S. Department of State Guidelines (ALDAC 137958).
 7. Return system to service.

(b) Unless exempted, there is a 2 percent tax of the amount of a specified Federal procurement payment on any foreign person receiving such payment. See 26 U.S.C. 5000C and its implementing regulations at 26 CFR 1.5000C-1 through 1.5000C-7.

(c) Exemptions from withholding under this provision are described at 26 CFR 1.5000C-1(d)(5) through (7).
