

NOTICE OF OPEN CONSULTATION

- The Republic of Madagascar has received a Credit from the International Development Association to finance the Safety Nets and Resilience Project (PFSR) and the Development Intervention Fund (FID) intends to use part of said Financing to make payments under the Contract relating to the rental of a 4x4 car for a supervision mission, FID-interregional direction of Antananarivo.
- The Development Intervention Fund (FID) is requesting closed offers from eligible bidders who meet the qualifications required to carry out the contract.
- The procedure will be conducted by competitive bidding using a Request for Quotation as defined in the "Procurement Regulations for Investment Project Financing – 6th edition February 2025 published by the World Bank", and open to all bidders from eligible countries as defined in the Procurement Rules.
- Interested and eligible bidders may obtain additional information and review the consultation documents at the address mentioned below (9) from 8:30 a.m. to 4:30 p.m.
- The electronic version of the Consultation File in *French* may be requested and/or withdrawn from the FID Office (9) by any interested Bidder by making a written request specifying the reference and subject of this notice and the contact details of the Applicant (Name, Telephone, e-mail, physical address).
- Tenders in sealed envelopes with the reference and title of this file and the words "DO NOT OPEN BEFORE: specify the deadlines for submitting tenders" , must be submitted to the address below (9) no later than May 20, 2025 at TEN O'CLOCK (10:00 a.m.) , local time. Submission of tenders by electronic means will not be authorized. Tenders submitted late will not be accepted.
- Tenders will be opened in the presence of the tenderers' representatives on the same day as the deadline for submitting tenders at TEN O'CLOCK (10:00 a.m.) .
- The offer must include a bid guarantee in the form of a certified bank check or letter of bank guarantee made out to "FID FSR DG", and valid for one hundred and twenty (120) days after the set bid opening date, in the amount of ONE MILLION SIX HUNDRED FIFTY THOUSAND ARIARY (MGA 1,650,000.00)
