The Government of the Republic of Burundi has obtained a Grant from the World Bank to finance the cost of the Integrated Community Development Project in Burundi "PRODECI-TURIKUMWE" and intends to use part of the sums granted under this financing to make the payments planned under the contract for the Electrification Works of the Kibezi, Gakere and Kiremera Centers in Kiremba Commune (Lot 1), the Bartye Center in Butaganzwa Commune, the Ruyigi Vocational Training Center, the Bisinde CDS in Ruyigi Commune and the Gatungurwe CDS in Cankuzo Commune (Lot 2).

1. PRODECI-TURIKUMWE hereby invites Bidders to submit their Offers in sealed envelopes for the Electrification Works of the Kibezi, Gakere and Kiremera Centers in Kiremba Commune (Lot 1), the Bartye Center in Butaganzwa Commune, the Ruyigi Vocational Training Center, the Bisinde CDS in Ruyigi Commune and the Gatungurwe CDS in Cankuzo Commune (Lot 2). 2 separate and indivisible lots as follows:

## - Lot 2.4: Electrification works of the Gatungurwe Health Center (Cankuzo)

The Electrification for each lot includes: the supply of electrical equipment in MT and BT, the treated wooden poles with their stainless steel caps for their head protection, metal poles for supporting the transformers as well as the Construction of the Medium and Low Voltage Lines whose linear lengths are previously specified.

The delivery time of supplies to the respective sites of the market, CIP Bujumbura is set at three (3) calendar months maximum but the bidder can propose a shorter time.

The deadline for execution of the works is set at a maximum of five (5) calendar months, including three (3) months of supplies, but the tenderer may propose a shorter deadline.

The deadline for completion of the work includes rainy periods.

# Candidates may bid on several lots, but the successful bidder may only win one (01) Lot.

- 2. The procedure will be conducted by National Competitive Bidding (NCB) using the World Bank Borrowers' Procurement Regulations dated July 2016, revised in November 2017, August 2018 and November 2020 and is open to all eligible Bidders.
- 3. The gathering will take place at the Chief Town of the Butaganzwa Commune on May 21, 2025 at 11 a.m. local time for lot 1, and at the Chief Town of the Gakere Zone of the Kiremba Commune on May 22, 2025 for lot 2 at 11 a.m. local time.

The visit will be sanctioned by a certificate jointly signed by the representative of the Commune, that of REGIDESO and that of PRODECI/TURIKUMWE.
