**Important conditions and notes:**

- 2- This invitation is not for submitting bids, and it is not required at this stage to submit any work proposals or any price offers. INTERSOS will communicate with suppliers who meet the requirements at this stage to move to the second stage, which is submitting financial offers.
- 3- This invitation to register qualified suppliers does not obligate the organization to issue any tenders or issue any contracts to companies/suppliers who expressed their desire through the application.
- 4- Any supplier wishing to register and fill out the registration application form pledges that all information provided is up-to-date and accurate and free of any ambiguity or misleading, and agrees to allow the organization to disclose and verify the information from any party, at any time and for any purpose.
- 5- The supplier's filling in the registration data does not mean that the organization provides a guarantee or undertakes any obligations towards the supplier.
- 6- Each applicant has the right to qualify the application in more than one category, provided that previous similar contracts with other organizations are attached, at least 3 contracts for the same category.
- 7- The organization has the right to request any other documents or data if necessary.
- 8- The evaluation will be conducted according to the organization determined by the INTERSOS management.
