1. The Government of Madagascar has received financing from the World Bank for the implementation of the Safety Nets and Resilience Project (PFSR), and intends to use part of said financing to make payments under the Contract relating to:
The acquisition and delivery of teaching supplies for the implementation of literacy at the office of the inter-regional management of FID FORT DAUPHIN
2. The Development Intervention Fund (FID) is requesting closed offers from eligible bidders who meet the qualifications required to carry out the contract.
3. The procedure will be conducted by competitive bidding using a Request for Quotation as defined in the "Procurement Regulations for the Financing of Investment Projects – 6th edition February 2025 published by the World Bank", and open to all bidders from eligible countries as defined in the Procurement Rules.
4. Interested and eligible bidders may obtain additional information and review the consultation documents at the address mentioned below (9) from 8:30 a.m. to 4:30 p.m.
5. The electronic version of the Consultation File in French may be requested and/or withdrawn from the address (9) by any interested Bidder by making a written request specifying the reference and subject of this notice and the contact details of the Applicant (Name, Telephone, e-mail, physical address).
6. Tenders in sealed envelopes with the reference of this file and the mention "DO NOT OPEN BEFORE: JUNE 3, 2025" must be submitted to the address below (9) no later than **June 3, 2025 at TEN A.M. (10:00 a.m.)**, local time. Submission of tenders by electronic means will not be authorized. Late tenders will not be accepted.
Tenders will be opened in the presence of the tenderers' representatives on the same day as the deadline set for submission of tenders at ten a.m. (10:00 a.m.).

The offer must include a bid guarantee in the form of a certified bank check or letter of bank guarantee made out to "FONDS D'INTERVENTION POUR LE DEVELOPPEMENT", and valid for one hundred and twenty (120) days after the set bid opening date: **TWO MILLION FIVE HUNDRED THOUSAND ARIARY (MGA 2,500,000)**.
