TENDER TITLE: DESIGN, SUPPLY, INSTALLATION AND COMMISSIONING OF DIMAJWE WATER TREATMENT PLANT AND ASSOCIATED WORKS

PROCURING ENTITY: Water Utilities Corporation

1. Sealed Tender offers are invited for the Works Contract for Design, Supply, Installation and Commissioning of Dimajwe Water Treatment Plant And Associated Works

2. The Works Contract will include the following:

- Design, Supply, and Install a Water Treatment Plant with a nominal capacity of 400 m³ /day (0.4ML/D) to produce potable water compliant with BOS 32: 2015 requirements. The plant should have 95% water recovery from the raw borehole water.
- Borehole Test pumping, Camera Surveying and Equipping (BH6635).
- Design Supply, and Installation of a Glass Reinforced Plastic (GRP) or equivalent Raw Water Collector Tank.
- Design Supply, and Installation of a Galvanised Steel (GS) Panel Clear/Treated Water Collector Tank.
- Design Supply and Construction of appropriately sized evaporation ponds compliant with environmental requirements.
- Design, Construct, Supply, and Installation of a Clear/Treated Water Booster Pumpstation to the Village Elevated Tank.
- Design and Construct of a pumping main pipeline from the Treatment Plant to Village Supply Tanks including Treatment plant-bypass.
- Design and install and commission Telemetry to monitor and control the entire scheme.
- Testing and Commission the Dimajwe Scheme.

3. Procurement Method is: **OPEN DOMESTIC BIDDING**

4. Tenderers must, in order to be considered for the award of the contract, be registered with the Public Procurement Regulatory Authority (PPRA) in the following categories:

Code 05: Water and Sewage Treatment Plant Works

Sub-Code 01: Water and Sewage Treatment Plants, Grade D.

In addition, the main Contractor's, JV partners or his sub-contractors shall possess the following codes.

Code 02: Electrical Engineering Works, Grade D

Sub-Code 01: Electrical Installations and

Sub-Code 08 Radio/Telemetry, Grade D

5. This tender is reserved for 100% Citizen Contractors in line with Section 76 of the Public Procurement Act.

6. Preference Margins will be applied to qualifying bidders in line with the following schemes: Economic Diversification Drive (EDD) for Design Consultants.

7. Tenderers to purchase all their products from 100% Citizen locally based manufacturers and service providers, provided that the goods and services are locally available, competitively priced and meet tender specifications in terms of quality standard as certified or recognized by Botswana Bureau of Standards (BOBS) or other recognized certifying bodies.

8. Tender documents shall be obtained by visiting web address <https://www.wuc.bw/wuc-tenders-new>. Online documents will be available for purchase from **26th April 2024**. Bidders are to process payment on the website.

9. A non-refundable deposit of **P2,000.00** payable to Water Utilities Corporation. Youth (18-35) owned companies shall pay half price.

10. Queries relating to this tender should be addressed to the Senior Manager Supply Chain at procurement@wuc.bw and should reach the office not later than ten (10) days before the tender closing date.

11. A compulsory Site visit meeting with representatives of the Procuring Entity will take place on the **7th May 2024 at 10:00hrs**. The assembly point shall be at **Dimajwe Village Main Kgotla** where the site visit to Dimajwe Water Treatment Plant will commence. (Tenderers should arrive at or before **10:00 hrs.**)

12. The closing date and time for receipt of sealed tender offers is **14:00hrs on 6th June 2024**.

11. Late tender offers will not be accepted.

12. The tender Evaluation will follow Least Cost Selection Evaluation Procedure.

13. The Bid Submission Method is: **One Envelope Submission Method in which a tenderers financial and technical offer is submitted together in one sealed envelope.**
