Main activity of the contracting authority : General services of public administration.

The procurement procedure in this notice is covered by the WTO Government Procurement Agreement.

Main characteristics: the purpose of the consultation is to provide development services for the perimeter firewalls of Brest mainland and the city of Brest, including supply, installation and on-site maintenance.

The consultation is carried out as part of the permanent grouping of orders linked to recurring needs. This contract concerns the following entities: Brest Métropole and the City of Brest.

Negotiation phase planned, but possibility of awarding the contract solely on the basis of initial offers.

Variations are allowed.

A site visit is obligatory under the conditions set out in article 4.7 of the consultation regulations.

Services divided into lots: no.

Essential financing and payment modalities and/or references to the texts which regulate them: financing in accordance with the rules of public accounting, from own funds.

Payment method chosen: transfer with payment within 30 clear days. Online billing will be accepted. Prices are subject to review.

Deposit and guarantees required: not applicable.

Legal form that the group of economic operators awarded the contract must take: the contract may be awarded to a single company or to a group of companies. If the contract is awarded to a joint group, the joint agent will be responsible for each of the members of the group.

The execution of the contract is subject to other specific conditions: no.

Conditions of participation:

Candidate selection criteria: sworn declaration to justify that the candidate does not fall into any of the cases of mandatory ban on bidding provided for in articles L.2141-1 to L.2141-5 and L. 2141-7 to L.2141-11 of the Public Procurement Code.

- technical value (60%),

- price of services (40%).
