A letter addressed to Practical Action Organization from the party submitting the bid, containing (confirmation of the type and quantities of the required /8 service/the total amount of the bid including the added value/the time set for completing the provision of the service on site/the name, address, telephone .number and signature of the person authorized by the party submitting the bid)

The above documents shall be submitted in a sealed envelope with red wax and marked (Attached sticker - this information and must be affixed to the /9 .tender envelope). Tender number/tender name/tenderer's name, address and telephone numbers

.Each envelope must contain only one bid, meaning that more than one bid may not be submitted in one envelope /10

Those wishing to submit must separate the financial offer from the technical offer, as there are two different committees for financial evaluation and /11 .another separate committee for technical evaluation

.Documents submitted for the tender will not be returned / 12

.Any applicant who does not meet the above requirements will be excluded from the competition / 13
