 - 2) Earnest Money has to be deposited by the bidder through online payment mode as per Memorandum of Finance Department vide No. 3975-F(Y) dated 28th July, 2016.
 - i) Net banking (any of the banks listed in the ICICI Bank Payment gateway) in case of payment through ICICI bank payment gateway.
 - ii) RTGS/NEFT in case of offline payment through bank account in any bank.
 - The L_1 bidder shall submit the hard copy of the documents to the tender inviting authority with this acceptance letter. Failure to submit the hard copy with the acceptance letter within the time period prescribed for the purpose may be construed as an attempt to disturb the tendering process and dealt with accordingly legally including blacklisting of the bidder as per G.O.NO.2254-F(Y) dt.24.04.2014.
- 3) Pre-qualification, Technical & Financial Bid is to be submitted concurrently duly digitally signed at desired documents in the Website www.wbtenders.gov.in. Tender document may be downloaded from website & submission of Pre-qualification Bid/ Technical Bid/ Financial Bid is to follow the stipulated date & time Schedule (Clause-33).
 - The documents submitted by the Bidders should be properly indexed & notarized with seal.

- 5) <u>Time of Completion</u>: Stated above in the list of works.
- 6) <u>Eligibility for participating in the Tender</u>: Permission of participating in the tender will be given only to those fulfilling the following eligibility criteria.
- a) Working Status:- Intending tenderers should produce credentials of a similar nature of work of the minimum value of 20% of the quoted amount put to tender during 5(five) years prior to the date of issue of this tender notice; or,
 - Intending tenderers should produce credentials of one single running work of similar nature which has been completed to the extent of 70% or more and value of which is not less than the desired value at above.
 - Intending tenderers must produce completion certificate of physically completed work(s) as per above eligibility within the qualifying period i.e. during last 5 (five) financial years and current financial year as on the date of application. In case of running works; only those tenderers who will submit the certificate of satisfactory running work from the concerned Executive Engineer, or equivalent competent authority will be eligible for the tender. In the required certificate it should be clearly stated that the work is in progress satisfactorily and also that no penal action has been initiated against the executed agency, i.e., the tenderer. (Copy of completion/satisfactory completion certificate to be uploaded)

If any intending bidder is undergoing FHTC (Flagship) works, reasonable progress is mandatory. Any adverse correspondence in case of FHTC works automatically negates the bidder.

Similar nature of works means Construction of R.C.C. - Average annual financial turn-over during the last 3(three) previous financial year, should be at least 30% of the Tender value in addition to Acceptance / Formal Work Order issued under this Division but work has not yet been completed so far as per balance sheet {in case of above 1 (one) crore audited balance sheet} must be submitted.

The credential papers issued by Local Bodies / Block Level Authority / PSU or Private Bodies will not be entertained in this regard in normal course & it is the wholesole authority of the tender inviting authority to consider the bidders claim for participation in special circumstances. Also the intending bidder should not have any adverse credential in mal handling of tools & plants installed of PHE premises. The experience and timely completion certificate of works is to be issued by an officer not below the rank of Executive Engineer or equivalent concerned. Payment Certificate will not be treated as credential. All document attached shall be stamped and signed by a Notary. Original certificate / order copies / other document as required shall have to be produced on demand during evaluation.
- n) The intending bidder must be having minimum knowledge of PHED T & P and might be required to co-ordinate with the manufacturer & mechanical wing of PHE Dte. Any sort of deviation from time may have automatic implication of IPC / CRPC as application.
- o) Tender inviting authority may go for verification of credential by the credential issuing authority. The necessary mode of communication will be e-mode of communication. If the undersigned does not get any suitable reply within 07 (Seven) days, the acceptance and rejection of bid might be done as per discretion of tender inviting authority.
- p) Moreover, the tender inviting authority reserves the right to relax the eligibility criteria, except Sl. No. (c), of the applicant in respect of any of the technical or financial requirements, if it is deemed to be necessary for fair & competitive tender without assigning any reason whatsoever.
- q) The application of the intending tenderer who is already working in PHE Dte. and whose performance, if found unsatisfactory and/or clause-2 or 3 of tender agreement imposed upon him any division within Western Circle, P.H.E Dte. will not be entertained.
- r) The Tender Inviting Authority has got every right to reject the bid who has failed to comply labour wages & case was reported to the principal employer subsequently. The intending bidder who has received 02 (two) numbers of subsequent communication regarding imposition of Clause 2, may automatically be rejected / disqualified if not reasonable satisfactory explanation is received. If any intending bidder has a history of intentional refusal of departmental correspondence in postal / currier mode might be disqualified in the tendering process. Ambiguous / fictitious address & email ID in erstwhile executions may automatically disqualify the intending bidder.
 - Any statutory dues (attachable / non-attachable) may lead the Tender Inviting Authority to disqualify or qualify as per its own discretion. In this regard Tender Inviting Authority might ask for clearance of all outstanding dues prior to issuance of subsequent correspondence.
- 7) The intending tenderer fulfilling the above requirement should bid for the work included in the Bid notice with all related evidentiary particulars documents only. However any extra non related document beyond demand uploaded the authority reserves the rights to reject their bid without assigning any reason.
 - The tender inviting authority reserves the rights to accept or reject their offered bid. as deemed necessary to finalize the tenders satisfactorily without assigning any reason whatsoever.
- 8) Selection of eligible agency will be made strictly on the basis of scrutiny and evaluation of the particular as to be furnished at the time of bidding. Decision of the tender inviting authority in this regard shall be final & binding.
- 9) The tendering operation will follow e-tendering process and all rules and regulation pertaining to the tender will be binding to the tenderers.

- 15) The rate is to be quoted both in words and figures in the financial bid and rates quoted should be considered inclusive of all taxes and charges as applicable & payable.
- 16) Before Biding, the Bidder(s) may visit the site to satisfy themselves about the local condition & other matters at their own cost. No claim whatsoever on the ground of insufficient knowledge about the work site or local condition will be entertained at a later date and no claim in future will be entertained.
- 17) Signatory, who will sign on tender document on behalf of a company or firm must produce the registered document in respect of their competence to do so, failing which the tender will not be considered.

SECTION-A

1. General guidance for e-Tendering

Instructions / Guidelines for tenderers for electronic submission of the tenders online have been annexed for assisting the contractors to participate in e-Tendering.

2. Registration of Contractor

Any contractor willing to take part in the process of e-Tendering will have to be enrolled & registered with the Government e-Procurement system, through logging on to www.wbtenders.gov.in. The contractor is to click on the link for e-Tendering site as given on the web portal.

- 3. Declaration: (a) Self Declaration of bidder not having common interest in any other work floated in different serials of that particulars tender vide Form-VI, Self declaration of antecedents and performance of bidder in Form-V are to be uploaded during bid submission in prequalification proposal.
 - (b) Additional performance Security Bank Guarantee of 10% of the amount put to tender if bid price is lower than 20% of the amount put to tender in Specimen Format (Annexure-II) are to be uploaded during bid submission in financial proposal.

4. Digital Signature Certificate (DSC):

Each contractor is required to obtain a Class-II or Class-III & Working under PHE Dte. Digital Signature Certificate (DSC) for submission of tenders, from the approved service provider of the National Information's Centre (NIC) on payment of requisite amount details of which are available at the Web Site stated in Clause 2. DSC is given as a USB e-Token.

- iii) Pursuant to the scrutiny and decision of the Tender Inviting Authority the summary list of Pre-qualified tenderers will be uploaded in the Web portal.
- iv) While evaluating, the tender inviting authority may summon the tenderers & seek clarification /information or additional documents or original hard copy of any of the documents already submitted & if these are not produced within the stipulated time frame, their proposal will be liable for rejection.

6.2. Opening of technical proposal:

- i. Technical proposals will be opened by the Executive Engineer, Midnapore Division, PHE Directorate or his authorized representative electronically from the web site stated in Cl. No. 2 using their Digital Signature Certificate.
- ii. Intending tenderers may remain present if they so desire.
- iii. Statutory documents will be opened first & if found in order, non statutory documents will be further opened. If there is any deficiency in such documents the tender will summarily be rejected.
- iv. Pursuant to scrutiny & decision of the Tender Evaluation committee the summary list of eligible tenderers will be uploaded in the web portals.
