- 6. The bidder will not be allowed to further sub-contract any part of the work allotted to him.
- 7. The bidder should take all precautionary measures for their staff, labour, equipment etc. deployed for conducting the work.
- 8. The rates quoted should be including all taxes but excluding GST. The GST shall be reimbursed on production of proof of payment / voucher / challan. The bidder shall submit a copy of their GST Number certificate along with the quotation document.
- 9. Time is the essence of the contract, no time extension shall be granted for delay due to the reason(s) attributable to the bidder, RITES Limited shall be free to charge liquidated damages @ 1% per week of delay or part thereof for the entire work subject to maximum of 10% of the award value of the work order.
- 10. RITES shall deduct taxes as per statutory provisions as applicable.
- 11. All works shall be done to the desired accuracy and standard as per governing specifications and sound professional practices for geotechnical investigations.
- 12. The necessary jungle clearance and approach etc. for proper execution of the work, wherever required shall have to be done by the bidder at no extra cost.

14. 'Force Majeure'

'Force Majeure' as embodied in this contract shall mean, war declared or undeclared, civil war, forest fire, major flood and earthquake, subject as elsewhere herein or in the contract documents expressly provided. Only the existence of 'force majeure' circumstances as defined in this clause hereof shall afford the bidder a ground for extension of time for or any operation(s) involved therein, and specifically inclement or unforeseen weather, strike, shut-down, third party breach, delay in payment or commercial hardship shall not afford the bidder a ground for extension of time or relieve the bidder of his/her obligations under the contract, nor will any shut-down or late time charges be payable by the client to the bidder for any delay in the commencement, progress or completion of the work due to any reason whatsoever, inclusive due to the existence of force majeure circumstances.

As soon as the cause of Force Majeure is removed, the party, whose ability to perform its obligations has been affected, shall notify the other of such cessation and of the actual delay incurred in such affected activity adducing necessary evidence in support thereof. From the dates of occurrence of a case of Force Majeure, obligations of the party affected shall be suspended during the continuance of any inability so caused until the cause itself and the inability resulting there from have been removed and the agreed time of completion of the respective obligations under this contract shall stand extended by a period equal to the period of delay occasioned by such events.

Should one or both parties be prevented from fulfilling the contractual obligations by a state of Force Majeure lasting for a period of six months or more, the two parties shall consult each other and decide regarding the future execution of this contract.

15. MANDATE FORM

16. SECURITY DEPOSIT

16.1 At the time of making payments for each stage to the consultant, a deduction@ 5% shall be made from the gross amount towards security deposit.

16.2 On expiry of six months from the date of completion of Geotechnical Investigation work and submission of Report i/c all connected drawings/charts and related documents as per scope of work to the entire satisfaction of Engineer-in-charge, the Engineer-in-charge shall, on demand from consultant, refund to him the security deposit.

Scope of Work and Technical Specifications for Geo-technical investigations: -

1. Field Work:-

The geo-technical investigation for selected site is required to be carried out as per the relevant BIS codes/ IS Codes and the report should also suggest the treatment required for the same, if any. The Soil Investigation shall include technical report for Geo-Technical Investigation for the subject work site and shall include the following:-

a) Number of Exploratory bore holes Dia 150mm – Total 49 Nos.

• Boreholes at locations shown in Layout Plan down to maximum depth of 6m or up to refusal whichever is met earlier in all type of soil including conducting SPT as per IS: 2131 within the borehole as per specification at every 1.5 m interval or at change of strata whichever is earlier. The work should include Collection of undisturbed soil samples (At least 3 Samples) and balance Disturbed Soil Samples from each bore at 1.5 m interval or at change of strata whichever is earlier.

• Laboratory Test:-

- j) If any Rock found on site, Laboratory test on rock samples collected from bore holes are:-
 - > Density
 - Specific gravity
 - Water absorption
 - Uniaxial compressive strength
- b) CBR Test (4 days soaked) with heavy compaction at OMC and MDD as per IS 2720 part-16 = Total 12 Nos
 - Excavation of Trial pits upto 3 m depth in soil for collection of samples for CBR and carrying out CBR test (4 days soaked) with heavy compaction, alongwith atterberg limits, grain size analysis and Natural moisture content & natural dry density.
- c) Modulus of Subgrade Reaction Test (As per IS 9214) Total 8 Nos
 - Loading platform truss of sufficient size and properly designed members so as to estimate load reaction Tor conducting the test shall be used. Hydraulic jack of required capacity with properly calibrated load measuring device, such as pressure gauge, electronic load cell, or proving, ring shall be used. Circular or square bearing plates of mild steel, not less
