## Section 2. Instruction to Bidders

GENERAL PROVISIONS	
1. <i>Introduction</i>	<p>1.1 Bidders shall adhere to all the requirements of this RFP, including any amendments in Writing by ISA.</p> <p>1.2 Any Proposal submitted will be regarded as an offer by the Bidder and does not constitute or imply the acceptance of the Proposal by ISA. ISA is under no obligation to award a contract to any Bidder as a result of this RFP.</p>
2. <i>Fraud &amp; Corruption, Gifts and Hospitality</i>	<p>2.1 ISA strictly enforces a policy of zero tolerance on proscribed practices, including fraud, corruption, collusion, unethical or unprofessional practices, and obstruction of ISA vendors and requires all bidders/vendors observe the highest standard of ethics during the procurement process and contract implementation.</p> <p>2.2 Bidders/vendors shall not offer gifts or hospitality of any kind to ISA staff members including recreational trips to sporting or cultural events, theme parks or offers of holidays, transportation, or invitations to extravagant lunches or dinners.</p> <p>2.3 In pursuance of this policy, ISA  (a) Shall reject a proposal if it determines that the selected bidder has engaged in any corrupt or fraudulent practices in competing for the contract in question;  (b) Shall declare a vendor ineligible, either indefinitely or for a stated period of time, to be awarded a contract if at any time it determines that the vendor has engaged in any corrupt or fraudulent practices in competing for, or in executing a ISA contract.</p> <p>2.4 All Bidders must adhere to the ISA Supplier Code of Conduct, which may be found at <a href="#">ISA Supplier Code of Conducts.pdf</a></p>
3. <i>Eligibility</i>	<p>3.1 A vendor should not be suspended, debarred, or otherwise identified as ineligible by any UN Organization or the World Bank Group or any other international Organization. Vendors are therefore required to disclose to ISA whether they are subject to any sanction or temporary suspension imposed by these organizations.</p> <p>3.2 It is the Bidder's responsibility to ensure that its employees, joint venture members, sub-contractors, service providers, suppliers and/or their employees meet the eligibility requirements as established by ISA.</p>
4. <i>Conflict of Interests</i>	<p>4.1 Bidders must strictly avoid conflicts with other assignments or their own interests, and act without consideration for future work. Bidders found to have a conflict of interest shall be disqualified. Without limitation on the generality of the above, Bidders, and any of their affiliates, shall be considered to have a conflict of interest with one or more parties in this solicitation process, if they:</p>

	<ul style="list-style-type: none"> <li>a) Are or have been associated in the past, with a firm or any of its affiliates which have been engaged by ISA to provide services for the preparation of the design, specifications, Terms of Reference, cost analysis/estimation, and other documents to be used for the procurement of the goods and services in this selection process;</li> <li>b) Were involved in the preparation and/or design of the programme/project related to the services requested under this RFP; or</li> <li>c) Are found to be in conflict for any other reason, as may be established by, or at the discretion of ISA.</li> </ul> <p>4.2 In the event of any uncertainty in the interpretation of a potential conflict of interest, Bidders must disclose to ISA, and seek ISA's confirmation on whether or not such a conflict exists. The ISA shall have the discretion to disqualify or proceed with a bidder where there is a probable conflict of interest subject to further evaluation and review of various factors such as access to sensitive information which may confer unfair advantage as against other bidders. The decision on a probable conflict of interest shall be made in the best interest of the work of the ISA.</p> <p>4.3 Similarly, the Bidders must disclose in their proposal their knowledge of the following:</p> <ul style="list-style-type: none"> <li>a) If the owners, part-owners, officers, directors, controlling shareholders, of the bidding entity or key personnel are family members of ISA staff involved in the procurement functions and/or the Government of the country or any Implementing Partner receiving services under this RFP; and</li> <li>b) All other circumstances that could potentially lead to actual or perceived conflict of interest, collusion or unfair competition practices.</li> </ul> <p>Failure to disclose such an information may result in the rejection of the proposal or proposals affected by the non-disclosure.</p> <p>4.4 The eligibility of Bidders that are wholly or partly owned by the Government shall be subject to ISA's further evaluation and review of various factors such as being registered, operated and managed as an independent business entity, the extent of Government ownership/share, receipt of subsidies, mandate and access to information in relation to this RFP, among others. Conditions that may lead to undue advantage against other Bidders may result in the eventual rejection of the Proposal.</p>
<b>PREPARATION OF PROPOSALS</b>	
5. <i>General Considerations</i>	<p>5.1 In preparing the Proposal, the Bidder is expected to examine the RFP in detail. Material deficiencies in providing the information requested in the RFP may result in rejection of the Proposal.</p> <p>5.2 The Bidder will not be permitted to take advantage of any errors or omissions in the RFP. Should such errors or omissions be discovered, the Bidder must notify the ISA</p>
6. <i>Cost of Preparation</i>	6.1 The Bidder shall bear any and all costs related to the preparation and/or

<i>of Proposal</i>	submission of the Proposal, regardless of whether its Proposal was selected or not. ISA shall not be responsible or liable for those costs, regardless of the conduct or outcome of the procurement process.
<i>7. Language</i>	7.1 The Proposal, as well as any and all related correspondence exchanged by the Bidder and ISA, shall be Written in the language (s) specified in the BDS.
<i>8. Documents Comprising the Proposal</i>	8.1 The Proposal shall comprise of the following documents: c) Documents Establishing the Eligibility and Qualifications of the Bidder; d) Technical Proposal; e) Financial Proposal; f) Proposal Security, if required by BDS; g) Any attachments and/or appendices to the Proposal.
<i>9. Documents Establishing the Eligibility and Qualifications of the Bidder</i>	9.1 The Bidder shall furnish documentary evidence of its status as an eligible and qualified vendor, using the Forms provided under Section 6 and providing documents required in those forms. In order to award a contract to a Bidder, its qualifications must be documented to ISA's satisfaction.
<i>10. Technical Proposal Format and Content</i>	10.1 The Bidder is required to submit a Technical Proposal using the Standard Forms and templates provided in Section 6 of the RFP. 10.2 The Technical Proposal shall not include any price or financial information. A Technical Proposal containing material financial information may be declared non-responsive. 10.3 Samples of items, when required as per Section 5, shall be provided within the time specified and unless otherwise specified by ISA, and at no expense to ISA 10.4 When applicable and required as per Section 5, the Bidder shall describe the necessary training programme available for the maintenance and operation of the services and/or equipment offered as well as the cost to the ISA. Unless otherwise specified, such training as well as training materials shall be provided in the language of the Bid as specified in the BDS.
<i>11. Financial Proposals</i>	11.1 The Financial Proposal shall be prepared using the Standard Form provided in Section 6 of the RFP. It shall list all major cost components associated with the services, and the detailed breakdown of such costs. 11.2 Any output and activities described in the Technical Proposal but not priced in the Financial Proposal, shall be assumed to be included in the prices of other activities or items, as well as in the final total price. 11.3 Prices and other financial information must not be disclosed in any other place except in the financial proposal.
<i>12. Proposal Security</i>	12.1 A Proposal Security, if required by BDS, shall be provided in the amount and form indicated in the BDS. The Proposal Security shall be valid up to thirty

	<p>(30) days after the final date of validity of the Proposal.</p> <p>12.2 The Proposal Security shall be included along with the Technical Proposal. If Proposal Security is required by the RFP but is not found along with the Technical Proposal, the Proposal shall be rejected.</p> <p>12.3 If the Proposal Security amount or its validity period is found to be less than what is required by ISA, ISA shall reject the Proposal.</p> <p>12.4 In the event an electronic submission is allowed in the BDS, Bidders shall include a copy of the Bid Security in their proposal and the original of the Proposal Security must be sent via courier or hand delivery as per the instructions in BDS.</p> <p>12.5 The Proposal Security may be forfeited by ISA, and the Proposal rejected, in the event of any one or combination, of the following conditions:</p> <ul style="list-style-type: none"> <li>a) If the Bidder withdraws its offer during the period of the Proposal Validity specified in the BDS, or;</li> <li>b) In the event that the successful Bidder fails: <ul style="list-style-type: none"> <li>i. to sign the Contract after ISA has issued an award; or</li> <li>ii. to furnish the Performance Security, insurances, or other documents that ISA may require as a condition precedent to the effectivity of the contract that may be awarded to the Bidder.</li> </ul> </li> </ul>
<i>13. Currencies</i>	<p>13.1 All prices shall be quoted in the currency or currencies indicated in the BDS. Where Proposals are quoted in different currencies, for the purposes of comparison of all Proposals:</p> <ul style="list-style-type: none"> <li>a) ISA will convert the currency quoted in the Proposal into the ISA preferred currency, in accordance with the prevailing UN operational rate of exchange on the last day of submission of Proposals; and</li> <li>b) In the event that ISA selects a proposal for award that is quoted in a currency different from the preferred currency in the BDS, ISA shall reserve the right to award the contract in the currency of ISA's preference, using the conversion method specified above.</li> </ul>
<i>14. Joint Venture, Consortium or Association</i>	<p>14.1 If the Bidder is a group of legal entities that will form or have formed a Joint Venture (JV), Consortium or Association for the Proposal, they shall confirm in their Proposal that : (i) they have designated one party to act as a lead entity, duly vested with authority to legally bind the members of the JV, Consortium or Association jointly and severally, which shall be evidenced by a duly notarized Agreement among the legal entities, and submitted with the Proposal; and (ii) if they are awarded the contract, the contract shall be entered into, by and between ISA and the designated lead entity, who shall be acting for and on behalf of all the member entities comprising the joint venture.</p> <p>14.2 After the Deadline for Submission of Proposal, the lead entity identified to represent the JV, Consortium or Association shall not be altered without the prior written consent of ISA.</p>

	<p>14.3 The lead entity and the member entities of the JV, Consortium or Association shall abide by the provisions of Clause 15 herein in respect of submitting only one proposal.</p> <p>14.4 The description of the organization of the JV, Consortium or Association must clearly define the expected role of each of the entity in the joint venture in delivering the requirements of the RFP, both in the Proposal and the JV, Consortium or Association Agreement. All entities that comprise the JV, Consortium or Association shall be subject to the eligibility and qualification assessment by ISA.</p> <p>14.5 A JV, Consortium or Association in presenting its track record and experience should clearly differentiate between:</p> <ul style="list-style-type: none"> <li>a) Those that were undertaken together by the JV, Consortium or Association; and</li> <li>b) Those that were undertaken by the individual entities of the JV, Consortium or Association.</li> </ul> <p>14.6 Previous contracts completed by individual experts working privately but who are permanently or were temporarily associated with any of the member firms cannot be claimed as the experience of the JV, Consortium or Association or those of its members, but should only be claimed by the individual experts themselves in their presentation of their individual credentials.</p> <p>JV, Consortium or Associations are encouraged for high value, multi-sectoral requirements when the spectrum of expertise and resources required may not be available within one firm.</p>
<i>15. Only One Proposal</i>	<p>15.1 The Bidder (including the individual members of any Joint Venture) shall submit only one Proposal, either in its own name or as part of a Joint Venture.</p> <p>15.2 Proposals submitted by two (2) or more Bidders shall all be rejected if they are found to have any of the following:</p> <ul style="list-style-type: none"> <li>h) they have at least one controlling partner, director or shareholder in common; or</li> <li>i) any one of them receive or have received any direct or indirect subsidy from the other/s; or</li> <li>j) they have the same legal representative for purposes of this RFP; or</li> <li>k) they have a relationship with each other, directly or through common third parties, that puts them in a position to have access to information about, or influence on the Proposal of, another Bidder regarding this RFP process;</li> <li>l) they are subcontractors to each other's Proposal, or a subcontractor to one Proposal also submits another Proposal under its name as lead Bidder; or</li> <li>m) some key personnel proposed to be in the team of one Bidder participates in more than one Proposal received for this RFP process.</li> </ul>



	This condition relating to the personnel, does not apply to subcontractors being included in more than one Proposal.
<i>16.Proposal Validity Period</i>	<p>16.1 Proposals shall remain valid for the period specified in the BDS, commencing on the Deadline for Submission of Proposals. A Proposal valid for a shorter period may be rejected by ISA and rendered non-responsive.</p> <p>16.2 During the Proposal validity period, the Bidder shall maintain its original Proposal without any change, including the availability of the Key Personnel, the proposed rates and the total price.</p>
<i>17.Extension of Proposal Validity Period</i>	<p>17.1 In exceptional circumstances, prior to the expiration of the proposal validity period, ISA may request Bidders to extend the period of validity of their Proposals. The request and the responses shall be made in writing, and shall be considered integral to the Proposal.</p> <p>17.2 If the Bidder agrees to extend the validity of its Proposal, it shall be done without any change in the original Proposal.</p> <p>17.3 The Bidder has the right to refuse to extend the validity of its Proposal, and in which case, such Proposal will not be further evaluated.</p>
<i>18.Clarification of Proposal</i>	<p>18.1 Bidders may request clarifications on any of the RFP documents no later than the date indicated in the BDS. Any request for clarification must be sent in writing in the manner indicated in the BDS. If inquiries are sent other than specified channel, even if they are sent to an ISA staff member, ISA shall have no obligation to respond or confirm that the query was officially received.</p> <p>18.2 ISA will provide the responses to clarifications through the method specified in the BDS.</p> <p>18.3 ISA shall endeavor to provide responses to clarifications in an expeditious manner, but any delay in such response shall not cause an obligation on the part of ISA to extend the submission date of the Proposals, unless ISA deems that such an extension is justified and necessary.</p>
<i>19.Amendment of Proposals</i>	<p>19.1 At any time prior to the deadline of Proposal submission, ISA may for any reason, such as in response to a clarification requested by a Bidder, modify the RFP in the form of an amendment to the RFP. Amendments will be made available to all prospective bidders.</p> <p>19.2 If the amendment is substantial, ISA may extend the Deadline for submission of proposal to give the Bidders reasonable time to incorporate the amendment into their Proposals.</p>
<i>20.Alternative Proposals</i>	<p>20.1 Unless otherwise specified in the BDS, alternative proposals shall not be considered. If submission of alternative proposal is allowed by BDS, a Bidder may submit an alternative proposal, but only if it also submits a proposal conforming to the RFP requirements. ISA shall only consider the alternative proposal offered by the Bidder whose conforming proposal ranked the highest as per the specified evaluation method. Where the</p>

	<p>conditions for its acceptance are met, or justifications are clearly established, ISA reserves the right to award a contract based on an alternative proposal.</p> <p>20.2 If multiple/alternative proposals are being submitted, they must be clearly marked as “Main Proposal” and “Alternative Proposal”</p>
<i>21.Pre-Bid Conference</i>	<p>21.1 When appropriate, a Bidder’s conference will be conducted at the date, time and location specified in the BDS. All Bidders are encouraged to attend. Non-attendance, however, shall not result in disqualification of an interested Bidder. Minutes of the Bidder’s conference will be sent to all the participants of the pre-bid conference. No verbal statement made during the conference shall modify the terms and conditions of the RFP, unless specifically incorporated in the Minutes of the Bidder’s Conference or issued/posted as an amendment to RFP.</p>
<b>SUBMISSION AND OPENING OF PROPOSALS</b>	
<i>22.Submission</i>	<p>22.1 The Bidder shall submit a duly signed and complete Proposal comprising the documents and forms in accordance with the requirements in the BDS. The submission shall be in the manner specified in the BDS.</p> <p>22.2 The Proposal shall be signed by the Bidder or person(s) duly authorized to commit the Bidder. The authorization shall be communicated through a document evidencing such authorization issued by the legal representative of the bidding entity, or a Power of Attorney, accompanying the Proposal.</p> <p>22.3 Bidders must be aware that the mere act of submission of a Proposal, in and of itself, implies that the Bidder fully accepts the ISA General Contract Terms and Conditions. <a href="#">ISA GTBs.pdf</a></p>
<i>Email Submission</i>	<p>22.4 Email submission, if allowed or specified in the BDS, shall be governed as follows:</p> <ul style="list-style-type: none"> <li>a) Electronic files that form part of the proposal must be in accordance with the format and requirements indicated in BDS;</li> <li>b) The Technical Proposal and the Financial Proposal files MUST BE COMPLETELY SEPARATE. The financial proposal shall be encrypted with password and clearly labeled. The files must be sent to the dedicated email address specified in the BDS.</li> <li>c) The password for opening the Financial Proposal should be provided only upon request of ISA. ISA will request password only from bidders whose Technical Proposal has been found to be technically responsive. Failure to provide correct password may result in the proposal being rejected.</li> </ul>
<i>23.Deadline for Submission of Proposals and Late Proposals</i>	<p>23.1 Complete Proposals must be received by ISA in the manner, and no later than the date and time, specified in the BDS. ISA shall only recognize the date and time that the bid was received by ISA</p> <p>23.2 ISA shall not consider any Proposal that is submitted after the deadline for</p>

	the submission of Proposals.
<i>24. Withdrawal, Substitution, and Modification of Proposals</i>	<p>24.1 A Bidder may withdraw, substitute or modify its Proposal after it has been submitted at any time prior to the deadline for submission.</p> <p>24.2 Manual and Email submissions: A bidder may withdraw, substitute or modify its Proposal by sending a written notice to ISA, duly signed by an authorized representative, and shall include a copy of the authorization (or a Power of Attorney). The corresponding substitution or modification of the Proposal, if any, must accompany the respective written notice. All notices must be submitted in the same manner as specified for submission of proposals, by clearly marking them as “WITHDRAWAL” “SUBSTITUTION,” or “MODIFICATION”</p> <p>24.3 Proposals requested to be withdrawn shall be returned unopened to the Bidders, only for manual submissions. For online submissions, bids will be disregarded by ISA.</p>
<i>25. Proposal Opening</i>	<p>25.1 There is no public bid opening for RFPs. ISA shall open the Proposals in the presence of an ad-hoc committee formed by ISA, consisting of at least two (2) members.</p>
<b>EVALUATION OF PROPOSALS</b>	
<i>26. Confidentiality</i>	<p>26.1 Information relating to the examination, evaluation, and comparison of Proposals, and the recommendation of contract award, shall not be disclosed to Bidders or any other persons not officially concerned with such process, even after publication of the contract award.</p> <p>26.2 Any effort by a Bidder or anyone on behalf of the Bidder to influence ISA in the examination, evaluation and comparison of the Proposals or contract award decisions may, at ISA’s decision, result in the rejection of its Proposal and may be subject to the application of prevailing ISA vendor sanctions procedures.</p>
<i>27. Evaluation of Proposals</i>	<p>27.1 The Bidder is not permitted to alter or modify its Proposal in any way after the proposal submission deadline except as permitted under Clause 24 of this RFP. ISA will conduct the evaluation solely on the basis of the submitted Technical and Financial Proposals.</p> <p>27.2 Evaluation of proposals is made of the following steps:</p> <ul style="list-style-type: none"> <li>• Preliminary Examination</li> <li>• Minimum Eligibility and Qualification (if pre-qualification is not done)</li> <li>• Evaluation of Technical Proposals</li> <li>• Evaluation of Financial Proposals</li> </ul>
<i>28. Preliminary Examination</i>	<p>28.1 ISA shall examine the Proposals to determine whether they are complete with respect to minimum documentary requirements, whether the documents have been properly signed, and whether the Proposals are generally in order, among other indicators that may be used at this stage. ISA reserves the right to reject any Proposal at this stage.</p>

<p><i>29.Evaluation of Eligibility and Qualification</i></p>	<ol style="list-style-type: none"> <li>1. Eligibility and Qualification of the Bidder will be evaluated against the Minimum Eligibility/Qualification requirements specified in the Section 4 (Evaluation Criteria).</li> <li>2. In general terms, vendors that meet the following criteria may be considered qualified: <ol style="list-style-type: none"> <li>i. They are not included in the UN Security Council 1267/1989 Committee's list of terrorists and terrorist financiers.</li> <li>ii. They have a good financial standing and have access to adequate financial resources to perform the contract and all existing commercial commitments,</li> <li>iii. They have the necessary similar experience, technical expertise, production capacity where applicable, quality certifications, quality assurance procedures and other resources applicable to the provision of the services required;</li> <li>iv. They are able to comply fully with ISA General Terms and Conditions of Contract;</li> <li>v. They do not have a consistent history of court/arbitral award decisions against the Bidder; and</li> <li>vi. They have a record of timely and satisfactory performance with their clients.</li> <li>vii. The consulting firm should provide credentials, through adequate references or documentation, their current local presence in the ISA focus regions. Past experience of working with ISA and/or with multilateral/international organizations will be an added advantage.</li> </ol> </li> </ol>
<p><i>30.Evaluation of Technical and Financial Proposals</i></p>	<ol style="list-style-type: none"> <li>30.1 The evaluation team shall review and evaluate the Technical Proposals on the basis of their responsiveness to the Terms of Reference and other RFP documents, applying the evaluation criteria, sub-criteria, and point system specified in the Section 4 (Evaluation Criteria). A Proposal shall be rendered non-responsive at the technical evaluation stage if it fails to achieve the minimum technical score indicated in the BDS. When necessary and if stated in the BDS, ISA may invite technically responsive bidders for a presentation related to their technical proposals. The conditions for the presentation shall be provided in the bid document where required.</li> <li>30.2 In the second stage, only the Financial Proposals of those Bidders who achieve the minimum technical score will be opened for evaluation. ### 1. Introduction

#### 1.1. BRIEF BACKGROUND ABOUT INTERNATIONAL SOLAR ALLIANCE

The International Solar Alliance (ISA) is a global organisation of 122 member countries working to increase the deployment of solar energy technologies for improved energy access, energy security, and the facilitation of the energy transition. In order to assist the alliance in their collective work, a Secretariat has been established in India, which supports Member Countries in developing low-carbon growth trajectories. ISA works on the three strategic priority areas: i) Policy & Capacity Building, ii) Programmatic Support, and iii) Analytics & Advocacy. The ISA has established partnerships with multilateral development banks, development financial institutions, private and public sector organisations, civil society, and other international institutions to achieve its objectives.

#### 1.2. COUNTRY BACKGROUND

Guinea-Bissau, located on the West African coast, is a nation characterized by its diverse ethnic composition and significant energy challenges. As of 2023, Guinea-Bissau has an estimated population of approximately 2.15 million people. The country is home to more than 20 African ethnic groups, with the Balanta being one of the largest, alongside the Fulani, Manjaco, Mandinka, and Papel communities.

Guinea-Bissau's energy consumption is predominantly based on traditional biomass, accounting for approximately 88% of the national final energy consumption. Petroleum products contribute about 11%, while electricity comprises a mere 1%<sup>2</sup>. This heavy reliance on biomass highlights the limited access to modern energy services within the country. Only about 33% of the population has access to electricity, with access rates around 58% in the capital city, Bissau<sup>3</sup>. The electricity sector faces significant inefficiencies, including discrepancies between supply and demand, outdated distribution networks with loss rates nearing 47%, and low investment levels.<sup>4</sup> The country possesses significant potential for renewable energy, particularly in solar power, due to its geographic location.

Guinea-Bissau is actively developing a Sustainable Energy for All (SEforALL) Action Agenda to establish its 2030 energy policy objectives. The agenda aims to achieve 80% electricity access and integrate 50% renewable energy into the national grid by 2030<sup>5</sup>. In June 2024, the World Bank announced the Guinea-Bissau Solar Energy Scale-up and Access Project, focusing on developing solar energy generation and enhancing the electricity network. The project includes plans for utility-scale solar parks and the expansion of grid infrastructure, supported by a USD 35 million grant from the International Development Association (IDA), USD 10.5 million from the Green Climate Fund (GCF), and USD 2.65 million from the Energy Sector Management Assistance Program (ESMAP).

Solar energy presents a viable solution to Guinea-Bissau's energy challenges. The country's high solar irradiance offers an opportunity to diversify its energy mix and reduce reliance on biomass and imported fossil fuels. Implementing solar photovoltaic (PV) systems can lower electricity costs and improve energy access, particularly in rural areas. The integration of solar energy aligns with national objectives to increase renewable energy usage and enhance energy efficiency. By investing in solar infrastructure and

supportive policies, Guinea-Bissau can address its energy deficits, promote sustainable development, and improve the quality of life for its citizens.

### 1.3. CONTEXT

The necessity of availing universal access to sustainable and environment-friendly sources of energy has been well established as a precondition for socio-economic development, particularly among developing nations. Understandably, the widespread deployment and utilisation of Solar Energy has received its due focus and importance in the global arena of sustainability and climate change. Transferring the knowledge, technology and capacity, including access to finance from developing nations to the Least Developed Countries (LDCs) and Small Island Development States (SIDS) has become of paramount importance. Notably, access to finance on the scale required to meet the growing energy needs is one of the major challenges for ISA member countries, categorised as LDCs and SIDS, due to the limited strategic plans, policies and regulatory framework, limited access to appropriate technology and bankable projects and programme, limited institutional capacity at various levels to leverage, utilise and monitor investments to accelerate the deployment of solar energy. In order to address these challenges and supplement the policies and regulatory framework developed domestically for solar deployment at scale, a strategic roadmap and an action plan to build a favourable ecosystem for private sector investments is felt essential.

Recognising the need for a strategic solar action plan enabling activities for investment to take root in the ISA member countries, especially LDCs and SIDS, ISA intends to engage a consulting firm to develop and draft the National Solar Energy Roadmap for Guinea-Bissau, taking into consideration the country's development needs and priority interventions. The National Solar Energy Roadmap will assist in the framing of a long-term vision for the country and set achievable capacity targets for the country's solar energy sector. Furthermore, it will also support outlining the broader strategies required to achieve those targets. Energy demand has been increasing continuously, and new energy sources are being added to meet the growing demand for power generation. On the other hand, it is also clear that a national solar energy roadmap is needed to boost the sector to achieve all the national targets and international commitments, the Paris Agreement, such as UN Agenda for 2030, the Sustainable Development Goals (SDGs) therein, and in particular SDG 7: Affordable and Clean Energy and SDG 13: Climate Action, the Nationally Determined Contributions (NDCs), etc. In this context, the National Solar Energy Roadmap is envisaged for Guinea-Bissau to meet the growing energy demand and achieve its national renewable energy targets and visions as set out in its National Development Plan.

The development of the National Solar Energy Roadmap shall be driven by a robust and inclusive engagement and consultative process bringing together key stakeholders across all levels of government, local and community-based institutions, the private sector, academia, and civil society to put forward clear and country-owned priorities on addressing energy needs through solar energy interventions. It will provide the Government entities with a robust action plan with clarity on the strategic initiatives, incentives, and interventions required to put forward to achieve the set target during implementation.

## 2. Objective

- i. Assess the status of renewable energy development and solar energy adoption and infrastructure in Guinea-Bissau.
- ii. Conduct a study and assess the solar energy potential for different types of solar technologies and applications, policies, regulations, institutional capacity.

- iii. Draft a National Solar Energy Roadmap covering short-term and long-term goals, policy review and recommendations, and implementation strategies or action plans to increase solar energy contribution in the renewable energy portfolio and national power generation mix.
- iv. Provide a cost-benefit analysis of transitioning to solar energy, including potential economic, environmental, and social benefits and set a target for solar energy generation and solar integration.
- v. Identify financing mechanisms, incentives, and partnerships to support solar energy development and promote appropriate, efficient, and environment-friendly technology for the development of Solar Energy in the country.

### 3. Scope of Work

The scope of this assignment is to develop a National Solar Energy Roadmap for a time frame as determined through the consultative process with the key stakeholders that identifies strategic priorities, milestones, and targets of solar energy in Guinea-Bissau. The selected global consultancy firm will be responsible for all the deliverables, the scope of work defined, and any other task required to draft and develop a comprehensive National Solar Energy Roadmap for the country through a consultative process at all levels, but not limited to the following:

#### **3.1 Analysis of global policy framework governing renewable energy and identification of power generation portfolio, including the best practices on solar energy**

- 3.1.1 Identification of various ongoing renewable energy schemes/programs (including solar, wind, biomass, mini/micro-hydro etc.) across the globe
- 3.1.2 Conduct a thorough analysis of the global policy framework governing renewable energy, with a specific focus on solar energy best practices.
- 3.1.3 Assessment of power and energy of the country and analysis of power generation portfolio at a global, regional and country level along with the historical trends over the last 5-year trends
- 3.1.4 Identification of prevailing solar technologies deployed around the globe and their applicability to the country context as appropriate.

#### **3.2 Review of country-specific solar energy policy landscape, solar potential, supply chain of Solar PV system and implementation status of various solar technologies in different areas**

- 3.2.1 Identify the list of stakeholders for consultation.
- 3.2.2 Conduct comprehensive research and data collection on the solar energy landscape in close consultation with the stakeholders in the selected countries.
- 3.2.3 Conduct solar resources assessment and mapping of solar deployment potential for the country, sector-specific, considering geographical, technical, economic and other factors.
- 3.2.4 Analyse existing country-specific renewable/solar energy policies, regulations and incentives and identify national priorities for solar adoption.
- 3.2.5 Identify energy-intensive sectors that are critical for sustainable development and estimate the solar potential of such sectors. Also, identify priority sectors that can be focussed in short, mid and long terms for large-scale solar energy adoption.
- 3.2.6 Map the current supply chain for Solar PV systems, including manufacturers, distributors, and service providers.

- 3.2.7 Analyze the efficiency and robustness of the supply chain, identifying any bottlenecks or vulnerabilities.
- 3.2.8 Recommend strategies to strengthen the supply chain and support local industry development.
- 3.2.9 Identify and recommend suitable solar technologies tailored to country's needs

### **3.3 Identification of Barriers and Challenges**

- 3.3.1 Identify gaps and barriers for accelerating solar energy deployment and investment opportunities, also outline new strategies for increased solar energy generation, utilisation, and demand savings.
- 3.3.2 Recommend ways to integrate solar energy in energy-intensive sectors to make service delivery cleaner and better.
- 3.3.3 Assess the current performance of the grid infrastructure through available data and the outcome of consultations.
- 3.3.4 Review the institutional capacity, organisational set-up, and financial and administrative systems available within the country and private sector to execute solar-based projects and provide recommendations to fill the gaps.

### **3.4 Market/Investment Analysis, Energy/Scenario Modelling for National Solar Energy Roadmap**

Based on 3.1, 3.2, and 3.3 above, conduct a market and technology analysis for solar integration using energy-related information such as primary energy sources, including renewable energy sources and consumption patterns, within the specified country.

- 3.4.1 Based on the above, analysing the historical energy trends and patterns over the past five to 10 years, establish a baseline for scenario modelling for the country.
- 3.4.2 Develop multiple energy scenarios, including Business as Usual (BAU), Best Possible Scenario (BPS), and Ambitious Scenario (AS), in alignment with the National Solar Energy Roadmap objectives and assess investment opportunities.
- 3.4.3 Integrate solar energy technologies and financial requirements into each scenario to assess its impact on the energy landscape, including power generation, utilisation, demand management.
- 3.4.4 Provide data-driven policy recommendations, market investment opportunities, and strategies to accelerate solar energy adoption based on the outcomes of the scenario modelling.
- 3.4.5 Conduct a quantitative analysis of each scenario, including energy production, consumption and evaluate the feasibility and effectiveness of different solar energy adoption strategies and environmental implications within each scenario and develop action plans.

### **3.5 Stakeholder Mapping/Consultation and Capacity Building**

- 3.5.1 Facilitate consultative processes, such as workshops, focus group discussions, and public consultations, to gather feedback and insights from stakeholders throughout the development of the Solar Roadmap and Action Plan.
- 3.5.2 Conduct a thorough stakeholder mapping exercise to identify and categorise all relevant stakeholders involved in solar energy development within country.
- 3.5.3 Conduct at least one face-to-face bilateral consultation during the inception workshop and conduct two wider stakeholder consultation workshops – one to present the findings of the initial assessment and scenario presentation – approval of the TOC and zero draft National Solar Energy

Roadmap and the final workshop, presentation of the draft final National Solar Energy Roadmap at the country level. The cost for organizing the workshop should be borne by the bidder.

- 3.5.4 Prioritize stakeholders based on their influence, interest, and potential impact on the successful implementation of the Solar Roadmap and Action Plan.
- 3.5.5 Develop a stakeholder engagement plan that outlines specific strategies for engaging with key stakeholders at various levels, including government bodies, local communities, NGOs, and industry associations.
- 3.5.6 Assess the training and capacity-building needs of the relevant stakeholders for the effective development and implementation of the National Solar Energy Roadmap.
- 3.5.7 Define the roles and responsibilities of various stakeholders in scaling up solar energy initiatives.

### **3.6 Actionable National Solar Energy Roadmap Development for Guinea-Bissau**

- 3.6.1 Using all the above, develop a comprehensive and actionable National Solar Energy Roadmap. The part of the roadmap should feature a clearly defined binding sort of action plan, short, mid and long-term deployment target, timelines and financing plan.

## **4. Qualifications and Experiences**
