INVITATION TO REBID FOR THE PROCUREMENT OF SUPPLY AND DELIVERY OF 1 UNIT HAULING TRUCK UNDER PNAD

1. The **Department of Agriculture-Western Visayas**, through the **General Appropriations Act of 2024 (Continuing)** intends to apply the sum **One Million Five Hundred Thousand Pesos (Php1,500,000.00)** being the ABC to payments under the contract for **Procurement of Supply and Delivery of 1 unit Hauling Truck under PNAD/IB No. 2025-042 (AMV)**. Bids received in excess of the ABC shall be automatically rejected at bid opening.
2. The **Department of Agriculture-Western Visayas** now invites bids for the **Procurement of Supply and Delivery of 1 unit Hauling Truck under PNAD** with the following specifications:
 - A. Prime Mover:
 1. Engine Displacement: 2500 cc, minimum
 2. Fuel Ignition/Fuel: Diesel
 3. Fuel Tank Capacity: 60 liters, minimum
 - B. Performance/Classification:
 1. Aspiration Method: Naturally-aspirated
 2. Steering system: Power steering
 3. Transmission system: 5 speed-manual transmission, minimum
 4. Clutch System: Dual Plate
 5. Brake system: Manual brake
 6. No. of Drive: 4 wheel drive
 7. Emission rating: Euro IV complaint
 - C. Body:
 1. No. of wheels: 4, minimum
 2. Payload: 1,200 kg, minimum
 3. Dimension: Length – 4,825 mm, width – 1,740 mm, Height – 2,105 mm, minimum
 4. Front Cabin: Double
 5. Rear Body: Drop-side
 6. Gross Vehicle Weight: 3,000 kg, minimum
 - D. Other Requisites
 1. Vehicle brand should have an authorized dealership and service center in Iloilo City
 2. Accomplished by a warranty of three years or 110,000 km, whichever comes first
 3. Include a 3-year LTO registration and 1-year comprehensive insurance
 4. Inclusive of accessories (spare tire, tools, tint, car matting, early warning device and DA-logo)

Delivery of the Goods is required within **30 calendar days from receipt of Notice to Proceed** and to be delivered at Operations Compound, Parola, Iloilo City.

Bidders should have completed, within **three (3) years (2022-present)** from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II (Instructions to Bidders).

3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary “*pass/fail*” criterion as specified in the Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 12009.

Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA No. 5183.

The prospective Bidder must be registered in the PhilGEPS.

4. Prospective Bidders may obtain further information from **Department of Agriculture - Visayas** and inspect the Bidding Documents at the address given below during office hours, **8:00 a.m. to 5:00 p.m.**
5. A complete set of Bidding Documents may be acquired by interested Bidders on **April 28, 2025 – May 20, 2025** from the given address and website(s) below and upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of **Five Thousand Pesos (Php5,000.00)**. The Procuring Entity shall allow the bidder to present its proof of payment for the fees to be presented **in person**.
6. The **Department of Agriculture-Western Visayas** will hold a Pre-Bid Conference¹ at **9:30 a.m. on May 6, 2025** at the **3rd Floor, BAC Bidding Room, Department of Agriculture, RFO 6, Parola, Iloilo City**, which shall be open to prospective bidders.
7. Bids must be duly received by the BAC Secretariat through **manual** submission at the office address indicated below on or before **9:30 a.m. on May 20, 2025**. Late bids shall not be accepted.
8. All Bids must be accompanied by a Bid Securing Declaration **or** Bid Security in the amount of any of the acceptable forms and in the amount of **Php30,000.00** (if the bid security is in the form of cash, cashier’s/manager’s check, bank draft/guarantee or irrevocable letter of credit) **or Php75,000.00** (if the bid security is in the form of surety bond).

In lieu of a bid security, the bidder may submit a duly notarized **Bid Securing Declaration** that is an undertaking which states, among others, that the bidder shall enter into contract with the procuring entity and furnish the required performance security within 10 calendar days from receipt of the notice of award, and committing to pay the corresponding fine and be suspended for a period of time from being qualified to participate in any government procurement activity in the event that it violates any of the conditions stated therein as required in the guidelines issued by the GPPB.

9. Bid opening shall be at **9:30 a.m.** on **May 20, 2025** at the given address below. Bids will be opened in the presence of the bidders' representatives who choose to attend the activity.
10. The **Department of Agriculture-Western Visayas** reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Sections 35.6 and 41 of the IRR of RA No. 12009, without thereby incurring any liability to the affected bidder or bidders.
11. The **Department of Agriculture-Western Visayas** does not condone any forms of solicitation on any prospective winning and losing bidders by any of our staff/employees or any other party. Any sort of this kind shall be reported immediately to the Office of the Secretary or the National Bureau of Investigation (NBI) for entrapment and proper investigation.
