

**Open call for tenders with  
minimum capacity requirements**

The urban land management and regulation agency of the wilaya of Mascara is launching a national open call for tenders with minimum capacity requirements for road works in the 140-lot subdivision in Sidi Kada - Mascara.

Interested companies with a category four (04) qualification certificate or higher in the public works sector, main activity, may withdraw the specifications against the payment of five thousand (5,000.00) dinars.

**Bids must be accompanied by legalized and valid documents, namely:**

- o The application file will include:
  - o the declaration of probity;
  - o **Bidder's identification sheet;**
  - o Certificate of delegation of authority;
  - o **A copy of the trade register;**
  - o a copy of the tax assessment extract;
  - o **A copy of the tax registration card;**
  - o a copy of the CNAS, CASNOS, CACOBAT certificates;
  - o a copy of the qualification and professional classification certificate covered by the call for tenders;
  - o copies of the articles of association and amendments (if any), group status;
  - o Filing of corporate accounts for EURL, SARL, and SNC in accordance with the provisions of the Finance Act. The list
  - o of human resources declared by name to the CNAS or filiation by person for executives with diploma;
  - o The list of material resources to be mobilized for the project supported by all supporting documents;
  - o The list of professional references; (certificates of proper performance issued by the project owners)
- o A copy of the tax balance sheets for the last three financial years, duly endorsed by the tax authorities;
- o Certificate of solvency
- o The technical offer will include:
  - o the declaration to be subscribed to;
  - o These specifications initialed by the bidder, bearing on the last page the handwritten note "read and accepted";
  - o The implementation schedule
- o The financial offer will include:
  - o the letter of submission;
  - o the unit price schedule and the quantitative and estimated breakdown

The offers must be submitted to the headquarters of the wilaya land agency, administrative city of the wilaya of Mascara in three separate envelopes, one marked "application file", the second marked "technical offer" and the third marked "financial offer" in an anonymous sealed envelope and bearing the following note:

"a notice of open call for tenders with minimum capacity requirements. Not to be opened, roadworks at the 140-lot subdivision in Sidi Kada - Mascara"

The deadline for preparing bids is set at fifteen (15) days from the date of the first publication of this notice in the national press. The deadline for submitting bids is set at the last day corresponding to the expiration of the bid preparation period before 12:00 p.m.

Bidders will remain bound by their bids for a period equal to the bid preparation period plus three months.

Bidders are invited to attend the opening of bids, which will be held in public session on the last day of the bid preparation period at 2:00 p.m. at the headquarters of the Mascara Urban Land Management and Regulation Wilaya Agency.
