Bids can be purchased from 09:00hrs to 16:30hrs, Mondays to Thursdays, and on Fridays from 09:00 hours to 15:00 hours.
- A complete set of the bidding documents, in English, may be purchased by interested Bidders at **address (1) below** upon payment of a non-refundable fee of **Five Thousand Guyana Dollars (GY\$5,000.00)**. The method of payment will be cash, or by manager's cheque payable to the Permanent Secretary, Ministry of Public Works, Guyana.
- Qualifications requirements include but are not limited to: Bidders registered in Guyana must submit valid Certificates of Compliance from the Guyana Revenue Authority (GRA) and National Insurance Scheme (NIS).
- Bidders must register via <https://bidders.npta.gov.gy/registration> to be added to NPTAB Contractor's list.
- Bids shall be valid during **One Hundred and Eighty (180) days** of the date of bid opening.
