PLACE AND DATE FOR SUBMISSION OF OFFERS: July 2, 2025, until 10:30 a.m., the envelopes will be presented at the Reception Desk of the General Administration of the Judiciary of Córdoba building, located at Arturo M. Bas 158, Ground Floor, city of Córdoba.

PLACE AND DATE OF OPENING OF THE BIDS: July 2, 2025, at 11:00 a.m., the opening of the bids will take place in the Meeting Room of the General Administration building of the Judicial Branch of the Province, located at Arturo M. Bas 158, 2nd floor, city of Córdoba.

OFFICIAL BUDGET: Two Billion Six Hundred Forty Million Pesos (\$2,640,000,000.00).

Those who have made a site visit may request technical clarifications in writing until 06/05/2025, and to do so must submit their query to the Reception Desk of the General Administration of the Judiciary, located at Arturo M. Bas 158 - PB in the city of Córdoba, from Monday to Friday from 08:00 to 14:00 hours, or through the Digital Reception Desk "e-trámite" (Multinota), with the digital signature of the legal representative of the potential bidder or authorized person, which will be evacuated by the Department until 06/12/2025.

The responses and clarifications provided will be published on the official purchasing and contracting website of the Province of Córdoba and on the official website of the Judiciary.

MANDATORY SITE VISIT AND CLARIFICATIONS: Those interested in offering a quote in this Tender must visit the properties where the work will be carried out, accompanied by technical personnel from the Infrastructure Area. To this end, TWO (2) visits will be offered to each of the buildings, and the applicant must attend at least one (1) of them, which is considered an essential requirement for submission of a quote. These visits will be carried out according to the following details:
