The *Government of the Republic of Burundi* has obtained a Grant from the World Bank to finance the cost of the Integrated Community Development Project in Burundi "PRODECI-TURIKUMWE" in the amount of 60 million United States Dollars and intends to use part of the amount of this *Grant* to make payments under contracts with a **Supervision and Control Office for the construction of hangars and multipurpose centers in the Provinces of Cankuzo, Ruyigi and Muyinga.**
2. These Offices will have the mission of providing project management services including the supervision and control of road infrastructure works, monitoring of environmental, social, hygiene and safety measures as well as the fight against GBV on behalf of the Gashoho, Muyinga, Bweru, Gasorwe and Gisagara municipalities, project management services including the supervision and control of infrastructure works; monitoring of environmental, social, hygiene and safety measures; the fight against GBV.

4. PRODECI-TURIKUMWE invites **eligible and available** Monitoring and Control Offices to carry out the mission \_\_\_\_\_ (“Consultants”) to express their interest in providing the services described above. The pre-selection criteria are as follows:
- be an office specialized in (i) the monitoring and control of this type of infrastructure, (ii) follow-up environmental and social aspects of social and/or commercial infrastructures;  
Provide proof of at least 10 years of proven experience in this field,
  - Have carried out at least two (3) construction work supervision missions for public buildings of the same complexity during the last 5 years;
  - Have key experts who meet the profile described in the TDRs, whose CVs will be required from the firm which will be ranked first when inviting submission of technical and financial proposals.

**NB: Similar missions carried out must be accompanied by proof of completion.**

**Key experts will not be assessed at the pre-selection stage.**

The attention of interested Consultants is drawn to Section III, paragraphs 3.14, 3.16 and 3.17 of the “Procurement Regulations for Borrowers Requesting Investment Project Financing (IPF) dated July 2016, revised in November 2017 and August 2018, November 2020 and September 2023”. In addition, please refer to the following specific information on conflicts of interest related to this assignment.
6. Consultants may not be engaged for missions that would be incompatible with their present or past obligations to other clients, or that would risk making it impossible for them to fulfill their mandate in the best interests of the State of Burundi. Consultants may not be engaged in the following circumstances:
- v No Consultant (including its personnel and subcontractors) or affiliated service provider (which controls it directly or indirectly, which it controls itself or which is placed under common control) may be engaged for a mission which, by its nature, creates a conflict of interest with another of its missions;
  - v Consultants (including experts, staff and sub-consultants in their service) who have a close professional or family relationship with any executive of the State of Burundi, the executing agency of the Project, a beneficiary of a fraction of World Bank financing or any other party representing the State of Burundi or acting on its behalf who participates directly or indirectly in any segment:
    - i. of the preparation of the Terms of Reference for the mission; of the selection process for the
    - ii. iii. contract; or of the supervision of the contract, may not be awarded a contract, unless the conflict arising from the said relationship has been resolved in a manner satisfactory to the Bank throughout the selection process or the execution of the contract.
7. Consulting firms may partner with other firms to enhance their qualifications, but must clearly indicate whether the association is in the form of a joint venture and/or subcontracting.  
In the case of a joint venture, all joint venture partners will be jointly and severally liable for the entire contract, if selected.

The selection will be made according to the selection method based on the Qualifications of Consultants in accordance with the Procurement Regulations for Borrowers requesting financing of Investment Projects (FPI), dated July 2016, revised in November 2017 and August 2018, November 2020 and September 2023" and in accordance with the criteria required under these Terms of Reference.
