REHABILITATION WORKS OF THE HYDRO-AGRICULTURAL DAM OF DEKOKAHA AND DOWNWAY IRRIGATED PERIMETER

- 1. The Government of the Republic of Côte d'Ivoire has received financing from the OPEC Fund for International Development (OFID), hereinafter referred to as the Bank, to finance the Agro-Industrial Pole Project in the North (2PAI-NORD), and intends to use part of this loan to make payments under the Contract for the rehabilitation works of the DEKOKAHA hydro-agricultural dam and the downstream irrigated area. For this Contract, the Borrower will make payments using the Direct Payment disbursement method, as defined in the Bank's Guidelines for Disbursements under Investment Project Financing.
- 2. The Agro-Industrial Pole Project in the North (2PAI-NORD), acting on behalf of the Ministry of State, Ministry of Agriculture, Rural Development and Food Production, is requesting closed offers from eligible bidders who meet the required qualifications to carry out the rehabilitation works of the DEKOKAHA hydro-agricultural dam and the downstream irrigated area, consisting of one (1) single lot consisting of the works described below:

Part 1: Rehabilitation of the Dékokaha hydro-agricultural dam

- The restoration of the retention dam;
- The rehabilitation of the intake structures; -

The creation of a dissipation basin;

- The rehabilitation of two (2) flood spillways, consisting of one (1) flood spillway primary and one (1) secondary flood spillway;
- The creation of pastoral developments;
- The implementation of land stabilization development upstream of the body of water;
- The implementation of environmental and social measures.

Section 2: Development of the irrigated area downstream of the dam:

The irrigated area is a gravity-fed, open-air canal system covering a total area of approximately 220 ha and including the following works:

- Cleaning and reprofiling the main drain;
 Construction of the secondary drain;
 Construction of guard drains and outlet drains;
 Construction of service tracks along the primary and secondary channels;
- The construction of hydraulic works;
- The implementation of land stabilization development upstream of the body of water;
- The implementation of environmental and social measures.

Section 3: Support infrastructure:

- The construction of a 200 m2 storage warehouse in each beneficiary village (4 stores);
- The construction of a latrine block with 4 cabins and a hand-washing facility for each beneficiary village (4 sets).
- The construction of a composting bin per village.

The works are made up of one (1) single lot for a maximum execution period of fifteen (15) months excluding wintering as indicated in the following table:

The market will be at unit prices.

The qualification requirements are: average annual turnover - specific experience - personnel - equipment (See the Special Data of the Call for Tenders (DPAO) for detailed information).

- 3. The bidding procedure will be conducted by competitive (international) means using an open International Competitive Bidding (ICB) as defined in the Bank's Procurement Framework for Bank Group-financed operations, October 2015 edition, which can be consulted at: https://www.afdb.org, and open to all eligible bidders as defined in the Procurement Framework.
- 4. Eligible Bidders may obtain information from the 2PAI-NORD Coordination Team and review the tender documents at the address mentioned below.
- 5. The French Tender Documents may be purchased by any Tenderer by submitting a written request to the address below against a fixed, non-refundable payment of two hundred thousand CFA Francs (200,000 FCFA) to the address mentioned below:

To this end, candidates are invited to register in advance on SIGOMAP V2 at the address above. As part of this registration, they may be assisted by the General Directorate of Public Procurement. The payment method will be by mobile money or credit card. The tender documents will be downloadable electronically.

6. Offers must be submitted online in the virtual space (SIGOMAP V2) accessible at the following address: https://sigomap.gouv.ci/login-emarchespublics, no later than Tuesday, May 20, 2025 at 9:30 a.m. Universal Time. Offers submitted after the deadline will be rejected. The Offers will be opened in the presence of the members of the Bid Opening and Judging Committee (COJO), representatives of the Bidders and those present on **Wednesday**, **May 20**, **2025 at 10:00 a.m. Universal Time** in a public session, online in the virtual space (SIGOMAP V2), at the address: https://admin.sigomap.gouv.ci/

7. Tenders must be accompanied by a Tender Guarantee, in the amount of

forty million (40,000,000) CFA Francs.

This offer guarantee will remain valid for 30 days after the expiry of the offer validity period, i.e. 120 days + 30 days (150 days).

The bid guarantee must be established by a bank approved by the Ministry of Finance of the Republic of Côte d'Ivoire or issued by a bank established in the UEMOA area.

If a bidder produces a bid guarantee from a foreign bank (a bank outside the UEMOA area and established in a country meeting the origin criteria set out in Section V. Eligible Countries), this must be accompanied by an agreement signed between the guarantor and the bank established in Côte d'Ivoire or in the UEMOA area.

- Please note that the Procurement Framework requires the Borrower to disclose information on the beneficial owners of the successful Bidder, as part of the Contract Award Notification notice, by completing the Beneficial Ownership Disclosure Form included in the Bidding Documents.

Upon validation of the decision to award the contract, 2PAI-NORD will publish the award decision on the ADB website, in the Official Bulletin of Public Procurement, in a widely circulated newspaper and by posting it on its premises, and will make the analysis report of the Bid Opening and Judging Committee available to bidders or will provide a copy at their request and at their expense.
- 11. The market resulting from this call for tenders will be subject to the formalities of registration stamps and regulatory fees (0.5% of the amount excluding tax of the market at the expense of the holder).
