1. Send a letter to the head of the sub-tender committee at Harouge Oil Operations Company, stating the intention to participate in the tender, and send it via the following email:

2. The company representative must be authorized to withdraw the terms and specifications booklet by means of an official document issued by the entity he represents, stamped with the company seal and stating the name and number of the tender.

3. Submit a copy of the following valid documents:

- Certificate of proof of registration with the Chamber of Commerce
- Certificate of proof of tax payment
- Company incorporation contract
- Company articles of association
- Statement of the company's main address and branches in Libya, phone numbers and company email.

In the event that there are no inquiries from the bidder during the bid submission period, this means that the bidder has studied the terms and specifications booklet and it is considered clear to him from the technical and commercial point of view. Accordingly, in the event of any deficiency or change in the submitted bid from what is stated in the terms and specifications booklet, it is considered ineligible and will be excluded without the need to request clarification from the bidder.

5. Pay the sum of (300 LYD) three hundred Libyan dinars as the price for purchasing the tender conditions and specifications booklet in cash or in the form of a certified, non-refundable check in favor of Al-Harouge Oil Operations Company.
