Hence, ethio telecom invites all interested and eligible bidders by this **National Competitive Bid (NCB)** for procurement of “AGENT/RETAILER external wall mounted signage, banner with iron frame as per design, with installation at Awash area (**Afar region, Ethiopia**)” with **RFQ No. 4274721**. The Tender remains floating from **19-May- 2025 up to 18-Jun-2025**.

1. Interested bidders are expected to fulfill the Requirements stated here below:
  - Original Bid Security: – The bidder shall deliver a bid security (Birr 15,000) which remains valid for 120 days from a bid opening date;
  - Availability of valid and renewed trade license for the year;
  - Availability of tax clearance certificate for the year issued by the Tax authority;
  - Availability of VAT registration certificate issued by the Tax Authority;
  - Availability of Letter of Authorization to sign the bid offers;
  - Availability of Anti-bribery pledge form;
  - Bidders should have/are willing create a B2B account and agree to take the payment through Tele birr account.
2. All Bids must be accompanied by a bid security for **Birr 15,000 (Birr Fifteen thousand only)**.
  - 2.1 The bid bond shall be furnished in one of the following forms: –
    - a) Certified Cheque /CPO issued by a recognized domestic bank or
    - b) Bond issued by and/or confirmed through a recognized/reputable domestic bank.
