The Court of Auditors is issuing a national open call for tenders for the renewal and strengthening of the Court of Auditors' IT equipment.

- Acquisition of one hundred and eighty (180) laptop computers.

I- Conditions of participation:

The call for tenders covered by the specifications is aimed at economic operators operating in the field of marketing, manufacturing, import, and distribution of computer hardware and equipment, as justified by the electronic commerce register.

- II- Place of collection of the specifications:

Bidders may, directly or through their duly authorized representatives, collect the specifications at the following address:

III- Documents Constituting the Tender:

- Tenders must include an application file (application declaration, declaration of probity, professional references, etc.), a technical offer (declaration to be subscribed, etc.), and a financial offer (letter of submission, unit price schedule, and quantitative and estimated details, completed, dated, and stamped and signed by the bidder) in accordance with Article 9 of the tender specifications.
- The application file, technical offer, and financial offer, to be prepared without erasure or overwriting, must be inserted in separate, sealed envelopes, indicating the name of the company, the reference, and the subject of the tender, as well as the words "Application file," "technical offer," and "financial offer" for each lot, as applicable
- The three envelopes above must be placed in an anonymous, sealed envelope, bearing only the following note:

**IV- Tender preparation period:**

-The tender preparation period is set at thirty (30) days from the date of first publication of the tender notice in the Public Operator's Official Bulletin of Procurement (BOMOP), in the approved print or electronic press.  
- If this date falls on a public holiday or a legal day of rest, the tender preparation period will be extended until the next business day.

**V- Date and deadline for submission of tenders:**

-The tender submission date is set at the last day of the tender preparation period, deadline 12:00 p.m

- The exact date for submitting bids will be mentioned in the specifications by the contracting department before it is submitted to the candidates.

**-Opening of bids:**

- The opening of bids containing the application file, the technical offer, and the financial offer will be handled by the contracting department's bid opening and evaluation committee on the day corresponding to the bid submission date, as indicated in Article 19 of the specifications, at 12:30 p.m. sharp, in the presence of the bidders or their duly authorized representatives, holding a power of attorney. If this date falls on a public holiday or a legal day off, the bid submission date will be extended until the next business day.

**VIII-Bid validity period:**

Bidders will remain bound by their bids for a period of ninety (90) days plus the bid preparation time from the date of submission of bids.

-For the provisional successful bidder, the bid validity period is systematically extended by one (01) additional month in accordance with the provisions of Presidential Decree No. 15-247 of September 16, 2015, regulating public procurement and public service delegations, in particular Article 99
