**The submission must contain:**

**- The application file :** including: All the parts and documents listed in point 5 “Documents constituting the file” of the instructions to tenderers of the specifications: (Declaration of application, Declaration of probity, Copies of the statutes for companies, Documents relating to the powers authorizing persons to commit the company, Documents allowing the capacities of the tenderers to be assessed, etc.).
