

NOTICE OF OPEN CONSULTATION

- . The Government of Madagascar has received Financing from the World Bank for the implementation of the *Safety Nets and Resilience Project (PFSR)* , and intends to use part of said Financing to make payments under the Contract relating to:
Supply and delivery of various small agricultural equipment divided into two (02) lots:
 LOT 01: Ploughing tools
 LOT 02: IRRIGATION EQUIPMENT
- . The Development Intervention Fund (FID) is requesting closed offers from eligible bidders who meet the qualifications required to carry out the contract.
- . The procedure will be conducted by competitive bidding using a Request for Quotation as defined in the “Procurement Regulations for the Financing of Investment Projects – 6th edition February 2025 published by the World Bank”, and open to all bidders from eligible countries as defined in the Procurement Rules.
- . Interested and eligible bidders may obtain additional information and review the consultation documents at the address mentioned below (9) from 8:30 a.m. to 4:30 p.m.
- . The electronic version of the Consultation File in French may be requested and/or withdrawn from the address (9) by any interested Tenderer by making a written request specifying the reference and subject of this notice and the contact details of the Applicant (Name, Telephone, e-mail, physical address).
- . Tenders must be submitted to the address below (9) no later than April 3, 2025 at 3:00 PM (15:00), local time . Submission of tenders electronically will not be permitted. Late tenders will not be accepted.
Tenders will be opened in the presence of the tenderers' representatives on the same day as the deadline set for submission of tenders at 10:00 AM (10:00 AM).
- . The offer must include a bid guarantee in the form of a certified bank check or letter of bank guarantee made out to “FID FSR DG”, and valid for one hundred and twenty (120) days after the bid opening date set:
 LOT 01: ONE MILLION ARIARY (MGA 1,000,000.00)
 LOT 02: ONE MILLION FIVE HUNDRED THOUSAND ARIARY (MGA 1,500,000.00)
- . The offer must include a bid guarantee in the form of a certified bank check or letter of bank guarantee made out to “FID FSR DG”, and valid for one hundred and twenty (120) days after the set bid opening date: TWO MILLION TWO HUNDRED THOUSAND ARIARY (MGA 2,200,000)
