- All the tender documents are to be submitted online only on the website **etenders.kerala.gov.in** in the designated covers and no manual submission shall be entertained.
- A nonrefundable tender document fee of **Rs.5900/- (Rupees Five thousand Nine hundred only) inclusive of GST @ 18%** and an Earnest Money Deposit **Rs.50000/- (Rupees Fifty thousand only)** shall be remitted to the account number in the remittance form provided by the e- procurement system for this particular tender. Only **SBI/MOPS** (State Bank of India Multi Option Payment System) Internet Banking remittance is allowed.
- Kerala Government Public Sector Undertakings and all SSI/MSME units within Kerala which are registered with store purchase Department for the products/service for which registration is valid are exempted from furnishing EMD on producing valid documents in support to their claim.
- **The offers shall be submitted in two cover system.**
- All communications regarding e tender including queries if any shall be done online within the e-procurement system at website <http://etenders.kerala.gov.in>
- **The contractor shall quote the price excluding GST, and considering all other taxes, if any, applicable. The price has to be quoted, after considering the current market rate and after passing on the benefit of Input Tax credit, as per section 171 of the CGST Act 2017. Only GST registered bidders are allowed to participate this tender.**

- **Opening of Bid-** Cover No.-1 consisting of details of Tender Cost, EMD, Experience and Agreement etc. will be opened online. After verification of the contents of Cover No.-1, Cover No.-2 will be opened. The bid shall be opened online at this office in the presence of the bidders /their authorized representatives who wish to attend, on the date and time mentioned above or modified and communicated through corrigendum.
- The bidder should have adequate financial and technical resources as well as infrastructure facilities readily available with him to undertake this work. The decision of the bidding authority will be final in acceptance of the bid if this condition is not complied with.
- The bidder should submit documentary evidences to show the bidder's experience in similar works.
- After evaluation of the price bid the successful bidder shall execute an agreement in the form prescribed by KSEBL for the due fulfillment of the contract within the period to be specified in the work order and shall furnish Security Deposit equal to 5% of the contract value before signing the agreement. Bidder should be prepared to accept orders subject to an indemnity clause for forfeiture of security deposit in the event of default or failure to work within the stipulated period.
