Terms and Conditions|नियम और शर्तें

- 1. General Terms and Conditions-
- 1.1 This contract is governed by the General Terms and Conditions, conditions stipulated to this Product/Service as provided in the Marketplace.
- 1.2 This Contract between the Seller and the Buyer, is for the supply of the Goods and/ or Services, detailed in the schedule above, in accordance with the General Terms and Conditions (GTC) unless otherwise superseded by Goods / Services specific Special Terms and Conditions (STC) and/ or BID/Reverse Auction Additional Terms and Conditions (ATC), as applicable
- 2. Buyer Added Bid Specific Terms and Conditions-
- 2.1 Generic

OPTION CLAUSE: The Purchaser reserves the right to increase or decrease the quantity to be ordered up to 25 percent of bid quantity at the time of placement of contract. The purchaser also reserves the right to increase the ordered quantity by up to 25% of the contracted quantity during the currency of the contract at the contracted rates. Bidders are bound to accept the orders accordingly.

2.2 Generic

Bidders are advised to check applicable GST on their own before quoting. Buyer will not take any responsibility in this regards. GST reimbursement will be as per actuals or as per applicable rates (whichever is lower), subject to the maximum of quoted GST %.

2.3 Generic.

Bidder shall submit the following documents along with their bid for Vendor Code Creation:

2.6 Buyer Added Bid Specific ATC: Buyer Added text based ATC clauses

A) PRE-QUALIFICATION REQUIREMENT:

- 1 The participated vendor must have supplied minimum 200 CuM of UHP Nitrogen G as with minimum 99.999% purity in one financial year within a period of last five years from the date of opening tender.
 - 2) As a supporting document to Point (1) following has to be provided:
 - a) Proof of Order: copy of Purchase Orders/Purchase Agreements etc.
- b) <u>Proof of Supply</u>: Copy of Invoice/any other document to confirm supply of material again st above Purchase order.
- c) <u>Proof of Quality</u>: Copy of Test Certificate required (If Nitrogen purity is not mentioned in PO/ Invoice copy)
- **B**) Other Terms and conditions:
 - Material shall be supplied as per requirement for Nitrogen gas (Grade-5.0) Purity 99.999 % m in. Oxygen=1.0 PPM MAX; Moisture =2.0 PPM Max.
 - 2. Prices to be quoted on F.O.R. CFFP BHEL Haridwar basis.
 - 3. Delivery period shall be as per GeM bid (On intimation basis).
 - 4. Quantity tolerance will be ± 5 % of tendered quantity.
 - 5. All the charges (Freight, insurance, cylinder charges, GST etc.) are inclusive in the quoted rate.
 - 6. Ordered quantity is valid for 2 years of supply from contract date.
 - 7. Tentatively 10-20 cylinders (70-140 CuM) of Nitrogen will be required per intimation. This Intimation is approximately given on bi-weekly/monthly basis.
 - 8. Nitrogen cylinders will be required at CFFP within 2-3 days after date of intimation. However, BHEL reserves the right to call any no. of cylinders with mutual agreement.
 - 9. Vendor has to keep stock of minimum 20 cylinders at CFFP, separate rent will not be paid for cylinders. Maximum holding time for these cylinder is 6 months.
 - 10. Oxygen and moisture shall be max. 2.00 ppm.
 - 11. Nitrogen Purity in the supply should be of UHP Grade-5, 99.999% purity.
 - 12. PAYMENT TERMS: 100% payment will be made to the seller within 45/60/90 days (as per below mentioned) after receipt; subject to acceptance of material at CFFP / BHEL, Haridwar through e-payment by the Buyer.

Participating MSME bidders which are already registered with CFFP BHEL, need to ensure th at their latest MSME status is updated with CFFP for getting above payment preference. Als o, MSME bidders not registered with CFFP should provide copy of "previous financial year's audited balance sheet and P&L statement" along with UDYAM certificate for availing above mentioned payment preference.

- 13. RISK PURCHASE: In case of abnormal delays (beyond the maximum late delivery period as per LD clause) in supplies / defective supplies or non-fulfilment of any other terms and conditions given in Purchase Order, BHEL may cancel the Purchase Order in full or part thereof, and may also make the purchase of such material from elsewhere / alternative source at the risk and cost of the supplier. BHEL will take all reasonable steps to get the material from alternate source at optimum cost. If bidder does not agree to the above Risk Purchase Clause, BHEL reserves the right to reject the offer. In case for compelling reasons BHEL accepts the offer without acceptance of this clause by the bidder and in the eventuality of Risk Purchase, appropriate action will be taken as per BHEL extant rules. This will be without prejudice to any ot her right of BHEL under the contract or under General Law.
- 14. PO delivery date is tentative in nature. However, Nitrogen gas shall be delivered for the part quantity as and when requirement basis.
- 15. Cylinder repair & maintenance to be done by supplier. No separate cost will be paid by BHEL Haridwar. In case, any defective cylinder if fund in supply, it will not be considered for materi al clearance.
- 16. Vendor has to ensure to provide safety caps /protection for cylinder valves.
- 17. The enquiry quantity is subjected to part delivery on as and when requirement basis. Thus there may be multiple lot of supply to complete enquiry/PO quantity.
- 18. All cylinders are required to be examined and tested periodically as per the Govt. rules, responsibility for compliance with these tests will be on the seller, who will carry out test as may be required.
- 19. Conflict of Interest:

A bidder shall not have conflict of interest with other bidders. Such conflict of interest can lead to anti-competitive practices to the detriment of Procuring Entity's interests. The bid der found to have a conflict of interest shall be disqualified. A bidder may be considered to ha ve a conflict of interest with one or more parties in this bidding process, if: a) They hav e controlling partner (s) in common; or b) They received or have received any direct or indi rect subsidy/financial stake from any of t hem; or c) They have the same legal representati ve/agent for purposes of this bid; or d) They have relationship with each other, directly or t hrough common third parties, that puts them in a position to have access to information a bout or influence on the bid of another bidder: or e) Bidder participates in more than one b id in this bidding process.
