2.3 Generic:

Manufacturer Authorization:Wherever Authorised Distributors/service providers are submitting the bid, Authorisation Form /Certificate with OEM/Original Service Provider details such as name, designation, address, e-mail Id and Phone No. required to be furnished along with the bid

2.4 Warranty:

Warranty period of the supplied products shall be 3 years from the date of final acceptance of goods or after completion of installation, commissioning & testing of goods (if included in the scope of supply), at consignee location. OEM Warranty certificates must be submitted by Successful Bidder at the time of delivery of Goods. The seller should guarantee the rectification of goods in case of any break down during the guarantee period. Seller should have well established Installation, Commissioning, Training, Troubleshooting and Maintenance Service group in INDIA for attending the after sales service. Details of Service Centres near consignee destinations are to be uploaded along with the bid.

2.5 Buyer Added Bid Specific ATC:

Buyer Added text based ATC clauses

- 1) **Delivery Schedule: Supply & Installation to be completed within 60days from the date of PO.**
- 2) **Bidders are requested to provide, MII (%) declaration in the attached format along with list of local components.**
- 3) **Bidders are requested to mention percentage of GST in the technical bid. Bidders should not mention GST value in the technical bid. If any bidder mention GST value in the technical bid, their offer shall be disqualified.**
- 4) **EMD : a) The proposal complete in all respect be submitted along with an Earnest Money Deposit (EMD) of Rs.80,000/- be paid by Demand Draft drawn in favour of 'Pay and Accounts Officer, NRSC, payable at SBI, NRSA Branch, Balanagar, Hyderabad , from any nationalized/scheduled bank.**
b) The EMD deposit via demand draft should remain valid for at least 90 days (three months) from the last date of submission of tender.
c) No interest is payable on refund of EMD.
d) EMD should reach NRSC before the technical bid opening date mentioned in the tender.
e) The EMD in respect of the agencies which do not qualify the Technical Bid (First Stage) / Commercial Bid (Second competitive stage) shall be returned to them without any interest. However, the E.M.D. in respect of the successful bidder shall be adjusted towards the Performance Security Deposit.
f) EMD/Bid security shall be exempted to Central PSUs/PSEs/Autonomous Bodies and to those Bidders who are registered with the Micro, Small Enterprises (MSEs) on submission of attested copy of Registration Certificate along with the Techno-Commercial Bid and also exempted to eligible vendors as per GeM T&C and also exempted to registered vendors of NRSC. NRSC shall not entertain any correspondence in this regard after opening of the Tender.
g) The EMD/Bid Security will be forfeited if the Service Provider withdraws or amends, impairs or derogates from the Tender in any respect during the period between Tender Due date and Tender finalization. No separate order or letter would be issued for forfeiture of EMD/Bid Security which follows on default and shall be credited at once to the Government Account
h) The offers of those vendors who have submitted EMD before the technical bid opening date shall only be evaluated.
