Also guarantee against any manufacturing defects/inferior quality of LED for a period of 60 months from the date of despatch of material to HPCL regional offices. During this period, you will arrange

to repair/replace any defective parts free of cost or replace complete set if required. Guarantee Certificate should be submitted along with despatch documents. You will furnish performance Bank Guarantee in favour of HPCL issued by Scheduled bank (other than co-operative banks) valid during the above guarantee period.

Quantum of Performance Bank Guarantee inclusive of Security Deposit should be 10% of PO value. Composite PBG of above value towards Performance Bank Guarantee inclusive of Security Deposit shall be accepted (in lieu of deduction of retention money of 10% from each bill); Such composite PBG shall be valid upto a period of 3 months beyond the expiry of defect liability period.
