## 1. Special terms and conditions- Version:1 effective from 11-05-2023

2. The above terms and conditions are in reverse order of precedence i.e. ATC shall supersede specific STC which shall supersede General Terms and Conditions ("GTC"), whenever there are any conflicting provisions.
