## नियम और शर्तें | Terms and Conditions

### 1. General Terms and Conditions-

- 1.1 This contract is governed by the [General Terms and Conditions](#), conditions stipulated to this Product/Service as provided in the Marketplace.
- 1.2 This Contract between the Seller and the Buyer, is for the supply of the Goods and/ or Services, detailed in the schedule above, in accordance with the General Terms and Conditions (GTC) unless otherwise superseded by Goods / Services specific Special Terms and Conditions (STC) and/ or BID/Reverse Auction Additional Terms and Conditions (ATC), as applicable

### 2. Buyer Added Bid Specific Terms and Conditions-

#### 2.1 Generic

OPTION CLAUSE: The Purchaser reserves the right to increase or decrease the quantity to be ordered up to 25 percent of bid quantity at the time of placement of contract. The purchaser also reserves the right to increase the ordered quantity by up to 25% of the contracted quantity during the currency of the contract at the contracted rates. Bidders are bound to accept the orders accordingly.

#### 2.2 Generic

Manufacturer Authorization: Wherever Authorised Distributors/service providers are submitting the bid, Authorisation Form /Certificate with OEM/Original Service Provider details such as name, designation, address, e-mail Id and Phone No. required to be furnished along with the bid

#### 2.3 Generic

Without prejudice to Buyer's right to price adjustment by way of discount or any other right or remedy available to Buyer, Buyer may terminate the Contract or any part thereof by a written notice to the Seller, if:

- i) The Seller fails to comply with any material term of the Contract.
- ii) The Seller informs Buyer of its inability to deliver the Material(s) or any part thereof within the stipulated Delivery Period or such inability otherwise becomes apparent.
- iii) The Seller fails to deliver the Material(s) or any part thereof within the stipulated Delivery Period and/or to replace/rectify any rejected or defective Material(s) promptly.
- iv) The Seller becomes bankrupt or goes into liquidation.
- v) The Seller makes a general assignment for the benefit of creditors.
- vi) A receiver is appointed for any substantial property owned by the Seller.
- vii) The Seller has misrepresented to Buyer, acting on which misrepresentation Buyer has placed the Purchase Order on the Seller.

#### 2.4 Scope of Supply:

Scope of supply (Bid price to include all cost components) : Only supply of Goods

#### 2.5 Turnover:

Bidder Turn Over Criteria: The minimum average annual financial turnover of the bidder during the last three years, ending on 31st March of the previous financial year, should be as indicated in the bid document. Documentary evidence in the form of certified Audited Balance Sheets of relevant periods or a certificate from the Chartered Accountant / Cost Accountant indicating the turnover details for the relevant period shall be uploaded with the bid. In case the date of constitution / incorporation of the bidder is less than 3 year old, the average turnover in respect of the completed financial years after the date of constitution shall be taken into account for this criteria.

#### 2.6 Purchase Preference (State):

Procurement under this bid is reserved for purchase from Micro and Small Enterprises from the State of Bid Inviting Authority whose credentials are validated online through UDYAM Registration /Udyog Aadhaar (as validated by Government from time to time) for that product category. If the bidder wants to avail the reservation benefit, the bidder must be the manufacturer of the offered product in case of bid for supply of goods. Traders are excluded from the purview of Public Procurement Policy for Micro and Small Enterprises. In respect of bid for Services, the bidder must be the Service provider of the offered Service. Relevant documentary evidence in this regard shall be uploaded along with the bid in respect of the offered product or service. Benefits of MSE will be allowed only if seller is validated on-line in GeM profile as well as validated and approved by Buyer after evaluation of documents submitted.

#### 2.7 Certificates:

Bidder's offer is liable to be rejected if they don't upload any of the certificates / documents sought in the Bid document, ATC and Corrigendum if any.

#### 2.8 Inspection:

- 2) Bid Item Specific Terms and Conditions:

- a) This Twine Ball Thin Cotton is required for Loksabha General Election-2024, so the quality of the goods must as per specification and sample.
- b) Full quantity of work should be invariably accomplished (with inspection and delivery to consignee location) within stipulated time frame. Last date of delivery at consignee location is 30/03/2024 or 01 (One) Month from the date of GeM Contract whichever is earlier. No extension will be permitted.
- c) Balls should be wounded in such manner that at the time of unwinding there should be no wastage. Machine wounded balls preferred.
- d) Each Ball should contain round wrapper of paper which indicate the suppliers name & year of manufacturer and "Govt. of Gujarat 2023-2024" should be marked on each packet.
- e) The words "Government of Gujarat 2023-2024" should be conspicuously inscribed on the boxes of stores to show the same is the property of "Government of Gujarat".
- f) Ten(10) Balls should be packed in one card box & such card boxes should be kept in wooden/corrugated boxes.
- g) Cartons of Twine Ball Cotton should not exceed more than 50 Kg.

3) Bid Specific Terms and Conditions:

- a) Experience Criteria: The bidder or its OEM should have regularly manufactured and supplied same or similar products to any Central/State Govt Organisation/PSU/Public Listed Company for 5 years before the bid opening date. Copies of relevant contracts/Satisfactory delivery certificate to be submitted alongwith the bid in support of having supplied some quantity last 5(Five) years.
- b) Sample: Only one type of (Quality) Four (04) fresh samples must be submitted physically for specification, quality, feel, finish, colour and visual inspection within Two days of Bid opening date. Bidder submitting multiple type (quality) of samples will be straightway rejected. No deviations among the sample will be accepted. Online Bid without sample will not be considered and rejected. Sample will not be returned. Sample should bear following particulars.

- I. Name of the firm/signed by Bidder
- II. Name of manufacturer.
- III. Bid No. and date.
- IV. Brand name.

Bidder may please note that if sample is not found as per requirement then the bid is liable to be rejected.

- c) Sample of bid item is available at office; interested bidders may visit during office hours.
- d) In house Inspection (Inspection at manufacturing site) is compulsory /mandatory for MSE Bidder claiming for EMD Exemption.
- e) In case of requirement of excess quantity, it should be provided on urgent basis within 2 days with same price, terms & condition without fail.
- f) Sample approval of item should be obtained from DGPS/Election Commission before mass production.
- g) Forms of EMD and ePBG: Bidders can also submit the EMD with Account Payee Demand Draft in favour of DIRECTOR GOVERNMENT PRINTING AND STATIONERY, payable at GANDHINAGAR delivery of hardcopy to the Buyer within 2 days of Bid End date / Bid Opening date due to urgency of item for Loksabha General Election-2024. (If Bidder has to submit EMD in the form of ePBG; it should be among Bank mentioned in the Finance Department GR No.FD/MSM/e-file/4/2023/0057/DMO, dated: 23-04-2023). - h) Bidders seeking EMD Exemption based on MSE Certificate/Udyam Registration Certificate must submit details in Buyer uploaded ATC Document. In absence of supporting documents, EMD Exemption based on MSE Certificate / Udyam Registration Certificate will not be granted.
- i) Bidders seeking EMD Exemption are required to take utmost care for selection of base category for EMD exemption while applying for bid. Request for any modification in reason/Category of EMD exemption will not be considered during representation or at any stage of the bid. Selection of reason/Category for EMD Exemption at the time of participating in bid will only be considered.
- j) Bidder's Offering unregistered brand / unbranded product are required to clarify about the name of brand/company for the offered product on letterhead of the manufacturer in the bid document. Bidders offer is liable to be rejected if they don't upload this clarification in the bid document.
- k) Technical evaluation will be based on document submitted by the bidder along with the bid. During technical evaluation process, clarification will be sought only for the submitted documents. Submission of any new documents will not be entertained.
- l) Risk Purchase: If the L-1 seller fails to deliver the stores or any installments thereof within the period fixed for such delivery, DGPS is entitled to purchase the stores not delivered at the risk and cost of the defaulting seller. In the such event of purchase, the defaulting seller shall be liable for any loss which Government may sustain on account provided the purchase orders placed within 6 months from the date of such default.

- m) Pre-dispatch inspection at Seller premises (Fee/Charges to be borne by the SELLER): Before dispatch, the goods will be inspected by Buyer / Consignee or their Authorized Representative or by Nominated External Inspection Agency (independently or jointly with Buyer or Consignee as decided by the Buyer) at Seller premises for their compliance to the contract specifications. Fee/Charges taken by the External inspection Agency and any external laboratories testing charges shall be borne by the SELLER. For in-house testing, the Sellers will provide necessary facilities free of cost. Seller shall notify the Buyer through email about readiness of goods for pre-dispatch inspection and Buyer will notify the Seller about the Authorized Representative/ Nominated External Inspection Agency and the date for testing. The goods would be dispatched to consignee only after clearance in pre-dispatch inspection. Consignee's right of rejection as per GTC in respect of the goods finally received at his location shall in no way be limited or waived by reason of the goods having previously been inspected, tested and passed by Buyer/ Consignee or its Nominated External Inspection Agency prior to the goods' shipment. Inspection and external laboratory testing charges shall be borne by the supplier and it shall not be reimbursed by Buyer to them at any point in time. Cost of inspection / testing shall be factored in by the supplier in the cost of the product itself while submitting bid.

INSPECTION AGENCY The inspection agency will conduct the inspection and submit the certificate to the supplier as well as the buyers and consignees. The bidder will be solely responsible for pre-inspected material for Quality Assurance including pre-dispatch inspection/ testing at manufacturers site.

- n) Laboratory Charges: In case, if any laboratory test is required to be carried out during and after the receipt of stores, the said charges will be borne by the seller.
- o) After award of contract – Successful Bidder shall have to get advance sample approved for feel, finish, colour and visual inspection as per sample from buyer before bulk manufacturing / starting bulk supplies. Successful Bidder shall submit 04 samples for Buyer's approval, within 02 days of award of contract. Buyer shall, as per contract specifications framework, either approve the advance sample or will provide complete list of modification required in the sample within 07 days of receipt of advance sample. Seller shall be required to ensure supply as per approved sample with modifications as communicated by Buyer. In case, the sample is found to have major deviations / not confo

rrming to the Contract specifications, the buyer at its discretion may call for fresh samples for approval before allowing bulk supplies or may terminate the contract after notifying the deviations to the seller.

Unless otherwise provided in the contract, all samples required for test shall be supplied by the contractor free of cost. Where under the contract, the contractor is required to submit an advance sample, any expenses incurred by the contractor on or in connection with the production of stores in bulk.
