2.5 Generic:

8 The CCTV OEM should have its office and service/ support center in Maharashtra. Required sales, service tax number/ certificate to be provided along with the bid.

9 The Bidder(s) must propose 'Makes' that are in compliance to 'Make In India' guidelines of Government of India.
