. Successful Bidder to indicate Contract number and name of Seller entity in the transaction details field at the time of on-line transfer. Bidder has to upload scanned copy / proof of the Online Payment Transfer in place of PBG within 15 days of award of contract.

2.11 Buyer Added Bid Specific ATC:

a) WARRANTY / GUARANTEE:

- i) Bidders shall guarantee/warranty the item supplied against material and manufacturing defects for a period of 2 months from the date of commissioning or 18 months from date of supply whichever is earlier.
