1.1.1.3 Supply of suitable Connectors required for connecting the cable with Camera / DVR / NVR / HVR / SFP module / PoE Switch etc.						
1.1.1.4 Proper dressing of Cable ends, Pre-forming of connecting cables (end termination) and Fixing suitable connectors.
