1.1 1.The category deal with Sandwich Extrusion laminated Polypropylene (PP) woven sacks for packaging of foodgrain IS: 18482: 2023 with Logo/text to be printed on both the sides as per FCI requirement

2.Category is created based on IS 18482: 2023 and the specifications parameter have been indicated based on the requirements projected by Food Corporation of India.

3.The logo/text to be printed shall be made part of the bid when procurement is done by buyers from Food Corporation of India.

4.This category is exclusively made for the requirements of FCI and no other Buyer organization other than FCI and regional offices shall be authorized to place order against this category.

5.The unit of measurement shall be bale and each bale shall be packed with 1000 bags. Buyers shall accordingly calculate the number of bales required to be indicated while making procurement, taking into consideration of total number of bags needed by them. In case for any reason Buyer organization opt for lower number of bags per bale the same shall be indicated in the additional terms and condition of bid and number of bales shall be calculated and referred in the bids accordingly.
