- ii. Seller shall ensure that all saplings of plants/trees supplied as per order are duly treated for any type of insect/bug/disease infliction. The supplied saplings should not be affected with any type of known plant/tree diseases.
- iii. Seller shall be responsible for ensuring that the plant/tree saplings supplied are in the same condition as depicted in the listing on GeM platform.
- iv. Seller shall ensure that all saplings supplied as per the specifications as stipulated in the order in terms of height, growth and age.
- v. Seller shall replace the saplings of plants/trees that go dry or die out, at no additional cost to the buyer.
- vi. The supplied plant/tree saplings shall be placed by the seller at the designated location within the buyer's campus/premise as directed by the buyer.
- vii. The cost of all material, cartage, conveyance charges etc. shall be borne by seller for carrying plants from nursery to buyer location and vice versa.
- viii. Seller shall ensure that no saplings supplied are damaged in transit from nursery to buyer's location.
- ix. In order to maintain the freshness and health of supplied plants Seller shall ensure that supplied plants are maintained by professional gardener.
- x. Gardener shall visit at least once in a week or as and when required to carry out upkeep of supplied plants.(Optional)
