**1. General Terms and Conditions-**

- 1.1 This contract is governed by the [General Terms and Conditions](#), conditions stipulated to this Product/Service as provided in the Marketplace.  
1.2 This Contract between the Seller and the Buyer, is for the supply of the Goods and/ or Services, detailed in the schedule above, in accordance with the General Terms and Conditions (GTC) unless otherwise superseded by Goods / Services specific Special Terms and Conditions (STC) and/ or BID/Reverse Auction Additional Terms and Conditions (ATC), as applicable

**2. Buyer Added Bid Specific Terms and Conditions-**

**2.1 Generic**

OPTION CLAUSE: The Purchaser reserves the right to increase or decrease the quantity to be ordered up to 25 percent of bid quantity at the time of placement of contract. The purchaser also reserves the right to increase the ordered quantity by up to 25% of the contracted quantity during the currency of the contract at the contracted rates. Bidders are bound to accept the orders accordingly.

**2.2 Forms of EMD and PBG:**

Bidders can also submit the EMD with Fixed Deposit Receipt made out or pledged in the name of A/C (Name of the Buyer). The bank should certify on it that the deposit can be withdrawn only on the demand or with the sanction of the pledgee. For release of EMD, the FDR will be released in the favour of the bidder by the Buyer after making endorsement on the back of the FDR duly signed and stamped along with covering letter. Bidder has to upload scanned copy/ proof of the FDR along with bid and has to ensure delivery of hardcopy to the Buyer within 5 days of Bid End date/ Bid Opening date

**2.3 Buyer Added Bid Specific ATC:**

**1) Bidder to quote with Bid specific authorization of OEM otherwise offer will be summarily rejected and no representation will be entertained.**

**2) Bidder should have 20% of executed same nature of work in any government organization otherwise will be summarily rejected**

**3) Only Make/Brand as per attached specification are acceptable other make are not acceptable and make offered meets the technical requirement, bidder to give undertaking of the same.**

**4) IRS terms and conditions are applicable.**

**5) Offers without EMD will be summarily rejected subject to exemptions as per extant rules.**

**6) Firm to give undertaking they will deliver within 45 days otherwise offer will be rejected.**

**7) Firm has to deliver material to SSE/P.Way**

**2.4 Generic**
