Furthermore, in the event subsequent clarification(s)/query(ies) are sought and bidder fails to respond or esponds with incorrect / inadequate or n on-compliant information, the bid will be liable to be rejected.

Subsequent representation(s) may not be accepted in such cases.

- 3. Liquidated Damages: If the Seller fails to deliver any or all of the Goods/Services within the original/refiæd delivery period(s) specified in the contract, the Buyer will be entitled to deduct/recover the Liquidated Damages for the delay, unless covered under Force Majeure conditions aforesaid, @ 0.5% of the contract value of delayed quantity per week or part of the week of delayed period as pre-estimated damages not exceeding 10% of the contract value of delayed quantity without any controversy/dispute of any sort whatsoever.
