- i. CA certified Turnover during last three financial years 2020-21, 2021-22 & 2022-23 (Required minimum Avg. turnover of Rs. 10.50 lakh). **The Turnover should be issued by practicing CA with Membership Number ,seal and signed with UDIN**

In case the date of constitution / incorporation of the bidder is less than 3 years old, the average turnover in respect of the completed financial years after the date of constitution shall be taken into account. In this case, the financial turnover during last financial year / the average financial turnover during preceding two financial years should be at least Rs. 10.50 lakh

- ii. Relaxation in Experience criteria for eligible MSEs/ STARTUPS
