The purchaser also reserves the right to increase the ordered quantity by up to 25% of the contracted quantity during the currency of the contract at the contracted rates. Bidders are bound to accept the orders accordingly.

2.2 Buyer Added Bid Specific ATC:

Buyer Added text based ATC clauses

- The material be dispatched strictly as per the specification mentioned in specification colour through a well reputed Road Transport Agency in a water proof/compact packaging to the State Motor Garages Department Bemina Bye pass Road Srinagar as well as New plots Jammu duly insured for all transitory risks.
- The goods if any identified breakage/damaged the item thereof shall have to be lifted back and replaced immediately without any extra charges.
- The rate of the items supplied shall not in any case exceed the MRP.
- The supplier shall have to supply the Tyres manufactured during the year 2024 only in respect of Appolo, Bridgestone, MRF, Ceat and Goodyear make of tyres.
- Bidders shall submit sample of tyres by or before closing date of bid otherwise their bid shall be rejected without any further notice.
- Only Manufacturers or their authorized dealers/ Distributors participate in the bid and also upload the copy of authorization of OEM in case of dealer/Distributor.
- Delivery should be made within 15 days from the date of receipt of purchase order.
- Rates shall be quoted for destination i.e. Directorate of State Motor Garages Department Srinagar and Jammu.
- Financial bid of only those tenderer shall be opened who will qualify the technical bid.
