B. Provisions of revised "Public Procurement" (Preference to make in India) order 2017 notified vide order no. P-45021/2/2017-PP (BE-II) dated 16/09/2020 of Ministry of Commerce and Industry, Department of Industrial Policy and Promotion (DIPP) shall be applicable.
