3. Price is to be quoted FOR NALCO Smelter Stores basis including all cost component i.e. P&F, freight & transit insurance, GST etc. Any other condition mentioned anywhere in the attachment shall be ignored.

4. All prices quoted must remain firm & fixed till complete execution of the order (i.e., without any escalation/ price variation terms) except for statutory variation in taxes and duties during contractual delivery/ completion period. Any increase in taxes and duties after expiry of the delivery/ completion period shall be to supplier's account.

5. Please mention applicable GST rate against each item.

6. a) Payment term: 100% payment shall be made within 10 days of generation of CRAC. CRAC shall be generated after receipt & acceptance of material at our site.

6. b) Payment of GST is subject to reflection of party's invoice in GSTR 2A/ ANX -2 (GST NEW RETURN) of NALCO.

7. Declaration as per Annexure-II, Annexure-III, Annexure-IV & Annexure-V of NIT is to be submitted along with offer.

8. 1. UNDER INCOME TAX CLAUSES

(A) For supply Contracts / Purchase Orders / Supply portion of LSTK

NALCO, being Buyer (under Section 194Q inserted in the Income Tax Act, 1961 vide Finance Act 2021) having total sales, gross receipts, or turnover from business above Rupees Ten Crores during the last Financial Year, will deduct TDS under Section 194Q, w.e.f. 01.07.2021, at the prescribed rate of 0.1% on the purchase value of any goods, aggregate of which is exceeding the threshold limit of Rs.50 Lakhs in a Financial year.

Accordingly, Vendors/Sellers are not to collect tax at source under section 206C(1H) of the Act w.e.f. 01.07.2021, in case provisions of section are applicable to them.

The above is as per the current status and is subject to modification(s) based on amendments/notifications under Income Tax Act, 1961, from time to time.

(A) For Other Contracts / Orders

Income Tax TDS, as applicable at the prevailing rate on the gross amount billed shall be deducted from the contractor's bills.

2. UNDER INCOME TAX / BILLING CLAUSES

Vendor / Party categorised/designated as "specified person" under Section 206AB of Income Tax Act, 1961 shall be liable for TDS at higher rate as provided under the said section, by NALCO. So, Vendors/Contractors are advised to submit self-certified copies of Income Tax return (ITR) for each of the Two Previous Years for which due date for filing of ITR has expired, along with the Invoice/Bill so as to facilitate NALCO, verify the applicability of Section 206AB.

9. The bidders who are on Holiday / Negative list of NALCO as on due date of submission of bid / during the process of evaluation of the bids, the offers of such bidders shall not be considered for bid opening/ evaluation/Award.

10. The seller must upload his invoice, e-way bill etc. on GeM portal while dispatching the material. Without GeM invoice, material shall not be accepted at NALCO site.

11. Warranty: The materials shall be under warranty for a period of 18 months from the date of dispatch or 12 months from the date of installation, whichever is earlier, against poor workmanship or quality of material. Manufacturer's warranty certificate to this effect shall be submitted along with the supply of material.
