1. General Terms and Conditions-		
1.1 This contract is governed by the General Terms and Conditions , conditions stipulated to this Product/Service as provided in the Marketplace.		
1.2 This Contract between the Seller and the Buyer, is for the supply of the Goods and/ or Services, detailed in the schedule above, in accordance with the General Terms and Conditions (GTC) unless otherwise superseded by Goods / Services specific Special Terms and Conditions (STC) and/ or BID/Reverse Auction Additional Terms and Conditions (ATC), as applicable		
2. Buyer Added Bid Specific Terms and Conditions-		
2.1 Generic		
OPTION CLAUSE: The Purchaser reserves the right to increase or decrease the quantity to be ordered up to 25 percent of bid quantity at the time of placement of contract. The purchaser also reserves the right to increase the ordered quantity by up to 25% of the contracted quantity during the currency of the contract at the contracted rates. Bidders are bound to accept the orders accordingly.		

2.2 Buyer Added Bid Specific ATC:

Buyer Added text based ATC clauses

1] OEM or the bid specific authorized dealer of OEM should only quote and OEM authorization certificate should be submitted for or specified in the bid. The GeM bid number and date should appear on the authorization letter uploaded with the offer of the authorized dealer otherwise the bid will be summarily rejected.

2] Bulk order will be placed on the manufacturer or its tender specific authorized agent having past proven performance. The manufacturer firm must have satisfactorily executed at least one single purchase order of State Government / Central Government / Public Sector units / Zonal Railways/ Railway Production unit / Railway Electrification for the " SAFETY FOOTWEAR " for a minimum of 20 percent of total tender quantity (i.e. minimum 64 no's) against single purchase order placed during three preceding completed financial year and current year up to date of tender opening. [B] The onus of submission of requisite documents in support of supply [i] / CRAC/ Receipt Notes/Proof of acceptance of material by consignee OR [ii] RITE S Inspection Certificate. In case the tenderers do not submit the requisite documents as detailed above along with their offer, no back reference shall be made in this regard

3] The bidders are required to upload valid BIS License Certificate (IS 15298: 2016) in the name of OEM for the offered product along with their bid offer, failing which their offer will be summarily rejected.

4] Offers received without Make/Brands or with vague mentions like " as per tender " will be summarily rejected. Model along with the brand should be mandatorily disclosed. Firms have to quote for each make separately. Any ambiguity regarding offered makes in the bid offer will lead to disqualification of technical bid

7] Post tender opening no new documents (which are not part of bid offer before opening of bid uploaded by seller) will be considered for bid evaluation. Bidder's offer is liable to be rejected if they don't upload any of the certificates / documents sought in the Specification , Bid document,. Buyer Added Bid Specific , Additional Terms and conditions and corrigendum if any

2.3 Scope of Supply:

Scope of supply (Bid price to include all cost components) : Only supply of Goods

2.4 Certificates:

Bidder's offer is liable to be rejected if they don't upload any of the certificates / documents sought in the Bid document, ATC and Corrigendum if any.

2.5 Generic:

Bidders are advised to check applicable GST on their own before quoting. Buyer will not take any responsibility in this regards. GST reimbursement will be as per actuals or as per applicable rates (whichever is lower), subject to the maximum of quoted GST %.

2.6 Sample Clause:

After award of contract – Successful Bidder shall have to get advance sample approved from buyer before bulk manufacturing / starting bulk supplies. Successful Bidder shall submit

samples for Buyer's approval, within 7 days of award of contract. Buyer shall, as per contract specifications framework, either approve the advance sample or will provide complete list of modification required in the sample within 10 days of receipt of advance sample. Seller shall be required to ensure supply as per approved sample with modifications as communicated by Buyer. If there is delay from buyer side in approval of advance sample – the delivery period shall be refixed without LD for the period of delay in sample approval. In case, the sample is found to have major deviations / not conforming to the Contract specifications, the buyer at its discretion may call for fresh samples for approval before allowing bulk supplies or may terminate the contract after notifying the deviations to the seller.

Unless otherwise provided in the contract, all samples required for test shall be supplied by the contractor free of cost. Where under the contract, the contractor is required to submit an advance sample, any expenses incurred by the contractor on or in connection with the production of stores in bulk, before the sample has been approved unconditionally shall be borne by the Seller and he shall not claim any compensation in the event of such sample being found unacceptable by the Buyer / Consignee.
